The contest for the election of Grand Representative was keenly contested, Mr. Collett winning out 2 to 1.

The Cumberland District Conference met at Nappan yesterday afternoon and was largely attended by both clerical and lay delegates. The financial business with regard to the district was thoroughly discussed and during the afternoon stirring addresses were delivered by Rev. Dr. Heartz and Rev. Mr. Aikens. An evangelistic meeting was held in the church in the afternoon, the two principal speakers for this occasion being Rev. Dr. Heartz and Mr. Aikens. The evening meeting was very largely attended and the gathering was of a decidedly impressive character.—N. S. exr. (Revs. Dr. Heartz and Mr. Aikens are well known in Charlottetown.)

Thomas Oulton, the Amherst cyclist, again proved his superiority over George L. Prowse, Charlottetown, the Maritime champion, in a ten mile bicycle race on the Ramblers' grounds last evening. The race was called at 6.30 o'clock with the starters, Oulton, Prowse and Roland Chapman. Chapman is young at the age but for three miles made an excellent showing, leading the other two contestants. At the third mile Prowse forced ahead and maintained a straight lead from the third to the fifth mile but Oulton was pressing him hard all the time. In the fifth mile Oulton forged ahead and led from the fifth to the seventh mile. From that until the ninth mile there was considerable see-saw. The pace had proved too rapid for Chapman and he had dropped out before the last half of the race. Towards the close of the ninth mile Oulton was leading by some yards, when Prowse had a tire punctured and quit the race. We understand that there was a reserve bicycle waiting for him, but he evidently had come to the conclusion that Oulton has such a gain on him that he could not overtake him. Oulton finished alone, making the last three laps in 33, 32 and 31 seconds, which is certainly travelling some. The time for the ten miles was 30 minutes, 18 seconds. The attendance was not what it should have been.—Amherst exr.

CUT THIS OUT AND PASTE IT UP

Almost every day The Guardian receives orders by mail to insert news matter of an advertising nature. In most of these cases the sender, who are frequent readers, know any member of the staff and who have no account in the advertising department, write "Please insert the following and oblige," thus apparently implying that they think the items will be inserted free. Only a few weeks ago a reader wrote asking that his advertisement of Farm for Sale be inserted free from day to day until he canceled it, as he is a subscriber to The Guardian. In this connection it may be said that the subscription price is not sufficient to even pay the actual cost of paper, ink, presswork, mailing, bookkeeping and other expenses of the Circulation department proper, and thus subscribers have no privilege of advertising free and are on the same footing as non subscribers. Seldom ever does the sender state whether the item is to appear Daily, whether for one or more times in either Daily, or in both, whether as a display advertisement, announcement, business local, classified ad or otherwise. When for church or charitable purposes they seldom ever say so, or do not enclose sufficient money to pay for same, all of which will be returned by first mail in the event of the item not being chargeable, or if more money is sent than necessary to pay for the item the surplus will be returned at once, there being a greater discount for cash with order for advertising of churches & than for regular business. In all such cases the Advertising department communicates with the sender as quickly as possible by mail or phone, often paying the messenger service to get them to the telephone if not too far distant, thus saving all possible time. People write this office to know if News, Letters to Editor, etc., are charged for, and to all such there is but one reply—all items etc. of a money making nature, even though they be somewhat of a news nature, are chargeable. For instance, the advance notice of notices of a concert, lecture, picnic, etc., are chargeable in the Morning Daily or in the Evening if there is an admission fee, silver collection, sale of pies or sale of food or refreshments, etc. Advance notices of purely religious services, open tho' a silver collection is to be taken

Verses accompanying death notices are also chargeable. Even items which are actual news and not chargeable but once in either Morning Daily or Evening Daily or both are chargeable for more than one insertion, as they are thus not news. FALL FROM CAR KILLS MAN.

QUEBEC, Sept. 7.—Driving home from Quebec, George Drapeau, a well-known resident of St. Theresa range, Beauport met with a tragic death on Wednesday night. Corone Jolicoeur was informed of the fatality and an inquest was held, a verdict of accidental death being returned. According to the facts of the case, Drapeau was driving along the Beauport road at a good gait, when his rig suddenly came into collision with a heavy dray drawn by a man named L. Rodriguez. Drapeau was thrown from the rig, landing on his head. He was taken into the residence of M. John and Dr. Lachance was summoned, but the unfortunate man died about ten o'clock without regaining consciousness. He was about 54 years of age and leaves a widow and several children.

MEETING OF CITY COUNCIL

(Continued From Page One.)

the appointment of a local range officer at Kensington range. A petition from the electors of Ward three requesting a light on Richmond and Cumberland Sts. was also read.

Coun McKenna moved, seconded by Coun Campbell, that a new concrete sidewalk be placed, as requested, by the Royal Bank premises provided the Bank pay 2-3 at the cost. Carried.

Moved by Coun Riley, seconded by Coun McKenna, that the request of R. C. Goff for a sidewalk be referred to the street committee. Carried. Moved by Coun Riley seconded by Coun McKenna, that \$275 in addition to the amount in the estimates, be placed at the disposal of the street committee for new wooden sidewalks. Carried.

Moved by Coun Riley, seconded by Coun McKenna, that the request of the residents of Ward three for a light be referred to the light committee.

Coun McNevin brought to the attention of the council the new toll rates for the market and the necessity of taking action. Coun Riley stated that the additional cost of operation of the market and increased prices made it almost imperative and necessary to increase the tolls. A larger revenue from the market was due to the city. Coun Taylor asked for the proper protection of those renting stalls against others "hawking" vegetables, fish, etc.

Coun Walker, moved, seconded by Coun McLean, that a new wooden sidewalk be placed on the west side of School St for the convenience of school children. This was allowed to stand on the understanding that concrete walk would be placed there next summer.

Moved by Coun McNevin, seconded by Coun McLean that the amended market tolls as presented be adopted. Carried.

Moved by Coun Taylor, seconded by Coun McKenna, that tenders be called for coal for market house and City Hall, tenders to be in Sept. 16. Carried.

F. Trainor's tender for a copper gutter for the city hall, the lowest, was accepted.

Coun Taylor asked for a light on Rochford Square, which was badly lighted. This was referred to the light committee.

Coun McLean complained of a drain on Fitzroy St which is badly in need of repairs.

John Enman, representing a delegation of milkmen, asked that the new inspector of cattle by-law be not enforced until the law was made general so that the milkmen would be on an equal footing with the owners of cattle. Miller Matheson also spoke in support of this, saying that while milkmen were willing to have their cattle tested a great many who supply milk to the milkmen refuse to have the tuberculin test applied. The city will suffer from its milk supply. On the understanding that certain latitude would be exercised until the law became general while the milk vendors obeyed the law and filled their test certificates and source of supply the delegation departed.

Some discussion ensued on the condition of the police quarters in the City Hall, Coun Walker introducing the subject.

Coun McKenna moved, seconded by Coun McNevin, that an estimate be secured from the City Surveyor of the cost of repairs to the police and firemen's quarters. Carried.

Sgt Bradley was given authority by His Worship the Mayor to tear down the Old Ladies Home, it being shown that it is a menace in its present condition.

Council adjourned.

DETERMINED EFFORT TO SAVE THOMASSEN.

SYDNEY, Sept. 7.—J. W. Maddin, counsel for Henry Thomassen, and Rev. Mr. Kinsale are busily engaged in collecting evidence which they hope will result in a new trial and full acquittal for the prisoner. It is more than nine months since John Walberg was murdered at North Sydney and, consequently, the new evidence which the gentlemen interested are trying to collect, is spread over a large area, from Louisburg to St. Andrews.

Mr. Kinsale spent Thursday in Louisburg and reports his mission to that place successful. Thomassen was feeling in fine fettle yesterday, the day set for his execution, had not a stay of proceedings granted, at the county jail. Evidently he was glad to be alive and exulted in the news that the day of his execution had been put off.

The jailers say that Thomassen heard the news quietly and with little show of feeling. At the moment the only show of feeling evident was an exultant glitter of the eyes.

A strict watch is being kept on Thomassen, but he says it is not necessary now. He would not attempt to escape even if the chance were given him.

Thomassen has said the reason he made the break was that the noise of the carpenter's hammers as they drove the nails into the sawlows which they were building and on which he was to be hanged, practically drove him insane, and when he made his dash for liberty he was not wholly responsible for his actions.

He was brooding over his fate, and the sound of the ringing hammers seemed like a funeral knell through his half crazed brain. His attempt to get away was unpremeditated and he afterwards said he was glad the officers found him so quickly.

It is learned that Gundersen was the only witness really implicating Thomassen at the trial, and who was working at the Steel Works until a went as far as Boston and there deforntight ago, hired on a ship here, set when he heard that a new trial was being sought.
