The arraignment of Arbuckle in the court of Superior Judge Harold Louderback, on a charge of manslaughter in connection with the death of Miss Virginia Rabe, came on yesterday, but was continued until Monday, September 26. The county grand jury at its meeting on Monday night is to consider evidence that certain witnesses were tampered with.

"The jury also expects to clear up doubtful points in regard to the medical attention given Miss Rabe," Harry M. Kelly, secretary of the jury said. "The testimony of the doctors who attended her may be heard."

The arraignment of Arbuckle in the court of Superior Judge Harold Louderback, on a charge of manslaughter in connection with the death of Miss Virginia Rabe, came on yesterday, but was continued until Monday, September 26. The county grand jury at its meeting on Monday night is to consider evidence that certain witnesses were tampered with.

"The jury also expects to clear up doubtful points in regard to the medical attention given Miss Rabe," Harry M. Kelly, secretary of the jury said. "The testimony of the doctors who attended her may be heard."

LIVE STOCK

For those farmers who are intending making shipments of cattle to the British market, the following advanced information on the best procedure to observe, is offered by the Dominion Live Stock Branch, after considerable investigation and knowledge of conditions as they now exist.

Farmers or other individual shippers will find it to their advantage to ship through Live Stock Brokers. In the first place the experience of the brokers in obtaining freight space and overcoming the difficulties incurred in making shipments, makes it possible to ship overseas at less expense than in case where shippers with experience are undertaking their own shipments. The brokers have a good working connection with the overseas trade and are likely to get better treatment than would be accorded farmers who make but one or two shipments.

Also as the cattle broker obtains his commission from the steamship companies, his services are not charged up to the shipper. It is doubtful if farmers buying their space direct from the steamship company could obtain it at any reduction over the rate that is obtained from the brokers. In that case, the individual shipper pays the full cost of ocean freight and losses the service of the broker.

The cattle broker meets the cattle at the Stock Yards and makes arrangements for the feeding, watering and handling. It is his duty to see that the superintendent of the loading on the steamer and buys and delivers the hay on the steamer. He also furnishes the men to take care of the cattle on the ocean voyage.

A farmer or shipper can book his own space on the steamer if he applies through the Steamship Companies, provided there is any space to be had when his application is made. The rule is "first come, first served."

All ocean freight has to be prepaid at Montreal on steamers belonging to the Government Merchant Marine, other British Steamship lines will accept cattle collected on United Kingdom ports.
