

IMPORTANT ANNOUNCEMENTS BY MESSRS HAZEN AND ROGERS

Mail Service to be Divided Equally Between St. John and Halifax. Courtney Bay Works to be Pushed. Banquet in Honor of Ministers.

(Special to The Guardian.) ST. JOHN, Nov. 12.—That the Royal Mail steamers Royal Edward and Royal George of the Canadian Northern Railway service will run this winter direct between St. John and the Old Country was the announcement made tonight by Hon. J. D. Hazen at a banquet tendered to him and to Hon. Robert Rogers by the Conservative party.

spoke, stated that the government would do all in its power to aid in the development of the harbor facilities in St. John. Already in the afternoon he had been at a meeting of the Board of Trade and had expressed there just what he had to say. The government was prepared to promise at least one new pier by next season and he would recommend two which would provide ten new berths. He could not however guarantee two as it might be difficult to get the money for them. He felt, however, that he could guarantee one while he would recommend two. He also agreed to find the money for the development of Courtney Bay facilities in a quicker time than specified in the contract speaking directly to J. Norton Griffiths, the contractor

for the immense facilities at Courtney Bay, he stated if his firm could do the work in a year he would find the money to pay for it. At the Board of Trade meeting in the afternoon there was a lively political tilt between Mr. Hazen and Mr. Pugsley who was present. Mr. Pugsley asked Mr. Hazen if the Gutelius agreement by which the I. C. R. will carry freight from St. John to Halifax will remain ineffective until it has been dealt with by the Railway Commission. Mr. Hazen replied that such was not the case. The agreement had been made by Mr. Gutelius as the responsible head of the I. C. R. and as such the government would not interfere until the railway commission had dealt with it.

DERELICT SHIP IS CANADIAN

Two Bodies Washed Ashore Identified. 8 Frozen Corpses Found in Life Boat.

(Canadian Press) PORT HURON, Nov. 12.—After working desperately since this morning in an unsuccessful attempt to identify a derelict freighter which floated bottom up in stormy Lake Huron, eight miles northeast of here, marine men returned to-night convinced that the boat is the Canadian packet freighter, Regina. This belief is substantiated by the fact that two bodies washed ashore yesterday were positively identified as those of sailors of this vessel. Wreckage bearing the name of this boat was also washed ashore. A report this afternoon from Port Frank, Ontario, states that eight more frozen bodies were washed ashore in a lifeboat there to-day. (Canadian Press.) DETROIT, Nov. 12.—No more wrecks or vessels in distress were reported today at points on Lake St. Clair and along the Detroit River. A number of hunters who are believed to have been on these waters in open boats when the blizzard swept Michigan Sunday are still missing.

I. O. FORESTERS LEAVE THE ORDER

In Wisconsin on Account of Strict Requirements Demanded by State Laws.

(Canadian Press) MADISON, Wis., Nov. 12.—The Independent Order of Foresters of Toronto, which has 4,500 members in the state of Wisconsin, surrendered its charter to the state Insurance Department to-day. The same order withdrew from Minnesota last Monday. The action was taken because of the strict requirements demanded by the state in writing business. Fifty per cent. of the order's membership are in the United States.

PUBLICITY FOR P. E. ISLAND

Dr. Williams While in Montreal Saw Need of Such and Voices it in a Letter.

Sir,—I have been much impressed by the suggestion that a Commissioner for Prince Edward Island should be appointed to represent the Island in Boston and elsewhere. From my experience in Montreal I know that such an appointment would prove of incalculable value to the Island in general and the fox industry in particular. I should say a Commissioner with a salary of \$2500 and \$500 travelling expenses would fill the bill. Now is the time for action. I am only a small private fox owner, but I am prepared to subscribe \$100. Will other fox men join in? If the fox owners subscribe \$1500 I am sure the Government will be induced to contribute a further \$1500. The Commission would then be an independent government official, able to speak with the authority of the Government at his back—and that is what would be wanted in the large centres. BARK FOUNDERED ELEVEN DROWNED

(Canadian Press) LISBON, Nov. 12.—Eleven of the crew of the Italian bark Elvo were drowned, but three were rescued, among them John Claxel, a Californian, when the vessel sank to-day in deep water after striking the mouth of the river Mira, while manoeuvring to avoid collision with another. The Elvo was laden with lumber on a voyage to Genoa where she was owned, from a gulf port in Mississippi.

FATAL EXPLOSION IN COAL MINE

(Canadian Press) BELLEVILLE, Ohio, Nov. 12.—One man is known to be dead and eight entombed as a result of an explosion in Noble County Mine of the Imperial Coal Company of Chicago late to-day. On May 1st last fourteen were killed and several injured by an explosion in the same mine. A later report says none one was killed all having escaped.

ALL AMERICAN ATHLETES SAIL THREE YEARS FOR STEALING \$27,000

(Canadian Press) SAN FRANCISCO, CAL., Nov. 12.—With the cheers of many enthusiasts ringing in their ears, the quartette of American athletes who are to pit their prowess in feats of strength, speed and skill against the best of the athletes in Australia and New Zealand, sailed for the Antipodes to-day. The members of the team are James Power of the Boston Athletic Association, mile champion of the United States and Canada, who is ready to run at any distance from the half to two miles; Alvah Meyer, of the Irish-American A. C. of New York, who is the sprinter on the team; Ruris R. Templeton of the Olympic A. C. of San Francisco, who will do the hurdles, high jump, broad jump and pole vault, and Reginald Coughy of Ukiah, Cal., who is a shotputter and weight-thrower.

D.A.R. UNVEIL THEIR MONUMENT

LORD COUDRAY'S LOAD TO MEXICO

(Canadian Press) LONDON, Nov. 12.—Stung by a criticism of alleged financial support to Provisional President Huerta, Lord Coudray issued a statement above his signature, setting forth the extent of his financial dealings with the Mexican Government. The statement stated that his and allied companies took a small proportion of a three per cent. loan, but in justice, says Coudray, nothing more, nor were we asked to do so.

PRESIDENT WILL SUMMON COUNCIL

(Canadian Press) PEKING, Nov. 12.—President Yuan Shi Kai intends to summon an administrative council which in addition to transacting state affairs will draft regulations governing the new parliament. The council number 71 members, consisting of cabinet officers and others appointed by the President and Provincial Governors.

MISTAKEN FOR DEER AND SHOT

(Canadian Press) MONCTON, Nov. 12.—A distressing shooting accident with fatal results is reported from Kent County. James and William Bagnall, about 25 and 27 years old, belonging near Harcourt, were in the woods on Salmon River on a shooting expedition. The brothers separated and William mistook James for a deer and shot him through the abdomen. The victim was dead before assistance arrived.

SUPREME COURT MICHAELMAS TERM

Before Their Lordships Chief Justice Sullivan and Mr. Justice Fitzard. Daniel McDonald v. The Island Cold Storage Co., Ltd.—Application by the company for a new trial of the case heard at the Trinity Term of the Court this year in which the complainant obtained damages against the defendant company for a breach of agreement with regard to the cold storage of a quantity of lamb. Mr. W. S. Stewart, K. C., appears for the applicant, and Messrs A. A. McLean, K. C., and McKinnon for the complainant. The hearing of the argument of counsel in this case, commenced on the previous day, was continued when the Court resumed yesterday morning. Mr. McLean continued to show cause against the granting of a new trial, and Mr. Stewart's reply on behalf of the application occupied the balance of the day, and was not concluded when the Court adjourned to-day, 11 a. m.

TEMPERANCE ALLIANCE

The King's County Temperance Alliance met in Montague yesterday. The afternoon session was taken up completely with the business relevant to the work of the organization. The officers for the ensuing year were then appointed. An animated discussion took place concerning the enforcement of the law, and also as to the method adopted. The King's County Prosecutor was present and presented his report. Some of those present asked several questions in relation to the work. After a very profitable time, the session was adjourned to meet at 7.30 p. m. for the public meeting. In the meantime the rain had come on and the prospects for the evening's meeting were spoiled. However at 7.45 p. m. the President, Mr. William McLeod opened the meeting and called upon Rev. D. Wright as the first speaker. His subject was 'Canada's Great Burden. The Rev. gentleman quoted figures to show the great tax that liquor has put and is putting upon the citizens of this great Dominion. Then he went on to discuss the method taken to stem the tide that is rising higher and higher. The politicians, said the speaker, have made a foothold of the Temperance question. Let the church perform her function and the government, hers. When men realize their responsibility then we can have a solution of this question. The next speaker was the Field Secretary of the Temperance Alliance, Rev. W. D. Wilson. Mr. Wilson opened his address by referring to the history of the past year and thanked those men who had so loyally stood by the cause in the face of opposition and threats of those interested in the liquor business. 'We by your loyalty were able to accomplish something for Montague. Some have thought it to call that work in question, but I re-assert the evidence of the good deed done during that time. Continue the good work. It was begun because some of your boys and girls or fathers were being wronged and we wished to save them from it.' Then the Rev. gentleman went on to deal with the function of the community and it would purify the every phase of life and that it should be its unique prestige control politics. 'That is as it should be, but not as it is. If the church rises to its opportunity and duties and privileges soon this state will be enjoyed and the politicians will consult the God fearing men and women instead of a Godless liquor seller. The next speaker was the Rev. G. H. Henry. This was his gentle first appearance and he made a good impression. He spoke of the lack of the administration of the law. The chairman then called upon Mr. Hor. Nelson, who spoke a few words regarding the condition of Montague. The following gentlemen also took part: Mr. Martin McKinnon, Dr. A. J. Fraser, Mr. S. A. Martin, and Mr. N. J. McDonald. All present agreed that in listening to the speeches and remarks that a profitable time had been spent, and some good accomplished.

FOUND NO TRACE OF BRIDGEPORT

(Canadian Press) QUEBEC, Nov. 12.—After carefully searching the Lower St. Lawrence and the north side of the Island of Anticosti, the various steamers sent out to look for the missing collar bridgeport, which sailed two weeks ago from Sydney for Montreal, have reported no trace found. The Department of Marine and Fisheries has come to the conclusion that the sank with thirty hands somewhere off St. Paul's Island.

WILL SEND YOUTHFUL OFFENDERS TO OODS INSTEAD OF PRISON.

(Canadian Press) KINGSTON, Ont., Nov. 11.—To save young criminals from the associations of Portsmouth penitentiary an experiment in parole is now being considered by the federal authorities and is likely to be tried this year. These young prisoners, now serving terms in the Portsmouth penitentiary or other federal penitentiaries, will be sent into lumber camps throughout the Dominion next year under the personal charge of men employed by the Canadian Reading Camp Association. The scheme originated with G. M. MacDonnell, K. C., a member of the commission investigating conditions at the penitentiary, and is a direct result of that inquiry. The youths will be given work in the woods as axemen.

REFUSED TO ISSUE RESTRAINT ORDER

BOSTON, Nov. 11.—Judge Sheldon of the Supreme Court, to-day refused to issue an order restraining the New York New Haven and Hartford R. R. Company from issuing the \$97,000,000 debenture bonds recently authorized by the Public Service Commission, as sought in a bill in Equity, filed by former Governor Morgan G. Bulkeley of Connecticut.

SOUTHERN WOMEN IN SUFFRAGE FIGHT

(Canadian Press) NEW ORLEANS, La., Nov. 10.—'A government is not yet complete that withholds from its most enlightened women what it freely gives its most enlightened men.' This quotation from the writings of Thomas Jefferson is plastered on bill boards and blank walls, is on doggers, in show windows and on buttons, and is being thrown on the screens of all moving picture shows in New Orleans today. The occasion is the opening of the Louisiana equal suffrage convention and a conference of Southern women in the interest of the suffrage movement. Thomas Jefferson's prestige is so pinnaled in the South that the women decided to feature his view of the suffrage question. For various reasons the South up to the present time has lagged behind all other sections of the country in the battle for equal rights. The women of Louisiana have not taken the initiative in a vigorous campaign to secure the ballot rights that are enjoyed by their sisters in many States. Miss Kate M. Gordon, president of the State suffrage association, has been a power in many progressive movements and her influence is being exerted in a most determined way. She is supported by some of the most intelligent and influential women of the State, who hope to induce the legislature to allow Louisiana to be the first of the Southern States to recognize the right of women to vote.

PROVINCIAL BY-ELECTIONS IN QUEBEC

(Special to The Guardian.) MONTREAL, Nov. 10.—St. John's County and Huntingdon County, Quebec, in bye-elections to-day both returned Liberal candidates to the Provincial Legislature, although in the first named it was an Independent Liberal that secured the seat, the nominee of the administration convention going down to defeat in a four-cornered contest. In Huntingdon, Phillips, Liberal, had a majority of 380, with one poll still to be heard from, over Dr. Moore, Conservative. In St. John's, Marcelin Robert, Independent Liberal, had a plurality of 124 votes over Brossard, the Government nominee, whose total vote was 522, while Poulin, another Liberal, received 622 votes, and Trudel, Independent, had only two ballots marked for him throughout the whole riding. None of the Ministers took part in the St. John's contest, the party quarrel there having assumed such proportions previous to the election that the Government thought it the wiser plan to leave the field to the candidates themselves. In Huntingdon the provincial administration threw the whole weight of its support behind their candidate, favouring the personal popularity of Dr. Moore, the Conservative nominee. The bye-election in St. John's was rendered necessary by the retirement of Sir Lomer Gouin, the Premier, who held two seats and who finally decided to sit for Portneuf. Practically the same condition obtained in the county at the time of the general election last year, and it was in an endeavor to heal the party split that Sir Lomer consented to contest the seat. He was elected by a majority of 400 over Dr. Sabourin. In Huntingdon the vacancy was

SENDING RELIEF TO FROZEN NORTH

(Special to The Guardian.) WASHINGTON, Nov. 11.—Final instructions were telegraphed tonight by Acting Commandant Emery of the revenue cutter service, to Captain Woodbury, in command of the northern district at Seattle, regarding relief to be sent the inhabitants of Kodiak Island, Alaska, where an epidemic of measles has developed. Captain Woodbury was directed to co-operate with the Red Cross and to put aboard the cutter Tahoma, medical and other supplies of the Red Cross which has been developed. The Tahoma will steam north as soon as possible. More than 100 cases of measles have developed on Kodiak Island, and neighboring islands, and there have been several deaths.

CHICAGO WOMAN THE RICHEST IN WORLD

(Special to The Guardian.) CHICAGO, Ill., Nov. 11.—Mrs. Helen Swift Morris was put in control of the \$20,000,000 estate of her husband, by the will filed in the probate court here today. This disposition of the packer's estate makes Mrs. Morris, who inherited a large fortune from her father, one of the wealthiest women in the world. Charitable bequests total \$51,000, among twenty-one beneficiaries named by the testator, and others named by the widow, who is given \$50,000 to be distributed among such charities as she shall select. The largest bequest is one of \$100,000 to the pension fund of Morris and Company of which firm the deceased was the head. The remainder of the estate goes to Mrs. Morris and the four children.

MUNICIPAL GAS PLANT IS PROJECTED IN OTTAWA

(Special to The Guardian.) OTTAWA, Nov. 11.—It is probable that at the January elections Ottawa will vote on a proposal to establish a municipal gas plant. The rate at present paid to the Ottawa Gas Company is \$0.10 per thousand and \$2 per year meter rental. A special report presented to the council today shows that the city can supply gas for eighty-five cents per thousand with no meter rental. It is also found that the poor quality of the gas now supplied makes the price equivalent to \$1.53 per thousand.
