THE BOARD OF HEALTH ADDRESS

Held a Meeting and Order That all Infected House be Placarded.

A meeting of the Board of health was held last night after the adjournment of the City Council meeting.

Coun. Whear said there are good many complaints of diphtheria. He understood that in the cases of Moore, Tanton and Murphy the Board had been officially notified. It had been rumored in the press and otherwise that there are eleven cases. He had been informed that it had developed in Mr. D. Howlett's family. It appears that some houses are flagged and others are not. He could not see why one house is flagged and another is not. The placarding of the houses will certainly keep people away. Tomorrow is market day and people will go to a house without having knowledge that an infectious disease is in the house. If the citizens see that nothing is being done there will be an uneasy spirit. If the house is flagged the people will have confidence.

Dr. Johnson said that rumors that get abroad are one thing and facts are another. He then cited the Diamond cases stating that two children had died. The family did not call in a physician until after the death of the baby. A few days later a second child was taken down and when a physician called he found a case of diphtheria. The second child died. Anti-toxine was administered to the third which lived. No houses have been placarded this year. His opinion was that it was as well to trust to the head of the house. He found that diphtheria developed more readily where the cellars are damp.

In the case of Mr. Tanton's family anti-toxine was not administered until after the first death. In Mr. Howlett's family diphtheria did not develop. He had visited the family and found croup. The line of demarcation between tonsillitis and diphtheria is not easily drawn. Recorder Hassard stated that he had been informed that a little girl had attended Prince Street School to-day, who had visited Coun. Tanton's house on Friday. The child informed her teacher she did not know. The teacher sent for the Principal but he did not know what to do and the child stayed all day. He had heard that others had visited the same house.

Coun. Brown stated that he noticed children going in and out of Mr. Moore's house. Mr. Tanton had been out during the latter part of last week. Dr. Johnson then stated that the diphtheria is not of a malignant type. Couns. Horne and Taylor said that they had been informed that children had entered the infected houses. After some further discussion it was ordered that all houses where the disease has developed be placarded.

COUNCIL MEETING HELD LAST NIGHT

The Storing of Kerosene Oil in the City Discussed at Length.

REPORT SUBMITTED SHOWS THAT 1404 BBLs.

Are Housed in Different Parts of the City—A Resolution of Sympathy Passed in Connection With Coun. Tanton's Bereavements—Assessors for the Year Appointed.

The regular monthly meeting of the City Council took place last night; His Worship Mayor Warburton, Recorder Hassard, Couns. Whear, McDonald, Lyons, Horne, Taylor, Brown being present.

After the reading of the minutes of previous meeting, a number of bills were read and passed.

Coun. Brown asked why the tender for the printing of the city accounts had been let without the order of the chairman of the printing committee? He had been told that another firm would have printed the report for \$150. He thought the sooner it is known that one man is running the Council the better.

Coun. Whear said that he was acting within his jurisdiction as chairman of the finance committee.

The reports were wanted in a hurry. Coun. Horne thought it was unfair to give the contract to one firm without consulting the other printers.

Coun. Taylor thought that all should be given an equal chance by advertising the tenders.

Mayor Warburton said that he agreed with Coun. Brown, and all should have been given an opportunity to tender.

Coun. Lyons said it was the Councillor's duty at the Board to see that the work is properly done and done as cheaply as possible.

Mayor Warburton called the attention of the Council to Councillor Tanton's bereavement, and referred feelingly to his double affliction.

Coun. Lyons expressed his sorrow for Mr. Tanton and family. He was sorry the Board of Health had not been acquainted before. He hoped the health officer would be able to explain why the Board had not met before. The epidemic in its worst stages is worse than smallpox.

Coun. Whear then moved the following resolution which was seconded by Coun. Lyons, and carried unanimously:

Resolved that this Council desire to express its deep sympathy with Coun. Tanton and family in the loss sustained by the death of his only son and daughter.

A letter was read from Messrs. McLeod, Morson & McQuarrie in connection with a claim presented by Mrs. Walter Lowe some time ago for injuries sustained by tripping on a sidewalk.

Coun. Whear said that as he understood it no person could have an action where people trip over the sidewalk as it appears the complainant had done.

Coun. Taylor said he knew Mrs. Lowe was hurt. He saw the place where she fell; the sidewalk was worn.

DIPHTHERIA IN THE CITY

A Guardian Representative Talks With The Health Officer.

In view of current rumors of the prevalence of diphtheria in the city a GUARDIAN representative called at the office of the Health Officer yesterday afternoon and had a short talk with him in reference to the different cases. He said:

Since last (Sunday) evening another case has been reported on Douglas Street in the home of Albert Murphy, his son having developed diphtheria.

The death of Capt. O. Taylor's child has been reported to day and the funeral takes place this afternoon.

The places are not being flagged but the requirements are exactly the same as if flagged. Unless a guard is placed the results are exactly the same. All are notified according to the bye-laws, the sanitary officer notifies the neighbors of the home infected.

The flagging is more for pauper families under the care of the city. People will fight shy of a house where diphtheria has

developed. The fact is that people will keep away from the house. The danger from passing by a house is quite imaginary.

Mr. D. Howlett's family are improving and were suffering from quinsy.

ADMINISTRATION OF SERUM.

In reference to the administration of serum the doctor advocated its use in the strongest terms. So far as used in his experience the effect has been absolute and the same has been the experience of the case on Douglas street, Murphy.

The same. All are notified by the bye-laws. It has been found that the serum affords almost as good a protection from diphtheria as vaccination is in case of smallpox, but of course is not so permanent.

The doctors who have cases under their charge are promptly reporting cases, but of course there is a difference of opinion about diphtheritic croup and diphtheria.
