strengthening of the Empire. "May I add that we feel that our hands have been strengthened and our purpose sustained by the great outpouring of goodwill and kind wishes which we have experienced during the recent week; may the prosperity of our country and the welfare of the Empire ever command the best efforts of all of us.

Mr Ferguson has already had numerous invitations to address public meetings in London, but for the immediate future has accepted only two. On February 10 he will speak to the Canada Club, and in the first week of March he will address the Lyceum Club, a federation of Women's Institutes. On the Montcalm, Mr and Mrs Ferguson were welcomed by Hon Hugh McLean, Lieutenant Governor of New Brunswick.

Will Attend Canadian Conference (By W. W. Murray, Canadian Press Staff Writer)

ST. JOHN, N. B. Jan. 23.—Hon. G. Howard Ferguson, Canadian High Commissioner to Great Britain will attend the economic conference to be held in Ottawa this year, it was indicated prior to Mr Ferguson's sailing on the Canadian Pacific liner "Montcalm" from here today to assume the duties of high commissioner and to familiarize himself with the functions of that office which will occupy his time between now and his return to Canada, perhaps in May or June.

Welcomed on board the liner by Captain Rockwell, Master of the vessel and given a reception by Hon. Hugh McLean, Lieutenant Governor of New Brunswick, together with Hon. J. B. M. Baxter, Premier of the Province, Mayor W. W. White, of St. John, and many other prominent citizens of the province, the High Commissioner sailed for England at two o'clock this afternoon. Scores of telegrams awaited him at the Maritime port, among them wires of good wishes from Rt. Hon. R. B. Bennett, Prime Minister of Canada, Hon. L. A. Taschereau, Premier of Quebec, Premier Henry of Ontario, J. J. Morrison, former president of the United Farmers of Ontario, and many others.

Council were carrying out fairly and honourably their part of the contract.

Subsequent to the inspection, Mr Tanner consulted with the Hon John A. MacDonald, member of the Bennett Government, and Mr W. Chester S. McLure, M.P., who suggested other public works which might be undertaken under the unemployment grant. It is understood that Mr. Tanner expressed a willingness to recommend the suggestions favorably to the Hon. Mr. Robertson, Minister of Labour, who is in particular charge of this expenditure.

One of the suggestions impressed upon Mr. Tanner was the restoration of the Confederation Chamber. With this suggestion he was in particular accord, considering that not only should this work be undertaken under the unemployment grant but that the maintenance of the Chamber should be undertaken by the Dominion Government under the Historic Sites account.

Mr. Tanner also received suggestions for work on the government wharf, Government House and the Hillsboro Bridge.

The federal unemployment grant requires a strict accounting of all expenditures, also that all materials used be of Canadian manufacture, that the laborers be all Canadian workmen, that a minimum wage of 30 cents per hour for eight hours a day be paid, and that employment be given to all eligible applicants capable of doing the work, irrespective of political affiliation.

Mr. Tanner leaves this morning on return to Ottawa. He has already inspected the programme of work under the unemployment grant in the other Maritime Provinces.

if the man had lain down there. The skull had rolled a few inches. There was a small quantity of grey hair with the skeleton.

OTHER WITNESSES

John Joseph McDonald, East Point, (sworn), saw the man in May, 1928. Witness was working in the field, and he saw a man acting strangely on the main road, about 225 yards away. Witness was coming toward the road, and when he got to the end of the field the man was about 125 yards distant. When he got abreast of Mr. McDonald he stopped, and looked at him for about a minute. He was wearing overalls and a cap. Witness watched him till he got out of sight, then went up to the road and watched him go around a turn in the road out of sight. The man had been waving his arms and acting very strangely. Witness was called up from Central by phone that night, and asked if he saw a strange man passing. Witness told them that he had seen a man going east in the forenoon. She, the telephone operator, said that he had turned back. Witness told her that he had not passed by his place before dark. Central told him that the man had escaped from Falconwood and that there were parties looking for him then. They came up that night and searched the neighborhood.

Next morning witness talked to them on the road, while they were searching. The man he had seen was fairly tall, wore a pair of blue overalls and a smock. On Oct. 19 last Mr. Beaton came to the home of the witness, and told him that he had found the remains of a man in the woods. With several other men they looked over the remains. The skeleton was on its left side. The bones seemed to be all right. There were none broken. There was only one shoe to be seen. Witness had never been asked to go on search. The stranger was a tall, thin, elderly man.

HAD VISIT FROM DECEASED

J. F. Mossey, Bothwell, merchant, saw a strange man in May, 1928. He was called on the phone on Saturday afternoon and advised that there was a man coming west who appeared to be insane, and that he might be a native of that section or he might have escaped from Falconwood. Witness saw the head and shoulders of a man passing over the grade on Munn's Road. Mrs. Alex. Robertson, Red Point, phoned witness that there was a man acting strangely, going east, and had passed their store. He had turned back. Witness kept a watch, and about 5 o'clock he saw the strange man about Munn's Road coming eastward. He thought struck him that the man might be hungry. Witness filled a three pound bag with sweet biscuit. This man was approaching the store and was walking on the north side of the road near the gutter. Witness crossed the road to where the man was, and spoke. The man halted. Witness asked him his name.

He said "Don't know." "Where are you from?" "Don't know." "Where are you going?" "Don't know." Witness then offered him the crackers. He stretched out his hand reluctantly and took the bag. He appeared to be anxious to keep going, and with the bag in his right hand he started east. Witness called up central at South Lake and stated that he had seen a man who was a stranger to him, and that there was no doubt that he was from the asylum. Witness phoned the asylum, talked with the doctor, and asked him if he had a patient at large. The doctor told him that there was. Witness told him what had occurred. The doctor said that the man's name was Percy Gay or Jay, that he did not belong to that section of the province and that he was perfectly harmless. The man described by the doctor believed to be the escaped patient. He told the witness that they had a search party in the vicinity. That night a car came into the witness' yard and a man from St. Margarets came into the house, and said that they were looking for the escaped patient. Witness told what he knew, and they left, going east. The stranger, whom he had seen was an elderly man about 65 years of age, very tall, apparently had been of good appearance, grey hair, shaved face. He wore a suit of blue overalls, an old cap, and coarse red boots. He had no mitts, although the day was not warm. He was very lightly clad. Witness was a member of a search party of four which went to Red Point on Sunday a week later. They searched both sides of the road where it appeared likely that a man might go, as far as Black Point.

It was sufficiently cold for a man to perish if exposed on the Saturday night in question. The man appeared to be fairly robust. From certain reports witness believed that the stranger had walked about thirty miles on that day.

REMEMBERED GAY AS "TRUSTY"

Mr. William Payne, druggist, store-keeper and accountant at Falconwood (sworn), stated that he remembered Percy Gay very well. He saw him last at the hospital on the morning of May 4 when he helped the witness take in some goods from a car. Gay was a patient known as a "trusty." He worked in the dining room. For two years prior to his escape he would not answer questions, merely mumble to himself. He was wearing steel blue overalls, underwear, pants and jumper, all marked with the number of the ward. He wore no hat or cap. He was partially bald. He often gestured and talked to himself. He was about five feet ten inches tall. Witness would not say for sure that the man seen was Gay, Gay weighed 148 pounds, was fairly thin, had a rather refined face, was clean shaven. His hands were soft, as he did no heavy work. He waited on the table and washed dishes, carried up bread to the wards. Witness told Mr. Beaton when the latter called him up to take the matter to the Premier or the Attorney-General. The doctor was in the wards at the time, busy. When the doctor came back witness reported the matter to him.

AUTHORITIES NOTIFIED

Dr. McLean, Souris, coroner for Kings County (sworn), stated that he received a call from Mr. Victor Beaton by phone informing him that he had found the remains of an escaped patient of Falconwood. The doctor told him to call up the Provincial authorities. Some time after Mr. Beaton called again and asked witness to come to East Point. On his arrival Mr. Beaton told the witness that he had received instructions from Falconwood to call the Premier or the Attorney General. He did so and they murmured over something which he could not understand. He received orders to bury the body as that of an unknown man. Witness made some inquiries from Mr. Beaton, who had no doubt that the skeleton was that of Percy Gay. Witness thought that it was to the interest of the authorities to order an inquest, and as they did not do so, witness ordered the skeleton to be buried. There was no evidence of foul play.

John W. Platts, Charlottetown, Provincial Constable, stated that the Commissioner had sent him to Souris in connection with the remains that had been found. He had authority to have the remains exhumed. He empanelled a jury and secured the witnesses.

Abegweits Take Section Opener From Crystals 4-2

(By Tec.) Abegweits, 4; Crystals, 2

Nursing a two goal lead behind a sweet defensive game, Abegweits opened the second section of the P. E. Island Hockey League at the Forum last night by a well-earned and creditable victory over Crystals by a score of 4 to 2.

The Crystals' two goals were registered in the first and second periods, the first coming on a bouncing puck, which was flopped from the blue line by Jack Schurman. Their second and final counter was realized when Nicholson was "doing time," "Chick" Gallant scoring on a four man attack.

Consistent hockey coupled with splendid back-checking and great work on the defence, was the big feature in the popular verdict which went to the locals.

"Chick" Williams' return to the game was another feature of the set-to. The opening score of the night was made on one of his lightning-like passes, which was afterwards rifled from the blade of Johnny Squarebriggs. It was one of the prettiest plays of the game which brought dynamic cheering from the huge throng that packed the Forum.

Spillet and rangy Bill Power were on in every sense of the word last night, the latter bodying like a veteran—and legally at that, while the former seems to be just hitting his stride. Hal's stick-handling had the fans goose-necked from looking, Saunders, getting the bulk of the Abbie twisters, played a whale of a game; he scored unassisted in the second and third periods. D. Gillis, McDonald and Lawlor turned in their best games of the season. These three hockeyists making up the Abbie second string, held the Crystals scoreless while they were on the ice. Even when Williams was doing time for bumping Montgomery, the visitors were unable to score, so hard did the trio work. Ray Stull wasn't taking orders for rubber last night. His style of doing business amounted to the turning of thirty shots away from his front door. Lefurgey, opposing goalie, also had a busy night looking after twenty-seven.

Crystals played hard hockey throughout, but seemed to lack the smooth coordination which featured their many games here and at home. Almost every journey into Abbieland was thwarted by the hard bodying and timely poke-checking of their opponents. Only one player seemed to be going at top speed all night, and that was the redoubtable "Chick" Gallant, but even then his solos were frustrated for the most part by Williams, who poke-checked and bodied on nearly every endeavor.

The game as a whole was good hockey, but was marred somewhat by a regrettable near-riot which occurred towards the latter part of the second period, after Grady "elbowed" Nicholson in the face—an illegal check. Referee Lowther was slow in awarding what looked like a major penalty, with the result that Nicholson was given plenty of time to get to his feet and start an altercation with Grady. Hockey gauntlets then began to fly, with playing coach Silliphant chipping in, and finally both teams began to mill in a mad scramble.

Things would no doubt have ended in an amicable settlement had not the fans interfered by swarming on the ice. This was the most regrettable occurrence of all. Fans who come to hockey games with the proverbial chip on their shoulder, would be doing everyone a favor, including themselves, by burning said chips and above all—minding their own business. To make a long story short, Crystals left the ice to return ten minutes later and continue the game, the final result of which is mentioned above.

THE SCORES

First Period Opened slow, with both teams apparently afraid to open up. Not until the first score did either sextet display any brilliant hockey. At five minutes Chick Williams gave the home fans a chance to cheer when he followed a loose puck to retrieve and carry into the Crystal corner to snap a pass to Jack Squarebriggs who was "Johnny on the spot" to slam the rubber past Lefurgey for the opening goal. It was a smart count and brought the fans to their feet.

For upwards of thirteen minutes the Abegweit defence was practically airtight. Spillet and Power teaming with Williams were carrying well and poke checking good. After many unsuccessful cantos to the Abbie blue line the Crystals opened the score.

Second Period Opened fast with Abegweits taking the offensive, but poor judgment in passing lost them many golden opportunities. Saunders finally broke away to go in on top with Squarebriggs who in some manner got mixed up with the disc and lost another chance. After twelve minutes of play D. Gillis broke the tie score on a high back hand shot on a pass from Walter Lawlor, the disc hitting the net high, wide and handsome.

After this score Crystals perked up a bit but could not get through. Williams was banished for "bumping" in to Gauthier, and was followed shortly by Grady, for slashing. At this juncture, the above mentioned "entertainment" which did not appear on the program, was staged, with the hot-tempered fans furnishing most of the amusement. Those who remained in their seats enjoyed the fun immensely. Crystals left the ice and appeared about ten minutes later to resume the game. The two chief offenders, Grady and Nicholson, received three and five minutes respectively.

At the face-off Saunders took a pass from Squarebriggs to go through but was hauled down by Grady, who was again banished, this time for tripping. One minute later Saunders coasted in on a pass from Bill Power to try Lefurgey who loses the rebound to Saunders who followed up the shot and smoked it into the net. Score—Abegweits, 3; Crystals, 1. There were five penalties handed out in this period, Grady getting Summerside's three, while Williams and Nicholson represented the locals.

Third Period At the opening of this session, which found the red and black clan climbing in on top of Lefurgey, Nicholson was again chased for two minutes. The Abegweits lulled their offense as a consequence, but were forced to bend after a great stand to a four man attack, Gallant scoring via the Schurman, Silliphant, Saunders route. On the realization of this score, Crystals tried with might and main to even the count, but the Abbie line held firm until Nicholson arrived back on the ice. Tired by their previous exertions the visitors slackened their pace somewhat. Gillis, noticing the lull, sent his team into the game in terrific fashion, Saunders making the grade a few minutes before the final bell.

(Canadian Press) HALIFAX, N. The locals went into lead again in the second period on Ferguson's goal from a mixup in front of Truro's cage. Murdoch scored the equalizer in third and Jemmett put them up on solo rushers.

KENTVILLE, N. S., Jan. 23.—New Glasgow dropped into second place in the Eastern League here tonight when Kentville scored the only goal of a 3-2 count in an overtime period.

FREDERICTON, N. B., Jan. 23.—Fredericton Millionaires romped away with a game from the Moncton Vice in the Southern N. B. Hockey League here tonight, the score standing 3-1 after full time of fast hockey in which the home team had a wide margin.

THE MARKETS

MONTREAL, Que., Jan. 23.—7 1/2 prices were slightly higher, but wheat and cheese advanced, while potatoes were unchanged on the produce and dairy market here today. Ont. pig fresh eggs in carlots were from 19 to two cents higher; extras graded two cents at 30 cents a dozen and firsts advanced one cent to 25 cents, while seconds were unchanged at 20 cents a dozen. British Columbia fresh extras were one cent higher at 30 cents a dozen and firsts and pullets were unchanged at 25 cents a dozen. Storage eggs were unchanged, extras being quoted at 19 cents, firsts at 16 and seconds at 14 cents a dozen.

Quotations to retailers were unchanged. Receipts were 234,000 lbs. Eastern townships number one pasteurized creamery butter advanced one quarter of a cent at 31 3/4 to 32 cents a pound to retailers. Solids were 35 cents and prints 34 cents a pound. Receipts were only fifty one boxes. Winter white cheese was unchanged at 11 to 11 1/2 cents a pound, but winter colored gained one half of a cent at 13 to 13 1/2 cents a pound. Summer cheese was also up half of a cent, being quoted at 15 1/2 to 16 cents a pound. Receipts were 161 boxes. New Brunswick green mountain potatoes in carlots were quoted at 85 cents per ninety pounds bulk and 80 cents per eighty pound bags. Ottawa, Ont., Jan. 23.—Some further improvement is noted in the underline of Canadian egg markets today with weather conditions favorable. Toronto—A better enquiry for eggs is reported on this market and prices are steady, although unchanged. Brokers report sales of Ontario graded shipments of fresh eggs at extras 27, firsts 24, pullet extras 20 to 22, seconds 18 delivered. British Columbia are offering on the basis of extras 29, firsts 25, pullet extras 23 delivered. A sale of storage firsts is reported at 12 delivered, but some holders are refusing to sell for less than 15. Montreal—Egg receipts here today were 2,374 cases as compared to 806 cases on the corresponding day last year. There is a better feeling on this market today; a case of storage firsts and seconds is reported sold on the basis of firsts 16, seconds 11. The undertone on fresh is also firmer, although prices remain unchanged. Vancouver.—Wholesale producers on this egg market remain unchanged at extras 18, firsts 13, pullet extras 14. The producers pool is selling eggs to wholesalers at extras 22, firsts 20, pullet extras 18. Wholesale prices of fresh eggs to retail stores are extras 23 to 25, firsts 21 to 22, pullet extras 19 to 20. Chicago spot 20, April future 20 1/4.
