The choir members have been practicing diligently under Professor Auger for several months, and the results were apparent in their rendition of a varied and difficult program. Both in individual numbers and in choral parts their work was excellent, and the appreciation of the audience was evident from the enthusiastic applause which greeted every number.

Particularly effective was the choir's rendition of the great Cesar Franck number, "Panis Angelicus", with Prof. Auger taking the solo part. This sublime piece is a characteristic example of Franck's religious music and requires deep feeling as well as vocal skill in its interpretation.

Other outstanding were the choir's rendition of "Good Night Sweet Jesus" (A. T. Bourque) with Miss Frances McNamee as soloist; "The Blue Danube" by Johann Strauss; a charming melody of French traditional airs; and "Te-De-um" by Lionel Dunaus.

"Gracie Song" (Brahms), "Gay in the Rose" and "The Rose Tree" were sung by a quartet comprising Prof. Auger, Messrs. Frank McIntyre, Leo Doron, and Emile Dorian.

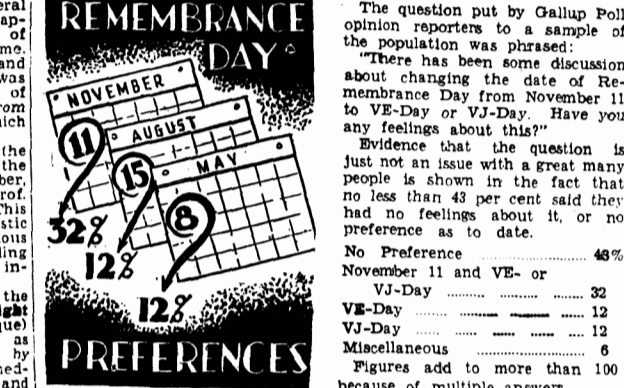
GENERAL PUBLIC IS UNEXCITED ABOUT REMEMBRANCE DAY DATE

But Largest Group Would Prefer to Continue With Nov. 11

By CANADIAN INSTITUTE OF PUBLIC OPINION

TORONTO, July 2—Sporadic debate as to the most suitable date for a national "Remembrance Day" leaves the public fairly cold, but those who do have any feelings on the matter lean towards continuing with November 11.

Largest single group, representing nearly half the population have no preference as between November 11 (Armistice Day for World War I, D. May 8 (VE-Day) or August 15 (VJ-Day).



The question put by Gallup Poll opinion reporters to a sample of 1,000 Canadians was: "There has been some discussion about changing the date of Remembrance Day from November 11 to VE-Day or VJ-Day. Have you any feelings about this?"

Evidence that the question is just not an issue with a great many people is shown in the fact that no less than 48 per cent said they had no feelings about it, or no preference as to date.

File 21 Charges Against University Of Chicago Student

CHICAGO, July 2—(AP)—Police filed 21 charges of assault or robbery today against William Heirens, 17-year-old University of Chicago student, they say he has been linked by finger and palm prints to the Suzanne Degnan kidnap.

The move apparently assured them of keeping the youth in custody until the charges are investigated of the kidnap-slaying of the six-year old girl last week.

Heirens' counsel, Roland Towle, said no effort would be made to return the youth to the University. Earlier today, Chief Justice Harold G. Ward dismissed the youth's petition for freedom on a writ of habeas corpus.

Mr. Towle, who saw his client yesterday, said he knew nothing about the ransom note except that it was exhibited to him by the police and was typed to copy it. He added that Heirens would plead innocent tomorrow to the 21 charges, including the kidnap-slaying.

None of the charges involve the "D-noon" case.

Heirens has been questioned intermittently about the Degnan case since shortly after his arrest last Wednesday night on the north side, where police said he was found prowling in an apartment. He has denied any complicity in the kidnap-slaying.

The Federal Bureau of Investigation telegraphed Walter Stovitz, chief of detectives Monday that Heirens' palm print as well as the print of his left little finger were identical to prints found on the \$20,000 ransom note.

Mr. Towle said his detector tests which the youth undertook were "inconclusive" because Heirens was "uncooperative." In a "hand-writing" test, Mr. Towle said, Heirens misspelled two words as "waite" and "safty" exactly as they appeared on the ransom note. The prosecutor also said a writing pad, containing sheets of paper similar to one which the ransom note was printed had been found in a washroom at Hall at the University of Chicago, where the youth lived.

visit to the Boy Scouts and Girl Guides of France, of her landing at Dieppe where so many Canadians had died on their ill-fated landing, and her visit to the Scouts and Guides on the Champs Elysees and her visit to Alsace-Lorraine. She spoke of the movement in Switzerland where at one time one million Swiss guarded the Swiss frontier from German attack.

Her visit to Italy showed that the Boy Scout and Girl Guide movement there was slowly regaining ground from the evil results of Fascism. Prior to 1920 the movement had been strong in Italy but under Mussolini the name of the movement had been changed to "Balilla". Not only was the name different, Lady Baden-Powell said, but the principles of democracy and the love of freedom were no longer taught. Instead a super-nationalism was developed and the whole moral fabric of the organization, as it is known in England and the United States, was swept away.

She told of the Boy Scouts and the Girl Guides of England having raised 170,000 pounds for the relief of the countries of Europe, of how teams were sent out to Greece to help the Greek population and of the gratitude of the Greek people.

Groner's Jury Recommends Further Investigation

A coroner's jury last night found that Ernest L. Essery, Charlottetown, came to his death on June 28 last from injuries received in an unaccountable manner and recommended a further investigation be held into the cause of the injuries. They absolved the Canadian National Railways of all blame in the death of Dr. J. D. MacGuigan, the coroner.

Dr. J. Yoo said he examined the deceased who had a fractured skull, the left arm almost severed, and several other serious external injuries. There was no evidence of alcohol. The cause of death was loss of blood, shock, and severe injuries.

Joseph Paquet, locomotive engineer from Charlottetown, was arrested on the train which was sidetracked and stopped train and extended the train to the track who was unconscious. Witness did not touch the man.

Ernest Essery, brother of the deceased, said he left his brother, Ernest, Thursday morning at 9:30. Deceased was then in best of health and was a would-be away on a trip. Deceased had been fairly deaf for the last two or three months.

James Spencer, undertaker, said there was lots of room for train to go by without touching the deceased and Col. Lionel Strong, R.C.M.P., gave evidence of having taken photographs at the spot where the body of the deceased was found.
