Annual Meeting

—The Annual meeting of the
O'Leary Pastoral Charge of the
United Church of Canada was held
in the Sunday School room of the
O'Leary Church on Thursday after-
noon, Jan. 12 with the minister,
Rev. W. G. Dickson presiding. The
minutes were read by the Record-
ing Steward, Mr. Bruce MacDoug-
all. Representatives were present
from Brae, Bloomfield and O'Leary
and reports were also read from
West Devon, the four congrega-
tions comprising the O'Leary Pastoral
Charge.

Reports show that 1949 was an ex-
cellent year from every standpoint.
The O'Leary reports were given by
Mr. A. J. Matheson. The Brae re-
port was given by Mr. F. W. Mac-
Leod. The Bloomfield report was
read by Mr. R. F. MacAusland. The
minister read the West Devon re-
port.

Highlights of the year were:—
O'Leary Church installed new pews
costing \$2300, free of debt, and
procured new choir gowns, new
baptismal font and stand.

Bloomfield Church painted at a
cost of \$375.00.

Visits of Dr. Catherine Whittier
of India at Bloomfield and Miss
Elma Inman of Trinidad at the
four congregations on the pastoral
charge were greatly enjoyed. The
visit of the President of the Mar-
itime Conference, Rev. A. A. Mac-
Leod of Whyocmagh, N. S. to
O'Leary in November was a mem-
orable occasion as was the visit of
Rev. Dr. Ross Flemington, Sack-
ville, N. B., President of Mount
Allison University, who was the
special speaker on May 29th at the
26th Anniversary of O'Leary
Church.

Dr. L. W. Shaw of Charlottetown,
Director of Education for
P. E. I. was heard in a delightful
lecture on Newfoundland under
the auspices of the Young Peoples
Union. Rev. John Jarvis, Sackville,
N. B. and Rev. K. G. Sullivan, Sum-
merside, P. E. I. were welcome visit-
ors as was Rev. Dr. W. S. God-
frey, Sackville, N. B., Supt. of Mis-
sions for the Maritime Confer-
ence.

The Missionary and Maintenance
Fund reached its objective of
\$675, a record high total: 68 per
cent of the Mount Allison Cam-
paign objective of \$1,000 was raised.
This is a 3 year campaign and the
charge will complete the rest of
the total in 1950 and 1951.

There were 38 new members ad-
ded to the church's roll in 1949,
the largest number in any one
year since Church Union in 1925,
of that total 27 new members are
from the O'Leary Church. The
largest number of communicants in
the history of Bloomfield Church
attended Holy Communion on
World Wide Communion Sunday
in October. There were 18 funerals,
25 baptisms and 5 marriages. The
Woman's Missionary Society groups
in O'Leary and Bloomfield raised
the magnificent total of \$735.00
for missionary purposes.

Summerside
Firemen Hold
Annual Dinner

Summerside firemen last night
held their annual dinner at the
Olympic Restaurant and a full at-
tendance of the members enjoyed
one of the most successful get-
togethers in a long line of successful
banquets. Seated at the head table
were Fire Chief W. B. MacNeill,
who acted as toastmaster. His Wor-
ship J.F. Arnett, Councillor Henry
W. Wedge, Town Clerk Hale
Strong.

Among the honored guests pre-
sent were ex-Fire Chief Thomas
Johnstone, who joined the brigade
in 1892 and served faithfully until
after the fire of 1918 in which a
large portion of the business sec-
tion of Summerside was wiped
out. Older residents of the Town
will recall that Mr. Johnstone was
assistant fire chief during the dis-
astrous fire of 1906 when a large
portion of the residential portion
of the Town was burned.

Also present last evening was
Assistant Fire Chief Claude Ken-
ny, who has been a member of the
Department since 1897. Assistant
Chief Kenny is still an active
member of the brigade and at the
last annual meeting he submitted
his resignation which was unan-
imously rejected by all firemen
present. Only three members of
the Department who were active
when Mr. Kenny joined the De-
partment, Mr. William Mathieson and
Mr. Kenny himself.

His Worship J.F. Arnett, on be-
ing called upon to speak first, ex-
pressed his appreciation of the in-
vitation to be present, and con-
gratulated Fire Chief MacNeill
upon his election as Fire Chief of
the Maritime Provinces. He also
expressed his sincere thanks to
the Department for the fine ser-
vice it has rendered to the Town
in protecting the property of the
citizens in time of fire hazard.

Mayor Arnett said that due to
the vigilance of the local brigade,
fire losses in Summerside were
very low. He paid high tribute to
the services of Assistant Chief
Kenny whose resignation was not
accepted when tendered at the last
annual meeting.

Other speakers were Councillor
Henry W. Wedge, who spoke of his
appreciation of the fine cooperation
given him while he was in the
council. Short speeches were also
given by Councillors L.G. Gor-
hill, H.B. Schurman, Hale Strong,
the Town Clerk, and Carroll Del-
aney, M.L.A. A brief but witty
speech by Ex Fire Chief Johnstone
was responded to by all members
singing "For He's A Jolly Good
Fellow".

Splendid entertainment was pro-
vided by Albert Huestis as pianist,
Doug Pineau on the accordion,
Roland Sheen, tap dancing and
H.B. Schurman as song leader.—S.

who is a wheat farmer at Kelehar,
Sask., but spends his winters in
Regina; and Mr. and Mrs. Cud-
more, Mr. Cudmore is from Brack-
ley, his wife being a former Miss
Reeves, of Freetown.

Mr. MacKenzie was pleased to
find that in every centre he vis-
ited, Prince Edward Islanders
were not only prosperous but took
a prominent part in community
activities.

Doing Good Job

Although not a supporter of the
C.C.F. Party, Mr. McKenzie said
he considered that Premier De-
groot, but spent his winters in
the Province of Saskatchewan, par-
ticularly in the fields of education
and public health. At present there
are over 4,000 students attending
the University of Saskatchewan.
He found that in small towns of
the four-room schools, not only the
principal but the vice principal
held a university degree. The pub-
lic health activities are financed
through a capital levy of ten dol-
lars per head with a maximum of
thirty dollars per family. As an
instance of the many services
rendered, he was informed that
in isolated districts where a per-
son is taken suddenly ill, a plane is
sent out at a nominal fee. The
criticism levelled frequently
against the Saskatchewan Govern-
ment, that a man cannot deed his
farm to his son, Mr. McKenzie
found to be absolutely incorrect.

In the West the overall picture
is fairly bright. Mr. McKenzie
states: He visited one farm where
the man had 25,000 bushels of
wheat in storage. He had heard of
another who had 40,000 bushels
stored. By and large the people
appeared very prosperous and a
great many were spending the
winter in warmer climates. Al-
though the winter was at zero,
there was a common thing to see
large herds of cattle out grazing.
He saw cattle brought into
the stockyards right off the range
in excellent condition.

was on his feet the vehicle was
past and he got a mere glimpse
of the rear of it as it went on up
the road. He then ran back
along the road to a car they had
passed and asked the driver to
pursue the truck. Going back to
the scene of the accident he found
Miss Gallant in the centre of the
road crying for help, and Miss
MacKay lying on the edge of the
pavement.

Afternoon Session

Leonard Arsenault, the first
witness called in the afternoon,
told of being at the B.A. Service
Station on St. Peter's Road and
of starting to walk home at ap-
proximately 12 p.m., walking on
the shoulder to the left of the
road. He saw four people com-
ing toward him and heard Sylvia
MacKay's laugh. He then saw
a vehicle which was coming along
the road behind them pull to the
side of the road and strike them
from behind. He had thought at
the time that the truck was pull-
ing over to stop.

One of the girls, he stated, was
knocked under the truck and out
to the centre of the road. The
truck went to the centre of the
road and then pulled over to the
side on which he was walking,
forcing witness to jump into the
ditch to avoid being hit. As the
truck passed him he noticed the
driver straighten up as though
he had been leaning down. After
running to the group of young
people on the road, he hurried
back to the service station and
from there telephoned for an
ambulance.

Witness stated in his evidence
that they were all walking on
the clay shoulder of the road.
Under cross-examination by Mr.
Bell he admitted that he was
not sure that they were all walk-
ing on the shoulder, but that one
might have been on the pave-
ment. Mr. Bell also brought out
the fact that witness did not no-
tice evidence of speed, and that
there was no increase in the rate it
was travelling after the accident.

Arsenault told of seeing a red
light on the rear of the truck
flashing as it passed the ser-
vice station.

One of the other victims of the
accident, Miss Joyce Gallant, was
next in the witness stand, but
stated that she could not remem-
ber very much about what hap-
pened. She could recall walking
along the road talking, but did
not know what hit them. Her
next recollection was of being
in the ambulance, and then in the
hospital where she stayed for
2-1/2 months.

Preston Cudmore, of Winsloe,
told of hearing the truck go by
his parked car and a few minutes
later the sound of a crash reached
him. He followed the truck
as far as the cemetery, and no-
ticed that its headlights were now
burning steadily, and was also
able to see its licence plates. He
pulled up alongside the truck
and called through the open win-
dow of his car to the driver but
received no reply. Stopping his
own car he turned around and
returned to where the accident
had happened. Under cross-ex-
amination he stated that he
thought the truck was going at
about 20 or 25 miles per hour.

No License Record

John Gallant, of the Motor
Vehicle Branch of the Provincial
Treasury, was then called and
stated that a search of the records
had been made and that no driver's
license had been issued to
Cecil Lester Robert's either in
1948 or 1949. No cross examina-
tion.

The next witness called was
Ivan Vessey, of Parkdale, who
stated that while parked at an
intersection he saw a light pass
along the highway. He heard a
crash but did not immediately in-
vestigate. Passing by the scene
of the accident he followed the
truck at some distance and saw a
car pass him and overtake the
truck, pulling up alongside it. As
he watched, the car stopped while
the truck proceeded on its way.
He then followed the truck for
from 2 to 3 miles, and noticed
that the truck now had lights, and
was driving on its correct side of
the road.

Under cross-examination by
Mr. Bell he stated that he
thought the truck was travelling
at approximately 30 miles per
hour.

Constable Smith of the R.C.
M.P. told of making a search and
finally finding a truck with the
correct license number in a field
by the summer cottage belonging
to Hubert Roberts at Pleasant
Grove. Near the truck a sedan
was parked and the defendant
was asleep on the rear seat. This
was at approximately 2.35 a.m. Prisoner
stated he had arrived in the truck
soon after midnight and was ar-
rested for failing to stop at the
scene of an accident. He then
passed the keys of the truck over
to Constable White who drove it
into the Charlottetown R. C. M. P.
barracks.

Cross examination brought out
the fact that when apprehended,
Mr. Roberts appeared to be quite
sober, his speech and condition
being normal.

The final witness called during
the afternoon was Constable
Johnston, R.C.M.P. who had
made photographs which were
shown in Court, both of the
truck in question and of the
roadway where the accident oc-
curred. He stated that he had
found reddish stains on the
right headlight of the truck, on
the reflector and rim, and also
shreds of clothing. At the scene
of the accident he had photog-
raphed three large reddish
stains on the road.

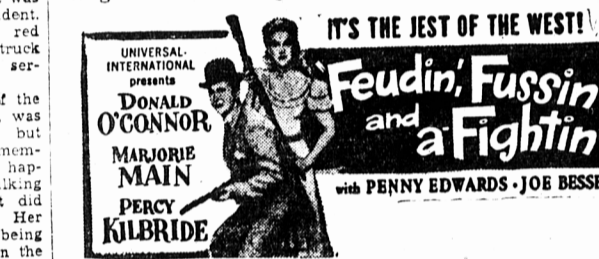
