**VALENTINO'S ESTATE IS VALUED AT \$500,000**

LOS ANGELES, Sept. 11.—The examiner says that Teresa Warner, an aunt of Rudolph Valentino's wife, Natascha Rambova, shares equally with Albert and Maria Guglielmi, brother and sister of the dead actor, in his estate. The estate is valued at \$500,000 exclusive of the actor's interests in last pictures. In addition to \$50,000 life insurance policy, the will of "Falcon's Lair," Valentino's \$100,000 home in Beverly Hills, a collection of armor and antiques valued at \$75,000, his motor cars, horses, and dogs, and a private yacht among the properties of the estate.

Valentino's last will is said to be broken and a will made in New York naming Miss Rambova, Winifred Hudnut, as she was known in private life, as sole heir, the dancer and former wife of Valentino is said to have been cut out with \$1 in the subsequent will. The remainder of the estate is left to the only three named heirs.

**John Smith and His Car**

 John Smith is a character whom every motorist should welcome. He is not selfish, rather he is a generous man, a chap willing and glad to have exploited, in an interesting way, his experiences for the benefit of the other twenty million or more members of the motor clan.

UPON INVESTIGATING, Smith discovered that the fire damage to his car was more serious than he thought it was. When he presented the bill to the starter motor was all right as usual, but that from the engine.

Smith knew what the matter was. He declared at length, "The fire burned all the gasoline in the car. This was only half true as explained to him. The backfire had burned the gasoline in the car. The vacuum tank had not spread to the vacuum tank, otherwise there would have been an explosion. There's plenty of gasoline in the vacuum tank," I said, pointing to the chamber which was overflowing. The needle valve is stuck and the fuel is flowing down from the vacuum tank. I spent about fifteen minutes removing the cover from the float valve and float in the needle places. The carburetor showed evidence of fire on the outside, but in any case it would require a thorough cleaning. Finally I adjusted it so that the needle valve opened and closed properly.

"Now try cranking again," I suggested.

The starter motor churned. The engine started. It skipped, coughed and then stalled. We had overlooked the fact that the insulation was burned off the ignition wires.

When the garage man saw this he offered to put on his mechanics immediately on the job of rewiring the engine.

"I'm insured," Smith said. "I'm insured, you know. The insurance company will pay the bill. And, by the way, while you're working on it, can you see what ails this clutch? 'One minute' I urged. "Let me things too quickly. You are fully insured in a reliable company, but must deal with the company's representative, the company's adjuster. When an adjuster is sent to inspect a loss he assumes that there is a claimant. He assumes that ahead of your own accord. If you go this car repaired he will have to take your word for it that the car really had been damaged."

Smith interrupted to remind me that he would have the repair bill for me.

"That would only further complicate matters," I replied. "You were just now suggesting that the mechanic do some work on your car. That wouldn't be the company's obligation. The best plan is to send a written notice of the loss, together with a rough estimate of the cost to repair the damage, to both your insurance broker and the insurance company. Doubtless the adjuster here in the city will investigate losses reported by your broker or the agent. When the adjuster sees the loss and learns the details he will authorize co-operating with him in this way there won't be any 'hitch' in the adjustment of the loss."

"That's all right in this case," Smith argued. "But what if my car had been damaged while on the street. Would I have to leave it there until an adjuster authorized me to take it to a shop?"

"You would be voiding your policy contract if you didn't remove it," I retorted. "Better read your policy again, especially the part where it speaks about protecting the property against further damage."

But Smith was impatient to present the claim and have the new experience of meeting an adjuster. He was yet to learn that the fire policy had been written with the understanding that he would equip his car with a fire extinguisher and that he had technically voided his policy by not doing so. It is sometimes well to anticipate trouble.
