The Monument Movement

From time to time the question of erecting a Provincial Soldiers' Monument had been discussed and different opinions were expressed as to what form it should take.

Mayor Jenkins explained the object of the meeting and the following resolution was moved by Mr. Jas. Paton, seconded by Col. D. A. MacKinnon:

That the action of the Mayor and City Council regarding the proposed Soldiers' Monument be endorsed by the Citizens' Meeting.

The following Committee was appointed: Col. D. A. MacKinnon, S. A. McLeod, James Paton, C. H. Chandler, W. F. Tidmarsh, D. J. Riley, Col. W. B. Prowse, John McKenna, Mrs. W. S. Stewart and Mrs. S. R. Jenkins.

The City Council selected Councillors Wm. Moran and George McLeod to represent them on the Committee. The functions of the Committee were to consider the amalgamation of all funds available for the erection of the monument, and the recommendation of the Council of the situation, character and estimates of the probable cost, with suggestions for the best method of raising the money for the purpose, and all such other information as would enable the Council to assist and to bring the project to a speedy completion.

After the public meeting a meeting of the Committee was held and Col. D. A. MacKinnon was appointed chairman and S. A. McLeod, Secretary of the Committee.

At the meeting on November 2nd the Chairman and Secretary were appointed to immediately secure designs and cost of suitable monuments, the price to be not more than \$16,000.

At the meeting on January 10th, 1923 a suggestion was made that the Provincial Government might contribute toward the Monument, the Committee, consisting of His Worship and Mr. Tidmarsh were asked to wait on the government with the object of securing their support.

Site Selected On July 14th, 1923, the Monument Committee met and selected a site. On motion of Mr. Tidmarsh seconded by Mr. C. H. Chandler, a resolution was passed that the Monument be erected on the North Side of the Square, facing Great George Street, just inside the present rail of posts. This recommendation by the Committee was afterwards approved by the City Council.

At the meeting on November 2nd the Chairman and Secretary were appointed to immediately secure designs and cost of suitable monuments, the price to be not more than \$16,000.

At the meeting on January 10th, 1923 a suggestion was made that the Provincial Government might contribute toward the Monument, the Committee, consisting of His Worship and Mr. Tidmarsh were asked to wait on the government with the object of securing their support.
