The second half was a repetition of the first. The Vics were continually forcing things, their forwards getting in splendid work. Rodd by a clever run scored in four minutes after play.

Perry and Gallant got in some nice work but the Vics failed to connect with the net. Rodd again, by one of his swift dashes, got another for the Vics in six minutes.

With the Vics still forcing matters the Crystals were kept on the defence. Four minutes elapsed when Prowse passed to Rattenbury and another score was made.

The Crystal defence resorted to lifting and the game lagged in consequence. It took twelve minutes for another score to come when A. Rattenbury, by a pretty piece of individual work, went from end to end of the Rink and netted the rubber.

CHESHIRE RAILROAD'S FIRST LOCOMOTIVE.

The dedication of the new passenger station at Keene, N. H., calls to mind the first locomotive purchased by the Cheshire Railroad company which bore the name "Rough and Ready." It was a very light machine, bought of the old Boston and Lowell railroad. When it arrived at Ashburnham junction, it was drawn over the highway by oxen about 3 1/2 miles to a point above the junction, where the road crosses the old turnpike, the roadbed being ready for ballast from that point to Winchendon. About four days was required for its transportation in the same manner, as the deep ledge cut about the junction was incomplete. It was the first locomotive seen by the young people of about 25 families in the northerly part of Ashburnham. Soon after the completion of the road the Rough and Ready was sold to a lumber company at Whitefield, N. H., where it was used in hauling logs from the woods to the company's mills.--Winchendon Courier.

GIRL HYSTERICAL ON WITNESS STAND

NEW YORK, Feb. 27--Miss Annett Berthe Grunspan, the pretty young Russian who is suing William English Walling, the millionaire Socialist, before Justice Giegerich in the Supreme Court for \$100,000 for alleged breach of promise, collapsed on the witness stand today.

Unnerved by a grilling cross-examination, Miss Grunspan denounced Walling's counsel, and after screaming that he treated her harshly, she collapsed in the witness chair and was carried to an ante-room.

Miss Grunspan's mother rushed to the counsel table where Walling and his wife were seated, but she was prevented from reaching the table by court officers. After Miss Grunspan quieted the trial was resumed.

Miss Grunspan was being questioned by Mr. Fuchs, Walling's counsel, without waiting for Walling's counsel to ask her if she knew the man, Miss Grunspan shouted:

"Do you know a Mrs. Kleeman?" "No."

A woman stood up at Mr. Fuchs' request. Miss Grunspan looked at her and then exclaimed:

"Mr. Emsler, stand up," said Mr. Fuchs, not seeming to notice the young woman's outcry.

A man arose among the spectators. Without waiting for Walling's counsel to ask her if she knew the man, Miss Grunspan shouted:

"Do you know me, sir?" "The man did not reply and sat down."

"Did you tell Mrs. Kleeman that you were an attorney?" counsel demanded. Mrs. Kleeman, according to the defence, was the janitress at No. 34-1-2 St. Mark's place in 1906.

"It's a lie, a terrible lie," replied the plaintiff, the tears showing and her voice trembling. "I did not. I never did."

"But you gave her hats and laces?" "I gave hats and laces to many people and maybe I gave some to her, if she is the janitress there."

"Well, Miss Grunspan," continued the lawyer severely, "when you left that address was it not because this lady objected to your presence?"

The plaintiff stared at the lawyer for an instant, then she buried her face in her hands.

"She lies, she lies, she lies," was the answer, half a scream, half a moan. "You lie, Mr. Fuchs. You are torturing me. Oh, you--How much did you give that to come here and testify against me? This is awful, it is horrible. I cannot stand it. I cannot. Oh, honorable court, protect me. I cannot--"

Then hysterics overcame the pretty young woman. She stiffened in the witness chair, with her head resting on the back and shrieked until she was heard throughout the courtroom. She shook like a leaf and her limbs twitched as if she were in a fit. A. K. Stricker, her counsel, rushed to her side, as did a woman friend. The latter held a bottle of smelling salts under Miss Grunspan's nose, and in a few minutes she retried into Russia.

"He's buying these witnesses," she exclaimed, between sobs. "I never knew one of them. Let me get up. I want to face those people."

It was late in the afternoon before the plaintiff made her reappearance on the witness stand. She showed the effects of the ordeal of the morning; her face was pale and her eyes swollen with weeping. The most substantial evidence supporting her allegation that the defendant promised to marry her was introduced by her lawyer in the form of certified copies of passport for entry into Russia.

She made out in the names of William English Walling and "his wife, Anna Berthe." To obtain the originals, the lawyer said, Walling had to swear that Anna Berthe Walling was his wife.

Miss Grunspan's demeanor on the stand in the afternoon was cool and less demonstrative than during the morning. She parried difficult questions with ease and counsel for the defence made little headway in his efforts to shake her testimony given on direct examination.
