Church of which he was a faithful member, and in which he so regularly worshipped. The services were conducted at the house and church by the Rev. For some time past many of the Stock Breeders, in conjunction with the Department of Agriculture have been endeavoring to secure from the Canadian National Railway the operation in this province of a live stock demonstration train similar to those being operated in Ontario and the western provinces. In this effort Messrs. V. R. Shaw, Provincial Live Stock Superintendent, Mr. J. A. Clark, Superintendent of the Experimental Station, Mr. B. R. Brown, York, and Mr. William Gibson Marshfield, took a prominent part and left no stone unturned to achieve their purpose. Frequent conferences were held with the Railway authorities, the federal Department of Agriculture and prominent breeders in the province with the result that yesterday official notice was received that the concession had been made. Arrangements have been completed whereby a special live stock train will be put on between Charlottetown and Tignish during the week commencing August 10. Stops will be made at Hunter River, Emerald, Albany Kensington, Miscouche, Wellington, Northam, O'Leary, Elmston and Tignish. On this train small and select herds of Holsteins, Ayrshires, and Guernseys will be carried. There will also be cars of Yorkshire hogs, sheep and poultry. Its occupants started out on what was thought to be a clear line. Just as the coach was reaching the St. Dunstan's College crossing, however, a train approaching in the opposite direction at quite a high rate of speed, giving the endangered men not even time to stop their car. While the Superintendent was getting out his foot caught in the door and for the fraction of a minute it was touched and go. With the assistance of his companion he freed himself, and both jumped clear in the nick of time. The locomotive driver also had no time in which to stop, and the train stopped with great force, derailing the engine and causing the total destruction of the transmission gears of the coach, besides a great deal of damage to the hood, windows, and frame work. After the first impact, the train was driven backward and rolled away from the train, which as a result lost momentum hit it with another crash. The coach, however, never left the track.
