CONCLUDING C.W.L. SESSIONS AT KENSINGTON

The concluding sessions of the 14th Annual Diocesan Convention of the C. W. L. took place in the McMahon House, Kensington, on Thursday, Sept. 17th with the Diocesan President, Mrs. Frank Murray in the chair. The business of Convention was resumed. The reports of the different convents were read and discussed.

The organization of eight district units, six in Souris and two in Alberton respectively, was noted in the comprehensive report submitted by Mrs. Margaret M. Murphy, Diocesan Executive Secretary. This year the membership has increased to approximately 1450, the increase being especially noticeable in those parishes where district units are functioning. During the year the splendid total of \$8,457 was raised collectively by all the subdivisions, of which amount approximately \$7,000 was spent in parish work, church debts, social service work, etc. Other matters dealt with in the secretary's report included education and scholarship, study clubs, social service and child welfare (the Charlottetown subdivision contributes a yearly quota of \$200 toward the social service department of the City Hospital); sisters of service; business women's unit; closed retreats, and miscellaneous items.

An excellent report was also submitted by the corresponding secretary, Miss Marion E. Conway.

The work on Study Clubs was thoroughly explained by Mrs. A. J. Howatt, Charlottetown, as leader, and different ways and means were brought forward to make the movement a success.

The Resolutions Committee then brought in their report and the following resolutions were adopted:

RESOLVED that we do herby support and sustain all the resolutions passed at the National Convention held last June in Regina.

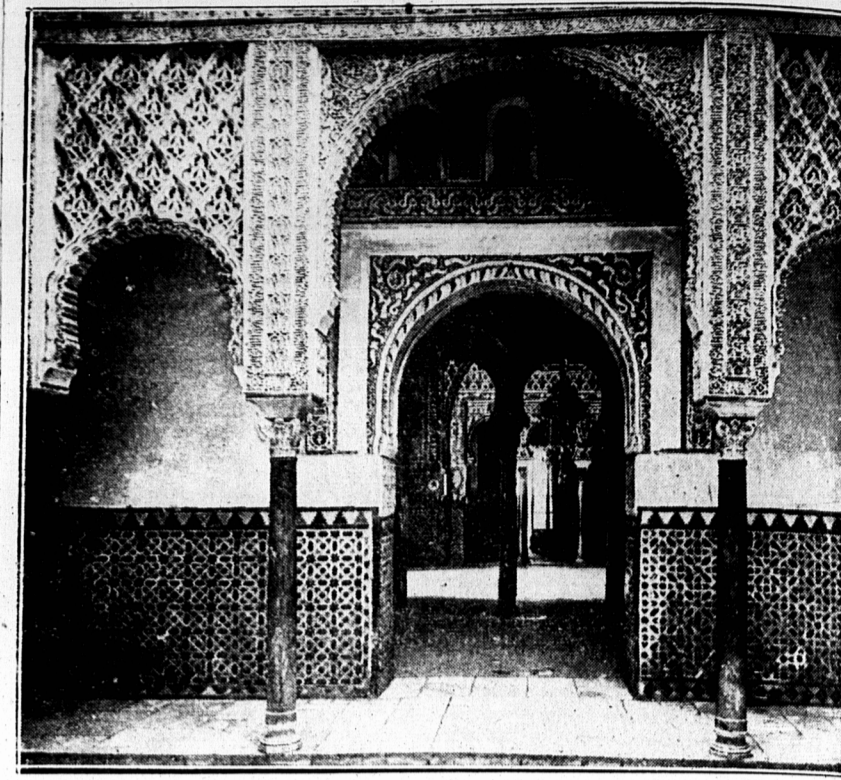

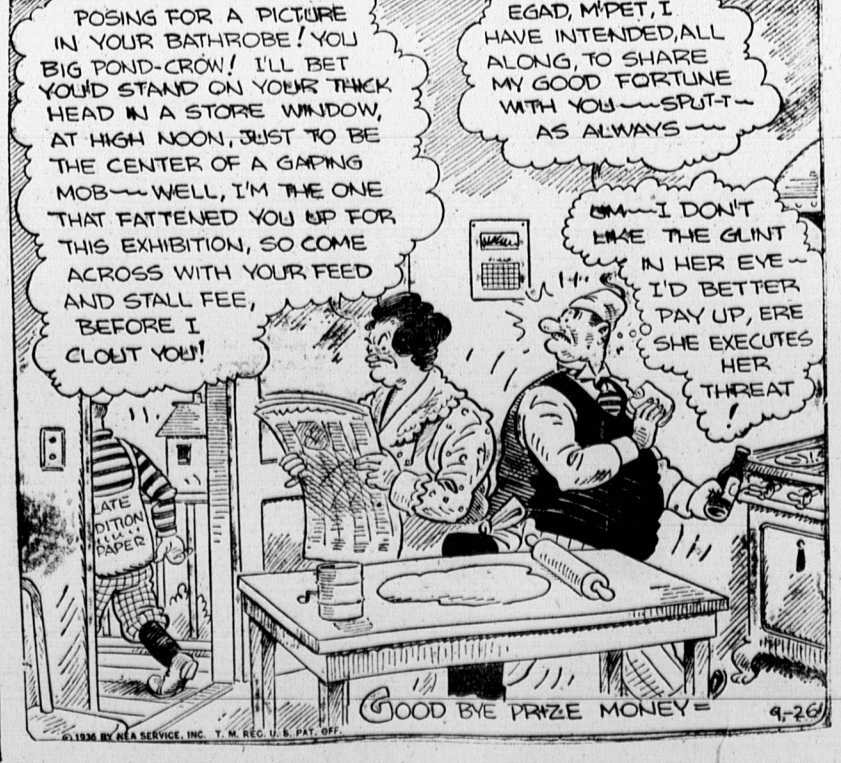
