CRIPPEN AND GIRL STILL AT QUEBEC

QUEBEC, August 21--Contrary to general expectations Inspector Dew did not take his prisoners, Dr. Crrippen and Miss LeNeve, home by the steamers Royal Edward or Lake Mont-Robert and both are still at the Quebec jail. Owing to the rumor that the prisoners would be spirited away to Rimouski or Father Point, there was a large gathering of people about the jail last night, who waited anxiously to get a glance at the pair.

A letter was received at the jail addressed to Dr. Crrippen. On opening it Governor Morin found that it contained a circular upon which was printed a sermon, it was torn up.

Both prisoners are stated to be anxious to get away. Speaking to Governor Morin, Dr. Crrippen asked: "When do we leave?" On being informed that their departure was not known he said: "Oh, well, I suppose we will not be delayed long now."

The arrival of Detective Mitchell with the necessary papers from Ottawa is still awaited, and until he gets here there will be nothing done.

The breach has widened between the English and provincial authorities in the Crrippen affair. Apparently the officer at Parliament House have sided with the Scotland Yard men, and the county officers are being kept utterly in the dark as to developments.

The fact remains, however, that until specific authority arrives the county officials will not permit the removal of Crrippen or Miss LeNeve from the jail.

This authority has not yet come, and there is reason to expect that it may be delayed for some days yet.

Justice Groulx is at Tadoussac, and communication with him is difficult. His order is necessary before Acting Sheriff Begin will permit the removal of the prisoners.

Inspector Dew and Sergeant Mitchell are beginning to show the strain they are under.

MILLIONAIRE GAVE AWAY HIS WEALTH.

ST. LOUIS, Mo., August 21--David Rankin, Jr., the millionaire philanthropist and founder of the school of Mechanical Trade at St. Louis which bears his name, is dead in Atlantic City, N. J.

Mr. Rankin endowed the trades school with all his fortune, saving only \$250 a month for himself. He was 74 years old, a native of Boylston County, Londonderry, Ireland. He came in 1862 to St. Louis, which city he made his permanent home until his death.

Mr. Rankin just before departing for Atlantic City in June gave \$3,000,000 of the school of which he was the founder, declaring that for the rest of his natural life he had to be content with \$2,000 each year or \$3 a day. He regretted the publicity attaching his gift.

CHILD EATEN ALIVE BY DOGS.

SYDNEY, Aug. 21--The officers and crew of the steam yacht Surf which was at North Sydney on Wednesday, and was lately cruising on the Labrador Coast, reports that the dogs in that country have become very wild and some of them are very dangerous. Doctor Mulligan of the Surf tells of a case where a little child was eaten alive by dogs before any assistance could be given. The cause of the dogs returning to the wild state is said to be lack of food on the coast.

\$50,000 WORTH OF CLOTH STOLEN FROM RAILWAY.

BOSTON, Mass., Aug. 21--Wholesale thefts of woollen cloth from the Boston and Maine Railroad Company and from various Massachusetts woollen mills amounting probably to \$50,000 are believed to have been disclosed by the arrest here of John J. O'Neil, and Wm. Potter, both of East Boston. The specific charge against them is the larceny of \$360 worth of woollen cloth from the Boston and Maine Railroad.

\$20,000 FOR AIR RACE.

PARIS, Aug. 21--The Paris City Council has decided to offer a prize of \$20,000 for an air race similar to that recently conducted over the east of Paris circuit. The latter race was for a prize of the same amount and was offered for the aviator who made the distance from Paris to Troyes, Nancy, Rezières, Charleville, Douai, Amiens and back to Paris in the shortest lapsed time.

FISHERIES AWARD IN SEPTEMBER

ST JOHN'S, Nfld., August 23--Complete satisfaction at the manner in which the British side of the fisheries dispute with the United States was presented to the international tribunal at The Hague was expressed by two of the colonial representatives at the hearing, who arrived here today on the steamer Mongolian from Liverpool. The men are Sir James Winter, former premier of Newfoundland and a counsel for the colony at the fisheries hearing, and Inspector John O'Reilly, a colonial fishing expert. Absolute impartiality in the dispute was shown by the arbitrators stated the two men. An award in the case is expected about the middle of September but Sir James and the inspector said they could not tell which country the decision would favor. They were hopeful, however, that it would be entirely to the liking of British interests.
