**Explained Conditions**

Mr. L. E. MacKinnon, Rice Point, on behalf of the fishermen explained the situation as he stated it existed. It would be necessary to explain conditions as they were years ago. About 25 or 30 years ago it had been possible for boats in the straits to land large quantities of lobsters. Some years ago fishermen west of Victoria had asked for an open season. In 1918 about 10 cases to a boat (about 2,000 pounds), had been landed each day on the average by each fisherman. An investigation had been held, and the report was made that it would be necessary to protect the buried lobster.

**Funeral Service For Islander At Lawrence, Mass**

The following clipping is from a Lawrence (Massachusetts) newspaper of Jan. 17. The late Mr. Arsenault referred to was a native of Tignish and an uncle of Mr. Eddie Arsenault, Charlottetown, night foreman of the Guardian composing room staff.

**St. Peter's W.A. Annual Meeting**

The adjourned annual meeting of St. Peter's Cathedral branch of Women's Auxiliary was held on Tuesday, January 9th, at three o'clock. After the singing of the hymn "Unto the hills," the President, Mrs. Simpson opened the meeting with prayers and the W. A. litany. The reports of various officers were read and approved and showed that a great deal of good work had been done and much interest shown in the cause of missions. The financial obligations were all met and besides an outfit for an Indian girl, composed of bedding, clothing, etc., had been made and sent to Gordon's School in Saskatchewan. Before Christmas a parcel was sent to the Rev. Charles Palmer in Palampur, India. This contained hand made Altar linen for the church and knitted and crocheted articles for the use of the lepers.

**Encroachments Made**

Clause 6 on the fishermen's license stated that destroying buried lobsters or eggs was an unlawful act, and was an unfair act to fellow fishermen. Clause 10 asked for the formation of an association to protect buried lobsters, and to prevent fishing and canning out of season, or supplying equipment for fishing during the closed season. An association had been formed by the fishermen along the coast for the protection of lobsters.

In reviewing the matter of encroachments of N. B. fishermen Mr. MacKinnon stated that in 1931 a few boats had come down from across the straits, and men from N. B. built a bunk house and cooked on St. Peter's Island. The lobsters had been landed on a lighter, and had been taken over to Pictou to be packed. The fishermen had protested to Ottawa, and expressed the intention of "drop-trap" fishing. Back-line fishing had always been used previously. The "drop-trap" fishing would be the ruin of the industry, Mr. MacKinnon believed.

Last year 19 boats had come to St. Peter's Island and ten or twelve to Victoria. These men had not left a dollar in this province. They had found the good ground which had been protected. No less than 20 boats had come from N. B. and fished illegally in the closed season. Local fishermen had never fished in the closed season. Those men had fished in the closed season every day of the week. They had taken 100,000 pounds of lobsters if they had taken one, Mr. MacKinnon stated.

From Victoria to West Point, there was excellent fishing grounds. The coast further east had very little grounds to fish on.

When the other boats came it was necessary to adopt "drop fishing." The men should not be allowed to drop traps within 150 yards from a "back-line". It was up to the Department to see that the industry was properly protected. There were very small areas of fishing grounds. Those fellows who come over discovered fishing grounds which the local men used, and fished on them. It was the boast of the N. B. men that they would clean up the grounds here, and then go to some other place.

**Illegal Fishing**

Regarding the subject of illegal fishing, Mr. MacKinnon stated that it had been necessary to put on three patrol boats. Those fishermen, when chased by the cutters, ran to the shore and went up the country. Unless the officials were able to get the lobsters on the men it was impossible to do anything.

It was unjust that outsiders should be allowed to operate in Island waters. The fishermen here had protested and brought up their grounds, and now those men who had squandered their industry were coming over to sponge on local men. These outsiders had bragged that they were going to clean out the grounds.

Mr. Daniel Taylor made reference to a meeting in Summerside, where the matter of fishermen of one territory in Prince Edward Island operating in another had been discussed. Those outside people who were coming over made their "blows" that they were going to clean up the grounds. These men used to steal turnips to bait their traps. There were men on the other side who were just as vexed as the people were on this side. It was up to the government to compensate the fishermen, or to prevent the men coming across the straits. Men had been coming to Cape Tormentine with large quantities of lobsters in broad daylight. At the present time those outsiders were equipping fast two engine boats to come over.

Mr. Reuben Betts stated that the fishermen from New Brunswick had used the marks of the local fishermen last year, and he believed that the outsiders would come over early this year.

**Limit to Province**

Mr. Daniel Taylor suggested that regulations be passed to confine the fishermen of one province to the grounds of that province, to give New Brunswick their half of the straits, and let Islanders fish their own waters.

Mr. MacKinnon thought that the fishermen should be prosecuted whether or not lobsters were found on them. He believed that the division line in the straits was a good idea, and would cure the trouble. If nothing was done the grounds would be depleted in two years. He predicted a larger influx of New Brunswick fishermen next year.

Hon. G. Shelton Sharp, Acting Premier, stated that so far as the illegal fishing was concerned, the matter was one of enforcement of law, and believed that the point would not cause much further trouble.

During the last ten or fifteen years the spawn lobsters had been carefully protected on their ledges. If the people had built up a better industry through protection, that industry should be protected from exploitation by outsiders. It might be possible to pass a regulation whereby fishermen would be allowed to operate only in waters adjacent to their province. It would be necessary to define the water line for each province, and to force fishermen to remain in their home waters. Last year 500 fishermen came from the North Side. It was unfortunate that it was not possible to have some regulation whereby men could fish only in their own waters.

The resolution moved by Mr. Betts, seconded by Mr. MacKinnon, and on vote, adopted was brought in at this juncture.

**SOCIAL EVENING AT NORTH RIVER**

Very pleasant and sociable evening was spent at the home of Mr. and Mrs. Ernest Warren on Thursday, January 19th, when about 30 of the North River young people gathered for their weekly meeting. The President, Mrs. Harry Scott, presided. Mrs. Lester Younker, happily acted as organist for the evening. An excellent program was carried out, under the direction of the group leader, Miss Helen Warren. Following are the items: Reading, from the Young Peoples' lesson, "How May We Know God's Will," by Fred Jewell, Gordon Jewell, Besse Younker, Mrs. Lester Younker, and Leone Dockendorff. Readings were said by Beth Ladner, Haldane Scott and Mrs. Harry Scott. A poem "Original," was then given by Wallace Moreside. Wallie as he is familiarly known, has great talent as a composer.

One item on the program is well worthy of mention, this being a drill, in which 12 of our enthusiastic young men took part, entitled, "Why am I dry." This was certainly enjoyed by everyone present. Last, but not least was a reading on Temperance, by Brenton Stevenson. The meeting closed by singing "Blest Be the Tie." Two contests were put on by Miss Muriel Warren, which made great enjoyment for all. An excellent lunch was served by the hostess and the remainder of the evening spent in social conversation.

**It was arranged by the United Baptist, Continuing Presbyterian and Christian Churches to have prayer services on the evenings of January 10th, 12th, and 13th.**

The Ministers in charge of these churches are Reverends, T. B. Goudge, Pyke, Allister Murray and Armstrong. The first meeting was held on the evening of the 10th, in the United Church, Mr. Goudge conducting. Hymns were chosen from the Caradian Hymnal, and the old favorite "Life is Like a Mountain Railroad," was sweetly sung by Miss Bertha Chapman. Beautiful prayers were offered by Messrs. Goudge, Pyke and Harris. A talk specially suited for the children was given by Mr. Goudge. Mr. Louis Harris was asked to give the address of the evening. His talk was based on the first part of the third chapter of acts. On Wednesday evening the service was held in the Baptist Church, with Mr. Pyke in charge. Hearty singing by choir and congregation was entered into. Mrs. Myrtle Dunn sang one of the favorite solos. After the scripture had been read and a period of devotion, Mr. Goudge was asked to address the gathering. His talk was inspired by the beautiful words of the 17th chapter of St. John's gospel which had been read by Mr. Louis Harris. On Thursday evening at 8 o'clock the prayer service was again held in the Baptist Church. (Thursday evening is the weekly meeting of the Sons of Temperance, Division No. 281, and about 60 of the members attended the service wearing regalia.) Mr. James Brooks invited Mr. Louis Harris to be the speaker of the evening. With a good deal of zest of spirit, Mr. Harris entered into a stirring talk based on the second chapter of The First Epistle General of Peter, which had already been read. Also the general attendance was not as large as it otherwise would have been, because of bad roads.

On the evening of January 14th, in the public hall at Murray Harbor, the Luther Orange Lodge sponsored a splendid entertainment, in the form of a three act play, "Go Slow, Mary". The hall was filled to the doors, and the play moved swiftly from start to finish. Between acts, there was a sale of candy. A boxing bout between black Sambo and his twin brother. Step dancing by three young people, and another boxing match were told, between Mut and Jef. Instrumental music was also a part of the evening's entertainment.—P.

**Previous Recommendation**

At a recent meeting of fishermen it had been recommended that only one lobster fishing license be granted to each lobster fisherman in each year, said license to be good for one fishing season only, and to allow the holder thereof to take lobsters only in the waters of the locality where said licensed fishermen resided; that a number corresponding with the license number be placed on both sides of the bow of each boat; that measures be taken to prevent the transfer of equipment from one territory to another; that a more efficient patrol service be instituted.

**Spawn Lobsters**

Mr. John Darrach remarked that prices were lower last year than they were for 35 years. When one fisherman ran a line the other men dumped traps on both sides. These men made no discrimination in the kind of lobsters they took. They took in spawn and spawn lobsters, and had a special day for cleaning them up.

Mr. Herbert Gillis, Flat River, thought that his part of the country was not as badly affected as were the people at St. Peter's Island. He believed that the fishermen should be protected from outlaws, as local men had protected the industry for years.

Mr. Riley, Belle River, stated that a man from Pictou had bought property at Belle River, and intended to operate from there this season.

Mr. Daniel Taylor stated that a letter written by this man indicated that the latter intended to fish lobsters this year as far east as Georgetown, and indicated that he never had come second best in any warfare with fishermen yet.

Major D. H. Sutherland regretted that he did not know as much about the situation a year ago as he did at the present time. Regarding the illegal fishing in the Fall, Major Sutherland stated that when the matter was first brought to the attention of authorities, preventative forces were taken by surprise. However, some good work had been done, as 1,200 traps had been taken from St. Peter's Island. Everything possible would be done to stamp out the practice of illegal fishing, Major Sutherland stated.

The other problem, that of the migration of outside fishermen was more difficult. Migration of local fishermen had always been practised in local districts. A meeting in Summerside had recommended the limiting of a fisherman's activities to his own district. However, a goodly number of fishermen had made provision for two seasons' work, and therefore the regulations would not be fair to these men. The difficulty in enforcing the regulation would also be very great, as fishermen could evade the law, by taking out licenses under different names. Following the meeting at Summerside, no action was taken with the result that 516 fishermen from the north side went to the south side to fish. They lost money, however.

**Patrolling Necessary**

Mr. J. H. Myers made reference to the necessity of patrol boats in enforcing the law, if a line were drawn to allot waters to each province. A great amount of patrol work would be required. A number of years ago through the effort and honesty of the south shore fishermen they had built up a good industry, which deserved every protection.

Mr. W. Chester S. McLure suggested the appointment of a committee to carry on the work of leadership and guidance locally.

A committee, composed of Messrs. L. E. MacKinnon, Reuben Betts, and Daniel Taylor were appointed.

A vote of thanks was tendered Mr. Sutherland, who in replying, stated that the department would attempt to do the greatest good for the greatest number.
