RETURNS WITH HANDSOME CUPS FROM MONTREAL

Mr. Gavin Reid "Brings Home The Bacon" From Ayrshire Association Meeting.

With two magnificent silver cups in his suitcase— trophies of his success in competition with all Canada, as an Ayrshire dairy farmer—Mr. Gavin D. Reid, Montague, yesterday returned from Montreal, where he received the awards at the annual meeting of the Ayrshire Breeders' Association in connection with the Royal Agricultural Society of Canada.

The cups presented to Mr. Reid were for the largest mature honor record, 1934, of 14,755 lbs. milk, 608 lbs. butter fat (score 13,555) and for the largest record in the honor roll division for two milkings per day, made by Sunny Slope Bonny Jean. This cow was the three year old winner in 1928. Her daughter Winswept, which led the four year old honor class in 1932 and the twice-a-day milking cup in the 1933 honor roll division, scored reserve points in the contests for the two cups awarded this year to Sunny Slope.

Mr. Reid was the only Island cup winner in the Ayrshire R. O. P. tests. The only other Maritime trophy winner was Mrs. Mary Hooper, P. E. I., who won a cup in the mature class, 365 days division.

Mr. Reid naturally prides himself on the possession of his fine Ayrshire herd, of some twenty head. Including two years old cattle, the herd averages 12,000 lbs. of milk and 500 lbs. butter fat. This high average has been obtained by painstaking breeding over a period of nine years.

Finds Dairying Pays

Mr. Reid has never regretted his decision to concentrate on dairy farming. A few years ago the temptation was strong to drop dairying for extensive seed potato production, but he persevered, and feels today that his judgment has been amply justified. "The point is," he said to a Guardian representative, "you don't have the ups and downs in dairy farming that you have in potato production. For that reason you don't feel a depression in the dairy farmer today, in spite of hard times, it is usually able to make ends meet. That has been my experience during the worst years for the industry. If we don't make fortunes overnight, we are at least able to get on going on the rocks. I am more convinced than ever that mixed farming, with a good purebred dairy herd, is the best policy for the agriculturists of this Province."

DECREASE IN PROVINCIAL FIRE LOSSES

A decrease of \$93,160 in property loss by fire in Prince Edward Island last year over the preceding year is reported from the office of the Provincial Fire Marshal, Mr. C. H. Beer. The comparison is made subject to slight correction with regard to the 1934 figures. The returns available show a property loss last year of \$187,961, as against \$281,121 in 1933.

But while the provincial fire loss was considerably reduced, property damage by fire last year in Charlottetown was \$38,321, almost three times greater than in 1933, the loss that year being \$13,200.

The total fires in the Province last year was 240, and as against 252 in 1933. There were 49 fires in Charlottetown last year, and 64 in 1933.

INTEREST IN BOAT BUILDING IS REVIVED

Library Books On Subject Are In Demand.

Prince Edward Islanders may have forgotten how to build ships, but they are fast regaining the knowledge, according to Miss Nora Bateson, director of the Carnegie Library Demonstration scheme which has placed libraries in every large community on the island.

"I find an unusual desire for books dealing with boat-building, particularly amongst fishermen along the North shore," Miss Bateson said. Years ago shipyards on Prince Edward Island turned out large square riggers that sailed the seven seas along with the famous Blue-nose barks and brigantines. But with the coming of steam, Islanders turned back to the soil and confined themselves to coastal fishing.

But Islanders still have their sea-love, and with the coming of the Carnegie libraries they have taken to reading of articles on the manufacturing of speedy craft. Along the shores these days coastal villagers are making use of their spare time, designing and building sailing vessels and motor launches.

In Charlottetown Malcolm Irwin is one of the leaders in the boat-building movement. Back of his printing establishment other enthusiasts gather whenever they have an off day from their employment. And here the main topic of conversation is boats.

Nor does the little shipping club confine itself to talk. Last winter they turned out four craft, two 16-foot outboard motor launches, a yacht, the "PNO" completely modelled and a fishing punt of their own invention which can be readily transported on an automobile.

Jack King is owner and skipper of the "PNO", an 18-footer with leg o' mutton sail and jib. In summer he takes it to Montague where he matches his skill with the Montague sailors.

Right now Mr. Irwin is busy remodeling his famous "Mac Wes", a speedy craft built of cedar.

"It got its name because of its shape," the boat-builder laughingly explained.

wann, and the development of the innocence of this defendant."

Names Fisch

Mrs. Bertha Hoff, a little woman in a brown hat and a black dress, testified a New Jersey farmer named Budreau and Isador Fisch had come to her home in Bayside, Long Island, late in 1933 with "bundles".

State objections choked off her testimony and brought Reilly's exposition of the case, opening the way for Heier's testimony.

Heier swore in the courtroom that he saw in a parked automobile a hundred feet or so from where Colonel Charles A. Lindbergh was waiting outside St. Raymond's Cemetery, on the night of April 2, 1932, and saw Fisch jump from the cemetery wall. His testimony made it appear likely the state would call Col. Lindbergh as a rebuttal witness to refute the story a car was parked outside the cemetery on the night Dr. Condon passed the \$50,000 ransom to a man the state contends was Hauptmann himself.

The witness, 24, self-possession, describing himself as a writer, now working as a cashier, said he sat in his automobile near the gate of St. Raymond's for two hours with a girl, who married a short time later and died soon afterwards. He told his story in a straight forward manner, but in cross-examination by Attorney General David T. Wilentz various inaccuracies cropped up as Heier strove to remember details of his physical surroundings.

He said the incident was called to mind in a letter from the girl after the news of the payment of the ransom was made public. Then he said he forgot it, and it was brought to mind again after Hauptmann's arrest when he saw a picture of Fisch in the paper. Fisch is the man, Hauptmann says, who left in his keeping a shoebox which he inspected last August, to discover it contained nearly \$15,000 of the Lindbergh ransom money.

Vague In Answers

Heier was vague in many of his answers to Wilentz's rigorous examination. He hesitated about revealing the name of the girl. He admitted to a conviction on a charge which was not brought out in examination.

Lindbergh spent his 26th day in court, listening to the testimony with no greater show of emotion than he has evinced since the beginning.

Heier refused to disclose the name of the girl he was with until Wilentz appealed to Justice.

Corroborated Hauptmann's Story

Mrs. Mueller also corroborated Hauptmann's own story that he was at home on the night of Nov. 26, 1933 when, the state contends, he passed a ransom bill at the Greenwich Village theatre. The state also produced a witness to testify that the memory of Mrs. Cecile Barr, cashier at the theatre, was faulty—she was the woman who identified Hauptmann as the ransom bill passer—but he was not permitted to answer defence counsel's questions.

Seeking further to implicate Fisch in the snatching of the ransom, Mrs. Bertha Hoff, a housewife in Brooklyn who formerly had lived in Bayside, Long Island, Mrs. Hoff's story was that late in 1933, she was visited by the New Jersey farmer, Bureau and Isador Fisch, whom she had not known previously.

Did Isador Fisch have any bundles with him? Mrs. Hoff answered "Yes he did."

Mrs. Hoff's statement brought a quick denial from Alfred Budreau of Yonkers, N. Y., who said he knew a Mrs. Bertha Hoff and that he had seen her at a farm at Mountaineer, N. Y., 20 miles from Mountaineer, N. Y. Budreau said he did not know Fisch and had never visited Mrs. Hoff in Fisch's company.

The reputation and character of Dr. John F. Condon were defended by John E. Seykora, department of justice inspector, after the defence had asked him the questions "Did you ever hear of any examination of Dr. Condon by alienists? Didn't you investigate thoroughly a man who popped up, took \$50,000 and passed it over a wall or a bush to a mysterious man when nobody saw him? Did your investigation disclose that Dr. Condon was an eccentric and was known to have masqueraded about the Bronx in women's clothing? Did it disclose that he was transferred for a reason at a school downtown?"

Seykora met the questions with answers defensive of Dr. Condon.

More friends of the Hauptmann family went to the stand in an attempt to strengthen stories he could not have been the man who passed a ransom note at the Greenwich theatre, almost 15 miles from his home, the night of Nov. 26, 1933, Hauptmann's birthday.

They said they attended a birthday party at the Hauptmanns and that Hauptmann did not leave his home before 10 p. m.

The witnesses testified Hauptmann was "respectable" and kind to his family. The state obtained the exclusion of the comment about respectability over defence objections.

Victor Schussler, a tenant in the same house occupied by the Hauptmanns, testified he missed several carpenter tools after Hauptmann's arrest but added that neither the chief nor the plane which are the state exhibits were his.

His statement came as the government mustered its every police force to restrain leftists and rightists, communists and royalists, war veterans and kinemen of the 1934 victims who had scheduled parades, mass meetings and demonstrations to mark the day.

Doumergue, who was recalled from political inactivity to head the government that took command last spring when disorders growing out of the Stavisky scandals were toppling one French government after another, recalled that France "narrowly escaped last Feb. 6."

"Civil war then," he asserted, "would have meant foreign war almost immediately. Civil war tomorrow would mean foreign war almost immediately, and even more certainly than last February."

"That is something that must be said," he concluded.

Appeals To Patriotism

The Flaudin Cabinet, which rode into power on the political strife provoked by Doumergue's advocacy of constitutional reform, met today, appealed to French patriotism to help maintain the "political truce" and issued stern orders against open-air manifestations tomorrow.

Announcing memorial services in churches, alone would be allowed, the cabinet—though keeping details of its plan of campaign secret—made ready to use soldiers of the Paris garrison, 14,000 policemen and 20,000 Mobile Guards to restrain political "troops" of the right and left.

Families of the 19 persons slain outright in the Place De La Concorde rioting were told they might not march to the riot scene and scatter flowers there. Nationalist organizations received similar instructions, with their Fascist foemen, were warned against creating disorders.

There were ominous indications, however, that trouble might be brewing for the morrow.

HERRIDGE IN OTTAWA

Visit Linked With U.S. Proposal Re Trade Agreement.

(CP. By Guardian's Special Wire) OTTAWA, Feb. 5.—Hon. W. D. Herridge, Canadian Minister to Washington, was in Ottawa today conferring with Prime Minister R. B. Bennett and officials of the Department of External Affairs.

The visit had no special significance, the Minister said, and he had no comment to offer on the proposal of the United States to negotiate a trade agreement with Canada, as recently announced in Washington.

Parliament will unlikely have any United States trade agreement legislation until late in March or April, in view of the hearings that must take place in Washington in March for presentation of the views of United States interests which will be affected by any reciprocal agreement.

In a recent speech in Toronto Mr. Bennett referred to the long and careful negotiations which would follow formal opening of discussions between the two countries, when items in the tariff schedule will be considered individually.

Canadian trade officials have been in practical readiness to negotiate with the United States for a long time and final details of the basis upon which the Dominion will enter into formal discussions will be applied in plenty of time when the Washington hearings have been completed, it was stated today.

Ontario Dealers Must Toe The Mark Says Potato Agent

Price Pegging Regulations Will Be Strictly Enforced, Says Mr. J. T. Cassin, Ontario Agent For The Potato Marketing Board.

Assurance that potato marketing in Ontario, as in the Maritime Provinces, will be governed strictly in accord with the provisions of the Ontario Potato Marketing Act, is given in the following article from the Toronto Star (Liberal) of Feb. 2.—

Ontario citizens on Monday will pay 10 cents more for a 90-pound bag of New Brunswick and Prince Edward Island potatoes and 20 cents more for Ontario potatoes as a result of the wide licensing and price fixing powers given by the Eastern Canada Potato Marketing Board by the federal National Products Marketing Act.

J. T. Cassin, Ontario manager of the Potato Marketing Board, told The Star today that the board had the absolute power to decide who should sell potatoes and at what price.

"There is no appeal from our decision," he declared. "We have the authority of granting licenses to potato dealers and can also do it their way. A dealer is really appointed as our representative and as long as he obeys orders there is no likely to be any trouble, but if he sells potatoes below the scale and will lose his license. Of course, his suspension may not be permanent."

CHICAGO, Feb. 5.—Mr. and Mrs. Olivia Dionne, parents of the famous quintuplets, embarked on a theatrical career today.

Max Halperin, vaudeville booking agent who brought the Canadian couple to Chicago, announced they had signed a contract to appear in Detroit and Michigan theatres on Feb. 14 and 15. He also said they had signed an agreement for a week's engagement at a Chicago movie house beginning next Friday and were considering extending their tour to Cleveland. They will be "guests" of the theatres and will limit their activities to personal appearance with no acting or speeches required.

The chance to realize some monetary reward for their renowned quintuplets from the Ontario north country by their immediate attention was devoted to the fascinating sights of the first city they have visited in the United States.

They thrilled to the first glimpse of the Metropolitan scene, posed for sound and still photographers and entertained a small army of reporters. ADDRESS POSTPONED

OTTAWA, Feb. 5.—Prime Minister R. B. Bennett's address before the Graduate Society of McGill University which was to have been delivered in Montreal Thursday next, has been postponed until Mar. 9, it was announced here tonight. Pressure of Parliamentary duties will prevent Mr. Bennett keeping the engagement as originally made and the new date was communicated to him late today.

But even if a retailer deals only with the farmers who come to him, he is not exempt from Mr. Cassin's jurisdiction. "If we find that a retailer is paying a farmer less than the agreed price, we can step in and prevent him from dealing in potatoes altogether," he declared. "We have absolute power to say who shall handle potatoes in the province."

Mr. Cassin pointed out that wholesale departments of chain stores would have to obtain dealer's permits.

The Ontario agency of the Eastern Canada potato marketing board now has a staff of only two employees. In addition to Mr. Cassin, but with the inauguration of the new marketing plan next Monday, this will likely be increased since considerable inspection and book-keeping will be involved. But Mr. Cassin anticipated little difficulty in the operation of the scheme, since there are relatively few potato "dealers."

The scale of wholesale prices, which goes into effect on Monday, stipulates that P. E. I. potatoes shall sell for 75 cents, New Brunswick for 70 cents and Ontario for 50 cents. The spread between Ontario and maritime potatoes was formerly 35 cents, but in view of the improved quality of the local market, farmers and dealers have decided it would be only fair to reduce this spread to 25 cents. Thus the price of Ontario potatoes has been raised 20 cents on a 90-pound bag, the increase on Maritime potatoes being only 10 cents.

Retail prices are estimated to run 5 to 10 cents above the wholesale scale.

Mr. Cassin explained that dealers would pay a nominal fee of \$1 a year. To provide the eastern Canada potato marketing board with adequate funds to carry on its activities on behalf of producers, a tax of one half cent a bushel will be imposed.

Two days after each sale, every licensed dealer will be required to forward to Mr. Cassin a complete statement of the transaction, giving the name of the vendor, the price and the quantity sold. In addition potatoes will be subjected to rigid inspection by officials of the federal fruit branch to see that only No. 1 (large) and fancy grades are sold in Ontario cities according to the potato board's ruling.

Check-up on Dealers

For this inspection there will be a fee amounting to \$1 on a truck load of 100 bags, and \$3 on a cartload of 400 90-pound bags. Certificates of inspection will be made in triplicate, one to the dealer, one retained by the inspector, and one sent to the fruit branch of the department of agriculture. Ottawa. Reports of these inspections will be forwarded to the potato marketing board, giving an added check on dealers who might neglect to file a statement of their dealings.

On the first and 15th days of every month "primary dealers," those who first purchase the potatoes from the producers, must send a report to the board on the number of bushels handled in the preceding half-month period. This "primary dealer" must pay the half-cent toll, but it is expected, he will attempt to pass this on in subsequent transactions.

No Fee For Detailers

"Detailers" requiring licenses from the board are only those buying potatoes for resale, such as wholesalers and brokers, and the term does not apply to retailers who buy for sale direct to the consumer. But Mr. Cassin explained, any retailer would be considered as a "dealer" and required to have a license if he went out into the country and purchased from farmers instead of waiting for them to come to him.
