In Ottawa

(C. P. By Guardian's Special Wire) OTTAWA, March 5.—A total of 785 appeals awaited consideration by the Pensions Appeal Court at the end of 1935, according to information tabled in the House of Commons today by Hon. C. G. Foweraker, Minister of Pensions and National Health. Of this number, 27 were appeals of the Crown from the pensions commission, 651 were appeals of applicants from the same body, and 111 were in "other categories."

The return showed 36 appeals were allowed by the court in 1935, while 1,693 were disallowed. Of the 1,693 disallowed, 14 were appeals by the Crown from the commission, 1,320 were appeals of applicants, and 259 were in "other categories."

A sub-committee of the House of Commons committee on appeals was appointed today to go over the complimentary list of Hansard with a view to deciding if it can be shortened. This committee, J. F. Pouliot, Liberal member for Temiscouata and chairman of the debates committee, E. R. E. Chevrier, Liberal member for St. John's, and W. K. Edging, Conservative, Kootenay West, will report in the near future.

Information before the committee today was that 7,200 copies of Hansard in English and between 600 and 700 copies in French are printed daily. More than 600 copies are supplied free to Hon. G. G. Campbell, members of the committee. The suggestion was made newspapers should be circulated by card to ascertain if they required it.

Criticism developed when the complimentary list was read by chairman Pouliot, and it was suggested some names be struck off. This matter was, however, left to the sub-committee.

A delegation representative of the all-Canadian Congress of Labor today urged on Ernest Lacombe, Minister of Justice, an amendment to the Criminal Code which would render illegal the picketing of a place of business in which there was no lockout or labor dispute.

Mr. Lapointe took under consideration a draft movement to the code, prepared on behalf of the committee of the Congress and promised to take it before his colleagues in the government.

Representatives of the sugar beet industry in Canada, which supplies 88 per cent of the Dominion's sugar requirements, today left with Finance Minister Dunning a request for such tax and tariff considerations the government may consider feasible.

Paul Martin, (Lib. Essex East), presented a summary of a brief he had prepared on behalf of the industry, disclosing the history and potentialities of sugar beet farming in Canada.

The meeting with Mr. Dunning was in private and the exact nature of requests made on behalf of the industry was not made public.

The sum of \$210,816, was spent on fish cultural work in Canada during the fiscal year 1934-35, according to information given in the House of Commons today. In answer to a question by A. W. Neill (Ind. Comox-Albert), the Minister of Fisheries stated that this total had been spent in the province of British Columbia.

Haig Revised 1918 Message

(By The Canadian Press) LONDON, March 5.—Haig's famous message to the Army in the critical days of March, 1918. "Our back to the wall, each one of us must fight to the end," was issued without the final sentence which Earl Haig wrote in the original draft.

The last sentence would have been, "be of good cheer, the British Empire must win in the end."

This was revealed by a former war chaplain, Rev. Alexander Campsie, M.C., at a Haig Memorial Service at St. Columba's, Port Street. Mr. Campsie said he had seen a facsimile of the message. It might be that Haig considered the last sentence, which would inevitably become known all along the fighting front, might tend to alienate the sympathy of the allies who were not particularly interested in the triumph of the British Empire.

But, from what was known of the character of Earl Haig, added Mr. Campsie, he thought it was possible to discern in his act a far deeper meaning. Personally, he was convinced that with unerring instinct the Field-Marshal cancelled that final sentence because it savored of "such boastings as the Gentiles used," from which Kipling proved that the nation might be saved.

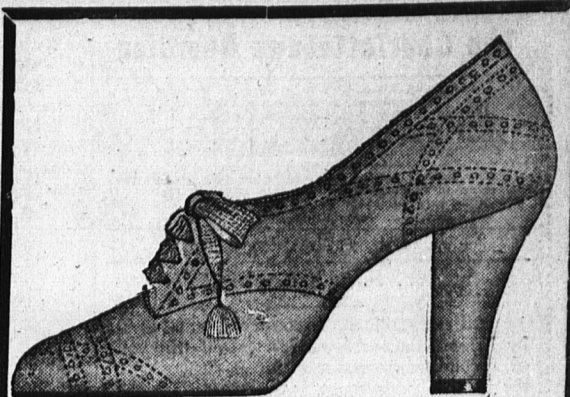

"I saw her picture recently in a London studio theatre, six weeks old, carried on her mother's arm at a tribal ceremony," writes a film correspondent of the London Observer.

"Picture Cinema's mother was simply dressed in the narrow girdle with the grass tail that indicates honorable motherhood.

"Nearby, inside the square of spectators, a bunch of young girls, wearing the tulle girdles of childhood, were dancing a girl-choosing dance with two masked witch doctors. The warriors of the tribe, fantastically painted with the semblance of European clothes—half a white waistcoat here, a checked golf stocking there—beat out the rhythm with drum and foot, and sang their tireless responses.

"That was the beginning of the oddest and most fascinating hour I have ever spent in a picture theatre. I had asked Zoltan Korda to tell me about the raw material which he brought back from Africa as a basis for 'Sanders of the River,' only a small proportion of which could be used in the film itself. He did better than talk—he showed it to me—thousands of feet of short ends of film, broken lengths of sound-track without pictures.

"There were war-dances from the Congo, songs of rejoicing from the Acholis—girls and warriors, voices in a perfect counterpoint, that combines the effect of the old
