Cable messages sent by the Panamanian Government to Washington with a view to ascertaining the United States Government's attitude toward Panamanian resistance to Costa Rican occupation of Coto have not been replied to. Armed men to the number of 150 have been ordered to proceed to Coto from David. They will take with them ten machine guns which were purchased in the United States last April. Secretary of Government and Justice Alfaro has given orders to Chief of Police Arango to hold the entire police force of Panama and Colon in readiness to march to Coto. Identical orders have been sent to heads of the police forces in interior towns. Mayors have been ordered to revise their volunteer lists, and to advise these men to be ready for an emergency.

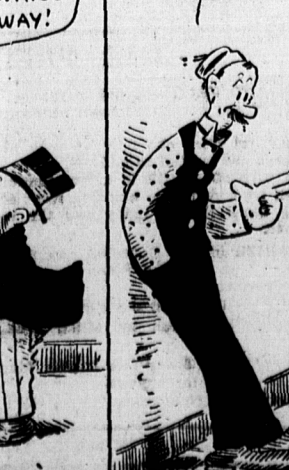
