BOSTON & MAINE MAKE CHANGES

BOSTON, Aug. 23.—After nearly half a century of continuous service, D. W. Sanborn, general superintendent of the Boston & Maine Railroad, will on Sept. 1 retire from the service of the road.

Charles E. Lee, assistant general manager will be promoted to succeed Mr. Sanborn and the office of assistant general manager will be abolished.

Other changes to go into effect on the same date include the promotion of Dana J. Flanders, general passenger agent, to general traffic manager, and the return to the road of C. M. Bart, formerly assistant general passenger agent, as general passenger agent.

The retirement of Mr. Sanborn removes from active service one of the last, if not the last, of the oldtime New England railroad officials.

UNITED STATES MAY INTERVENE

HAVANA, Aug. 23.—It is believed by many Havana business men that it will be necessary for the United States to intervene in the Cuban revolution.

The revolution will be crushed. Annexation is openly favored by the commercial interests in all of the larger cities and towns in Cuba. The revolutionary leaders even prefer annexation to the United States to a continuance of the present administration.

The American residents on the island of Pines have taken sides with the revolutionists against the Palma Government, and they are giving the insurgents all the aid possible. The island of Pines will be an important base of operation for the revolutionists.

JOHN, August 24.—In Queen's Rink last night Victoria and Cygnus Companies of the Uniformed Rank, Knights of Pythias, held a joint drill in preparation for the special turnouts next week when the Grand Lodge of the Maritime Provinces holds its annual session in Castle Hall, Germain street, and Supreme Chancellor Chas. Shiveley of Indiana visits the brethren and there is every prospect of a very enthusiastic and enjoyable two days commencing on the 28th.

A generous sum will be expended in entertaining delegates to the Grand Lodge. The program includes a grand ensemble of local and visiting Uniformed Knights on Tuesday. This will take place on King street east, where Commandant-in-Chief Shiveley will formally inspect the fraternal soldiers.

New Methodist Church in Amherst to Cost \$60,000—C. B. Chappell, Architect

AMHERST, Aug. 22.—The very impressive ceremony of laying the corner stone of the Methodist church in this town was witnessed this evening by a very large audience.

Rev. Dr. Heartz, president of the Nova Scotia conference, laid the stone. After the ceremony an interesting service was held at the Winter Fair building.

Among those taking part were Rev. Dr. Street, Rev. Dr. Heath, Rev. J. S. Coffin, Rev. C. N. Weldon, Rev. Dr. Andrews, Dr. Allison and others. When completed the church will cost upwards of \$60,000 and will be one of the finest in the Maritime Provinces.

It will be a very large and handsome structure, of chaste design without undue ornamentation, and admirably adapted for the increasing activities of this enterprising congregation which has had the guidance of a long list of earnest and in many cases very talented pastors, closing with the present minister, Rev. Wilfrid Gaetz. The architect is C. B. Chappell, of Charlottetown.

The incident occurred on Monday and a piece of woods about ten rods square including a number of piles of pulp wood were burned.

BOSTON GETS A GOOD SCORCHING

BOSTON, Aug. 23.—The sixth consecutive day of excessive heat and humidity in this city is charged with having caused one death, prostrated more than a score of people, and brought decided discomfort to everybody.

Albert E. Tisdale of South Framingham, fell dead on the gang plank of the steamer City of Bangor at Foster's wharf. The cause of death was given as heart failure superinduced by heat. The busy streets of the city and crowded tenement house districts suffered the most. In the former many people were exhausted and a score were treated at the hospitals while perhaps as many more were taken to their homes.

THE ACCIDENT TO THE DOMINION

QUEBEC, Aug. 23.—The Quebec Telegraph says of the grounding of the battleship Dominion: The accident is a serious mishap for the officers in charge of the rules of the British Navy, will have to submit to a court-martial, but, there are extenuating circumstances connected with the accident. It is said that the chart was at fault and lights deceptive, which, if proved, would exonerate the Dominion's officers from all blame.

As already announced, bush fires raged in the charge of the vessel. The battleship is still making water but the ship's pumps are able to keep it under control. It is said the leakage is sixty thousand gallons per hour.

CHINESE PIRATES CAUGHT TARTAR

HONG KONG, Aug. 23.—A plan to hold up the British steamer Nanning, which trades between Canton and Wuchow, has been frustrated. A gang of disguised pirates boarded the steamer at Canton and were reinforced in numbers at the way ports. The greatest of their number aroused suspicion and a careful watch was maintained. At the first sign of restlessness the captain threatened to shoot. This prompt action led to the arrest of three of the ringleaders who were delivered to the British Consul at Wuchow.

CLEVER HOAX ON MAGISTRATE

LONDON, Aug. 23.—An ingenious trick which the police and magistrates were the victims was revealed at Warrington police court.

EARTHQUAKE IS NOT YET ENDED

Two More Shocks Reported Yesterday—The Chilean Senate Vote Four Millions Dollars for Relief of Sufferers—Rain Adds to Misery of the Homeless People.

SANTIAGO, Chile, August 24.—(Special)—The Chilean senate today voted four millions for the relief of the earthquake sufferers.

Over three hundred thieves have been shot last in the few days. Another severe earthquake shock has just occurred here. There were two slight earthquakes shocks here last night.

Rain began falling, increasing the sufferings of the thousands who are living in tents. Many of those sought refuge from the rain in houses whose walls are in a dangerous state of ruin.

It is believed that if the rain continues much longer a serious epidemic is sure to break out.
