Japan is committed to Germany and Italy--both at war with Russia--to help them against any attacks by a new belligerent but, while the Government said Wednesday it had decided on a policy toward the Russian-Axis war, Ishii would not say today what that policy is. Asked if it meant continued Japanese neutrality, he answered only: "My mouth is sealed."

Ishii said, however, that the Japanese might send a message to Russian Ambassador Constantin Smetanin by Foreign Minister Yosuke Matsuoka. They conferred Wednesday. On Thursday it was disclosed that 100 women, children, members of Russian embassy families, were preparing for hasty departure homeward.

Newspaper discussion, indicating the Japanese might attempt to close routes to Vladivostok, has centred on Soya Strait, between Hokkaido and Sakhalin, only 25 miles wide, and the still narrower Tsugaru Strait, between Hokkaido and Honshu, the main Japanese islands. "There remain routes into the Sea of Japan through its southern mouth, the Chosen and Tushima Straits," said a Japanese official. "The Japanese mainland, and the Russian-controlled passage through the Sea of Okhotsk around the northern tip of Sakhalin, long Japanese-Russian islands off the Siberian coast. However the northern passage, besides being more than 2,000 miles out of the way, is difficult to traverse. The Japanese might declare her territorial waters extended far enough to cover all passages into the Sea of Japan except the northernmost route."

MET DEATH

(Continued from page 1) MacLeod, Elmer Perry, Const. F. C. Bradley and Capt. Jeremiah Doucette.

The text of the verdict was as follows: July 2 "We, the jury have come to the conclusion that the body of the unknown man who came to his death by drowning sometime recently. "We visited the scene where the body was found and have come to the conclusion that the body was washed ashore within the last day or two.

"Owing to the decomposed state of the head, we are not in a position for identification, neither were we able to see any signs of violence. There were no footprints of any individuals between where the body was lying and the water, neither was there any clear evidence of the body being dragged ashore by any person. The only supposed mark in the grass might have been caused by one of the feet partially dragged along as it reached the water. There being no shoes on the individual, we are unable to make less impression on the grass. This is the conclusion arrived at after seeing the body and visiting the scene where it was found. In answer to an inquest, we the jury have arrived at the conclusion that the body in question according to evidence presented by the witnesses, was that of Austin Doucette, signed W. A. Gaudet, foreman.

Other members of the jury were: G. H. Keefe, F. H. McArthur, H. Watway, W. Robertson, Harry Craig, D. Rockwell.

Jack Gay, the first witness called testified that he was 12 years of age when he was in the vicinity. He told of going out to Marshfield Wednesday morning to attend the Trail Ramee camp, which was opening that day and two other boys were walking along the shore, near the camp, when they noticed a piece of cloth sticking up in the marsh about the length of a car axle. They saw that it was a body and, a little scared, ran back to camp, and told (Rev.) Mr. Levy. A couple of men were there when they investigated. Windsor Brehaut, 13, and Warren Robinson, 13, both of Charlottetown had accompanied Gay on the walk. They corroborated the evidence given by the latter.

Rev. A. MacLeod testified that when the boys first came up it was thought they had made a mistake. However, when they insisted it was a body they had seen, Mr. Levy told witness and Mr. Perry to go down. They went down to McBeth's liquor in the grass. They saw that the man was dead. The body was clothed in pants, shirt, braces, and

Condition of Iona resident

Still serious

Mr. Francis Connolly, Iona farmer, who was seriously injured when he was drawn vehicle was in collision with a car on the early hours of Wednesday morning, is still unconscious in the Kings County Hospital, Montague, at a late hour last night. He has failed to recover consciousness since the accident occurred.

It is understood Connolly was returning home after attending a dance when a car crashed into the rear of his wagon. The accident happened at Grand View as both vehicles were going in the direction of Iona.

The accident victim is married and has several children. It is believed he suffered a fractured skull in the accident.

The wagon was almost demolished in the collision while the car was badly damaged.

Witness telephoned to the Mounties. He told the Coroner that there were marks as though the body had been dragged in well past the body where the body was found and it would gradually work the body in. He has no doubt it was deposited there by the water.

Elmer Perry, Sussex, N. B. leader of the boys' camp, corroborated the evidence of the previous witness. Constable J. Gliche, M. P. testified that he had received a phone call saying there was a dead body on the shore at Marshfield. This was about 12:30. Accompanying by Coroner, Dr. I. J. Yeo, he went to McBeth's Shore and saw the body lying on the shore about 30 yards in from the water. It was face down with the head away from the water. He described the clothing and the marks that were in the body had dragged as though no footprints, he added.

Captain Jeremiah Doucette told of identifying the body by the clothing. He was sure of the clothing. The body was that of his son, Austin Doucette who had been missing for 10 days. On the morning of June 1st, he was seen at Marshfield. He had been in bed and got up and said he was going out to try to walk this off. He had his hat on when he was seen at Marshfield. The boy was very nervous ever since he had gone to enlist and was turned down. This was the last day of January of the first of February. He was physically fit and witness said his son then began to worry and he had taken him to the hospital and received the news that he was not cleared up. But they could never make him believe he was all right. He had never done any work because when he looked for a job and, when asked, told what his father was doing, was always turned down. On Friday before he was seen at Marshfield, he was for again and was told to get some work which would help him to forget. The next day he went to Rustico and spent a week there. The following night he returned home.

When the boy left the house, at midnight Monday, witness got a brother to follow him. The latter did not see any sign of him. Witness said he must have gone to the wharf. When asked by the Coroner if he was in condition to take his life, witness said he was not. He thought so. Continuing he said the boy had lived in the water. For several years he had been in the water and witness warned him that he "would do that once too often." In his opinion, the deceased had some knowledge of the water. He did not think a cramp. He did not explain why he would go in with his clothes on unless it was his nerves.

ACQUIT PAIR

(Continued from page 1) had jurisdiction unless the committal had been set aside and went on to explain to the court his reasons for stating that the court did have jurisdiction.

C. St. Clair Trainor Mr. C. St. Clair Trainor addressed the jury in his opening remarks. Mr. Trainor stated that in his 17 years of experience he had never seen a lawyer this was the first conspiracy case he had known of to come before the court. It was very rare, Mr. Trainor said, in a conspiracy where two or more persons were heard making a conspiracy, and therefore it was difficult to find direct evidence. Continuing Counsel reviewed the evidence taken during the trial. He told the jury about the three dories coming alongside the boat and about the taking on board of boxes and kegs. Marc Moraze of St. Pierre had said in evidence that there were liquor bottles shipped both legally and illegally from St. Pierre and that when it was done illegally it was shipped at night by dories. "We find a strange coincidence here," Mr. Trainor said and was of the opinion that the jury would have no doubt in their minds that the conclusion that the cargo taken on board the boat that night was a cargo of liquor. He told the jury that both Steele and Lantierne, members of the ship had each stated where they were when the liquor before leaving the boat after the vessel had returned to the island, and further stated that the cargo of boxes and cases taken on board at St. Pierre was still on the boat when Lantierne and Steele had left it. What had become of it afterwards we do not know, Mr. Trainor added.

In conclusion Mr. Trainor told the jury that in reviewing the evidence in this case, he was of the opinion that if it must be very difficult for jury to understand why an unlawful agreement had been entered into then the verdict should be guilty as charged. But, he added, if there was any reasonable doubt, then both the accused should be discharged.

H. F. MacPhee K.C. Addressing the jury on behalf of the accused Mr. H. F. MacPhee stated in his opening remarks that this was a new kind of trial in the province and was the most peculiar case of conspiracy ever heard anywhere. The prosecution, Mr. MacPhee said had apologized for the sketchy evidence given and he was of the opinion that it must be very difficult for jury to understand why men should be brought into court to be tried. Why did the Crown pick the charge of conspiracy, Mr. MacPhee asked. If they smelted liquor in the grass, they tried for smuggling or illegal sale. And as co-accused for the accused Mr. MacPhee stated that he was

Touching upon the liquor given to Lantierne and Steele on leaving the boat, he stated that he had been quite natural that men, especially sea-faring men, should purchase a bottle of gin in St. Pierre to take with them. But he contended, he could not see how that could be taken as evidence of a conspiracy. Court here took recess until 2:30 p. m.

Continuing his address to the jury Mr. MacPhee pointed out that the jury had heard in his evidence that he had been on board a boat in St. Pierre which Griffin was going to purchase and stated that he had seen the boat being dumped water out of it and that in evidence given by Marc Moraze had told that he had been told to tell Griffin at a later date that his boat was now ready for use.

There was not one suggestion where there had been an unlawful transaction and in regard to Walsh there had been no evidence whatsoever connecting him (Walsh) with the agreement to take liquor. In his closing remarks Mr. MacPhee said that in order to connect Walsh with the case Crown would have to establish that cargo brought in was liquor; would have to establish that the cargo had entered into between Griffin and Walsh and some of the others and that Walsh had knowledge of such an agreement and that that knowledge would be used for an illegal purpose.
