## Gov't Measures Help Unemployed

LONDON, Oct. 21—Registration of all unemployed women was urged upon the Federal Government by the annual meeting of the Ontario Liberal Association here today. In addition, steps should be taken at once to provide work for women and young girls along the general lines of the scheme which established jobs for men, read the resolution which was sponsored by the Ottawa 20th century club.

With a varied agenda the first business session of the convention opened today. Among the resolutions passed was one deploring the policies of the Dominion Government which "destroyed trade, stagnated industry and brought increasing unemployment and distress to large numbers of our citizens." Another called upon Premier R. B. Bennett, "to implement his promises with respect to old age pensions by assuming the full cost" of the scheme. Still another referred to the growing practice of "watering stock, over-capitalization" the prevalence of "illegal financial reorganizations" among incorporated companies and called for remedial legislation from the Provincial Legislature.

Confidence was expressed in the leadership of Rt. Hon. MacKenzie King, Dominion chief, and Mitchell F. Hepburn, M. P., head of

the provincial forces. Coupled with this resolution was one which condemned the "excessive taxation with extravagance" of the Henry Government and praised Mr. Hepburn for bringing this situation to the attention of the people.

Representing 87 Ontario ridings, 459 delegates registered today with promises of others being present at the resumed business session tomorrow. In his presidential address, Senator Arthur C. Hardy of Brockville, forecast the introduction of a resolution which would call for a sweeping investigation of the Hydro Electric Commission of Ontario and its actions. It may come before the convention tomorrow, he intimated.

**FIGHT AGAINST CATTLE INSPECTION**  
BURLINGTON, I. A. Oct 22—Determined opposition to the state testing of cattle for tuberculosis which has been almost continuous since March last night broke out in a new section in Southeastern Iowa. The farm of Jake Everstman, just north of here became the camp ground of a group of men, women and children estimated to number between 500 and 1,000, who gathered avowedly to resist indefinitely further testing of cattle by state veterinarians.
