Hamlin its proprietor and E. F. Geers, the "Grand Old Man of the Turf," C. J. Hamlin was one of the top figures of the trotting turf in the early nineties and from his farm came some of the most beautiful and fastest performers of the day, for Hamlin believed in breeding beauty as well as speed.

Heir-at-Law was one of his stallions, claimed by another; Daisy Grattan was a product of Grattan Royal mated with an Heir-at-Law mare. Now getting back to Chimes, we find that he sired The Abbe 2.04 and The Abbe 2.04, full brothers, both champions on the Grand Circuit, the latter going through a campaign in the hands of E. F. Geers undefeated as a trotter and being switched to the pace undefeated as a pacer, if memory serves me correctly.

We stated above that Grattan Royal is probably one of the greatest sires of racing speed, but perhaps that statement can be challenged and if so it would be by the record which Abbedale has acquired in the past few seasons. Every day when you pick up the paper and look over summaries of fast pacing events you see an Abbedale as a winner or contender. For instance in the Frank P. Fox Stake for two-year-old pacers the contending horse was Silver Dale by Abbedale and the winner of third money was Widow Volo by Peter Volo out of Widow Grattan 2.00 by Grattan Royal, and the fourth horse was Heir-at-Grattan by Grattan-at-Law.

On the same day the 2.10 pace was won by Walter Dale by Abbedale and second money was won by Miss Abbedale.

A perusal of these interesting summaries convinces one of the supreme importance of good foundation blood. How proud C. J. Hamlin would have been to-day were he alive to see the results of his judgment and breeding skill so abundantly justified.

Other instances of the potency of the Hamlin strains is shown by the get of Guy Abbe, 2.04, who is a son of Guy Axworthy, 2.08, and Abbeby by The Abbe 2.04. This sire has the fastest three-year-old in America this season and the biggest money winner in Greyhound, 2.00 and the fastest pacer and biggest money winner in the world's record four-year-old mare Calumet Evelyn 2.00. It will be interesting to Islanders to know that Guy Abbe is out of the same dam as Calumet Brownie, 2.04, owned by the Lewis, North Sydney, N.S., who raced in the Free-for-All at Charlottetown Exhibition.

It is rather a belated acknowledgement on our part, but we are sure our friend Captain J. L. Read will know that it was not in vain when we were told the fact that his good sire Clover Guy 2.07 1/2 has not received as much publicity as he deserves for being the sire of the two-year-old race record holder of the Maritimes, Guy Ann 2.24 1/2.

When Captain Read acquired this horse we gave a write-up of him mentioning his wonderful racing career in which he won in 2.07 1/2 over a half-mile track and repeatedly headed summaries when in the lead in his superior breeding, good determination we predicted he would be a wonderful sire and now Guy Ann has come along to make good the prediction and there will be many others to follow, for the Captain's horse is destined to be presented by lots of excellent racing material.

Speed of sensational order was shown at the Springfield Grand Circuit meeting the same week as our Exhibition. For instance Greyhound shattered the world's record for three-year-old trotting geldings and lowered the track record for trotters when he won the second heat of the Illinois Review Futurity in 2.00. The same afternoon the practically green pacer Cardinal Prince paced three heats in 2.00, 1.59 1/2, 2.02 and Tara trotted the last half of a mile in 23 3/4 seconds, with the first half of her second heat in 59 1/2 seconds and the final quarter in 28 seconds—a 1.52 clip.

This date three years ago or the fall of 1932, the world was "ringing with the fame of Mc I. Win (3) 1.59 1/2, winner of the next two years and laid away with lameness and reappeared on the turf this season with his former driver Dr. H. M. Parrish. He has raced with varying success but did not approach his form of 1932 until the second heat in the 2.11 class at Springfield in 2.00 1/2 and was just beaten inches in the final in 2.01. A leg that still bothers him is the reason why he has not headed a lot of summaries.

The latest returns of race winning drivers issued by W. H. Gocher of the National Trotting Association, shows Will Bull leading with 30 Goodheart second with 24, Vic Fleming third with 23, Tommy Berry fourth with 22, Sep Palm fifth with 21 and Hump Morrison sixth with 20. Bull has picked up a lot of wins in the past ten days. It was from his stable that Frank Adams bought Abner T. Clegg 2.04 1/2.

Previously Mexico had added her voice to those standing by the Covenant in the Ethiopian crisis. "Mexico," said her representative, "condemns all violation of the Covenant."

So long as there remained the slightest chance of settling the dispute peacefully an attempt should be made to do so, he added. Collective security could not be maintained by provisions applicable to a single continent. He challenged the Italian position, and stood by the Covenant.

The committee of conciliation while retaining Ethiopian independence will be expected to go further over than the Anglo-French peace formula which Mussolini turned down at Paris. It will do its utmost in a last-hour effort to avert war. The issue will then lie squarely with Mussolini.

Paris Proposals The Paris proposals envisaged giving Italy the dominant share in economic and financial reorganization of Ethiopia, under League auspices and not infringing Ethiopian independence. They were previously rejected by the Italians as inadequate as they did not contain political concessions.

The committee was suggested last night but today Italy objected to the presence of Britain and France, as she was equally a signatory with the two others to the 1906 treaty defining influence in Ethiopia. But Spain, Turkey and Poland declined to act without Britain and France.

Complete deadlock threatened. Then came a private session at which agreement was reached on the committee of five, with Italy neither agreeing nor rejecting. At this private meeting incidentally both Aloisi and the Ethiopian representatives were present.

preventing direct conflict between Italy and the League. (By Andree Berding) (Associated Press Foreign Staff) ROME, Sept. 6.—A hint that Italy might demand Britain's exclusion from Egypt if she continues to regard Italy as a threat to her in Africa was given today by the semi-official journal Azione Coloniale (Colonial Action).

"If Italy is a danger to the British Empire, the publication said, Britain is also a danger to the Italian empire. "Britain affirms that Italian action in East Africa is injurious to her interests and her imperial security," it asserted. "The route to India, the territorial continuity between Cairo and Capetown, the base at Aden, such are the principal British interests which would seem to be menaced by Italy."

"We want to speak rather of another imperial security—our own," the Journal continued. Asserting none can deny that Italy has reached a rank among the great so-called imperial powers, it said: "If, therefore, the presence of Italy in East Africa is recognized as damaging to imperial interests in England, the same thing must be said of Britain's presence on the seas, coasts and bases within the Imperial Italian sphere."

Declaring "Britain at Alexandria, Egypt, is as dangerous as Italy in Adis Ababa," and mentioning Aden, Malta, Gibraltar, Cyprus, and Haifa as other menaces, the publication asserted: "For our own security we can very well demand Great Britain's exclusion from Egypt."

Would Curb Italy GENEVA, Sept. 6.—(C. P.—Havas)—Millions of workers throughout the world, through their representatives at Geneva, today called upon the Council of the League of Nations to curb "Italy's aggressive attitude" and apply full sanctions in the event of an Italo-Ethiopian war.

A strongly worded resolution to that effect was adopted by the International Federation of Trade Unions at a plenary session, held while the League Council was grappling with the East African crisis. The resolution was voted by 52 delegates of Socialist Labor Federations of 12 countries and 10 international trades unions. The resolution also was voted by delegates of the Labor Socialist International meeting in Vienna. The measure will be submitted to both the President of the present Council session and to the Secretariat of the League.

Senator Louis de Brouckere of Belgium presided at the conference. Addresses were made by the French Socialist labor leader, Leon Jouhaux. The resolution was endorsed by Pietro Nenni, an Italian member who is an anti-Fascist.

(By James A. Mills) (Associated Press Foreign Staff) (A.P. By Guardian's Special Wire) ADDIS ABABA, Sept. 6.—Emperor Haile Selassie made a fresh appeal to the League of Nations today to preserve peace between Ethiopia and Italy.

At the same time owners of all elephants, camels and mules used for commercial transport offered him their livestock for war purposes.

Their patriotic gesture was an unusual indication of sentiment, as these men as a rule are a peaceful lot, uninterested in politics and generally are looked down upon by the warrior class.

The Emperor's appeal to the League was made in a communique commenting upon the decision of the Laval Commission, which held neither Ethiopia nor Italy to blame for the border incident of last December that cost both Italian and Ethiopian lives.

"But the problem of Italo-Ethiopian relations still exists," the communique said. "The League, in accordance with its resolution of Aug. 4, must re-examine and settle the entire dispute at the present session. Ethiopia, as a member of the League, asks the council to define clearly an interpretation of the Italo-Ethiopian treaty and other disputed questions."

Italy's "excuses for war" were criticized in a speech this afternoon by Alois Mackonnen Haba Welh, director general of the ministry of commerce. He denied Italian allegations of slavery and anarchy in Ethiopia.

Hubert Julian, the "Black Eagle of Harlem" will leave tomorrow for Ambo, where he will be entrusted with a garrison. Julian deplored Ethiopia's lack of preparedness in the air.

Exhausted by their intensive labors, the Emperor's foreign brain trust, included Everett A. Colson, American financial advisor, went to a health resort at a lower altitude, 30 miles from Addis Ababa for a weekend of rest. All showed the strain of the crisis.

REICH PUZZLED BY U.S. COURT RULING

(A. P. By Guardian's Special Wire) NEW YORK, Sept. 6.—Charges against the men, growing out of the riotous Bremen flag-snatching last July 26, were dismissed today by Magistrate Louis Brodsky, but a sixth defendant was held for grand jury action on assault charges.

In a lengthy decision which avoided any direct reference to Germany the Nazi regime, Magistrate Brodsky reviewed the disorders during which the Nazi flag was ripped from the German liner's mast, and added: "Nor am I unmindful of the fact that to these defendants, again rightly or wrongly, the prominent display of this emblem even carried with it the same sinister implications as a pirate ship, sailing defiantly into the harbor of a nation, one of whose ships it had just scuttled, with the black flag of piracy proudly flying aloft."

Farther down, the Magistrate said: "I want no word of mine to be construed as countenancing such unlawfulness. . . . It may well be . . . that the flying of this emblem in New York Harbor was rightly or wrongly, regarded by our citizenry as a gratuitously brazen flaunting of an emblem which symbolizes all that is antithetical to American ideals of the God-given and inalienable rights of all peoples to life, liberty and the pursuit of happiness."

Regarding four of the defendants—Arthur Blair, William Bailey, William Howe and George Blackwell—the Magistrate ruled their presence aboard the Bremen did not constitute unlawful assembly. As to Vincent McCormack, another defendant, the Court ruled there was a variance of testimony which caused Judge Mathew Solomon during the disorders. The sixth defendant, Edward Drolette, was ordered held for grand jury action for assault and violation of the Sullivan gun-carrying law.

"HARDLY BELIEVABLE"

BERLIN, Sept. 6.—An official of the Propaganda Ministry tonight called the decision of Magistrate Louis P. Brodsky in New York dismissing five men from charges growing out of a riot on the liner Bremen "hardly believable."

"This is a tough decision," he said, "hardly believable and unheard of. I cannot understand it."

Ask Support For Railways

(C.P. by Guardian's Special Wire) VANCOUVER, Sept. 6.—(G.P.)—Canadian railways will take every step within their power to win back to their lines traffic lost to competing forms of transportation. Sir Edward Beatty, president of the Canadian Pacific Railway, said today.

He endorsed statements made at Toronto yesterday by Vice-President D. C. Coleman asking Canadians to give more support to their railways as alternative to a skeletal service.

Competition of other transportation modes will be increased rather than diminished with the rapid advance in air service, probably within the next few years, Sir Edward said.

"There is a limit, however, beyond which the railways cannot go in a period of declining revenue and, therefore, limitations in service, no matter how regrettable, may be necessary. I hope they will not be because there are other ways of much more permanent value of improving the condition of Canadian railways."

Toronto Journalist Passes

(C.P. by Guardian's Special Wire) TORONTO, Sept. 6.—(G.P.)—Joseph H. Armstrong, Toronto newspaperman, died early today. He had been in poor health for several months.

Born in Milltown, County Down, Ireland, in 1889, Mr. Armstrong came to Toronto at the age of 23 and for some years was on the editorial staff of the Toronto World. He later joined the Mail and Empire where he remained nearly two years. Five years he was with the Canadian Press, later becoming connected with the Daily Star.

Leaps From Train To Death

(C. P. by Guardian's Special Wire) RIMOUSKI, Que., Sept. 6.—Suicide was the verdict of a coroner's jury which today probed the death of Antoinette Rubaud, 55, of Sydney, N. S., mother-in-law of John Butler, (Mitchell Street) Dominion, N. S., who, an eye-witness testified, jumped off the train of the Canadian National Railway near here yesterday.

The train was en route to Quebec from where the woman had booked passage in the Duchess of York for Belgium. Her steamship fare was paid.

A rider to the verdict absolved the railway of all responsibility in the death.

Canadian Appointed By Palestine Govt.

(C.P. by Guardian's Special Wire) OTTAWA, Sept. 6.—(G.P.)—The Department of Trade and Commerce announced today it had loaned E. A. Cudmore, editor of the Canada Year Book, to the Palestine Government for three years to organize a bureau of statistics on the same principle and practice as the Dominion Bureau of Statistics.

Request for a Canadian to form the Palestine bureau came from that country's government through the British colonial office and bears out statements frequently made in recent years about the high regard in which Canadian statisticians were held in other parts of the Empire. Mr. Cudmore's appointment was recommended by Trade Minister R. B. Hanson.

STEVENS MAKES SPECIAL PLEA IN MARITIMES

ered on its merits," he said. "No Federal leader should ever declare he would refuse to consider a proposition from a provincial government because it is on the opposite side of politics."

The aide when Hon. R. W. Wigmore, a former Dominion Minister of Customs, was introducing Mr. Stevens, brought response from the Reconstruction Party leader. Incidentally it led to the summary departure of the inter-rupter, propelled by a policeman.

Mr. Stevens declared "my first act of treachery was when I stood upon a platform and demanded for the Canadian farmer the right to set a price for the produce he had to sell." He had broken loose because he could not get action on crying abuses which he claimed existed. "I made the break two years ago. I'd rather be a traitor to the flag interests and fight for the people than be faithful to the big interests," he declared.

Before the Reconstruction Party leader spoke, his son, Rev. Francis H. Stevens addressed the meeting briefly. He testified to the sincerity of his father, and declared Mr. Stevens had more to offer than any political leader of the day.

Hon. H. H. Stevens, Reconstruction Party leader, carried his campaign into the Maritime Provinces when he addressed a meeting here tonight. It was the first of a series of speeches which Mr. Stevens will make in New Brunswick, Nova Scotia, and Prince Edward Island.

Two new meetings have been added to his New Brunswick schedule. He will speak tomorrow afternoon at St. Andrews and St. Stephen, in addition to the night meeting at Fredericton.

The Reconstruction Party leader was driven at the head of a long parade of cars through streets somewhat obscured by fog, to the Forum here tonight. Chairman of the meeting was Paul B. Cross, of Saint John, who said "principles of fair play and unselfishness must be applied to politics or the whole thing will fall completely."

He introduced Rev. Francis H. Stevens, son of the Reconstruction Party leader. Francis Stevens said he was happy to support his father "because I know he is sincere." He addressed his remarks particularly to youths saying that they were entitled to something better than present conditions offered. He believed his father had more to offer the people than any of the other leaders.

Dr. Francis Fish, Reconstruction Party candidate in Northumberland, protested against concentration of capital in the hands of a few.

Is Ejected

Hon. R. W. Wigmore, of Saint John, introduced Mr. Stevens. He predicted the Reconstruction Party leader would be the next Prime Minister of Canada. While he was speaking there were some protests from a man in the audience who was subsequently ejected by a policeman.

Mr. Stevens said he did not recall a time in which there was such genuine interest in public matters as at present. He proposed to give some attention to the plight of the farmer. Farmers all over Canada were affected by similar influences and conditions.

"The Reconstruction movement grew out of a great question mark in the minds of the people?" They wondered if the old parties were capable of solving the problems facing the country thousands. Mr. King said the important thing was to restore confidence in the people and ensure unity. He had also stated that the Liberal party was in a better position to provide unity because there were eight Liberal provincial governments in power.

Contrast Liberal Leaders

"This is sheer nonsense," said Mr. Stevens. He contrasted views of some of the provincial premiers. "The Liberal leader in Quebec—Mr. Taschereau—is the most reactionary man in Canada. I have heard him described as an ultra-Tory, and he had said the other hand in Western Canada there were Liberal leaders like Mr. McGeer who claimed 'the east was gobbling up everything.' As a matter of fact provincial autonomy was a 'sacred thing.' To endeavor in any way to mix up federal with provincial issues or base an appeal for federal support on the basis of provincial governments was wrong.

Campbell Says No Limit To Land Speed

(A.P. by Guardian's Special Wire) SALT LAKE CITY, Utah, Sept. 6.—(A.P.)—Sir Malcolm Campbell said today he obtained "valuable and interesting" information from a motion picture film recording readings of the instruments in his Bluebird when it averaged 301.192 miles an hour, a world record. He added, however, that the full meaning of his experiments could not be known pending a more thorough check.

For the speed tests, duplicates of all instrument board dials were constructed inside an airtight box which stretched along the right side of the Bluebird just inside the body between the engine and driver's seat. A motion picture camera, built in one end of the box, recorded the readings from start to finish.

Sir Malcolm decided upon this scheme because of his inability to take his eyes off the course during his terrific dashes. He said the plan worked "perfectly," and added the information gleaned from the readings would enable him to improve upon certain features of racing craft should he decide to construct another car in an effort to boost his five-miles-a-minute mark still higher.

"There is no limit to land speed," the iron-nerved driver said, "but motor cars must be further perfected to attain greater speeds than 300 miles an hour."

Loses Money On Vacation Trip

Caddell, who said he came here to visit historical points, told the court he became acquainted with a young woman in a tavern where he stopped to get a glass of beer. When she offered to act as his guide he said he accepted. A short time later he said, he was thrown out of a taxi-cab minus his money.

Judge Joseph Donovan ordered a hearing next Wednesday after Dorothy Burke, 25, and two taxi drivers, William Bergeon and Nicholas Ben Tufo, pleaded innocent to larceny.

Mr. Stevens gave figures indicating that in the farm implement industry, for instance, there had been tremendous merging of organizations. In business you have the chain and department stores stretching their tentacles all over the country, destroying the independent dealer, not because they are cheaper but because they buy lower."

Maritime Rights

Maritime rights was a very important matter to the Maritime Provinces "but to political leaders it is a thorn in the flesh." He described how this matter was debated year after year in the House of Commons. Members from the Maritimes got up and spoke and when "Maritime Day" was over they sent copies of Hansard to their constituents. But party whips saw that there were no dividends and the government was forced to declare itself.

"The people of the Maritime Provinces all believe they have a grievance as a result of their treatment by the rest of Canada." He thought the grievance existed and that the Maritimes had not been afforded that access to central markets to that access to the Confederation pact. He advocated "bringing the Maritimes 500 miles nearer the Quebec and Ontario markets" by adjustment of freight rates.

KING'S HONORS BESTOWED BY GOV. GENERAL

Four Men Receive Order of Knighthood In Ancient Ceremony.

(C. P. by Guardian's Special Wire) OTTAWA, Sept. 6.—Sixty persons today bowed before the Governor General and received from him the Order of Knighthood bestowed on them in the King's Jubilee birthday list, while a group of about 90 friends and relatives looked on.

The ceremony which took place at Government House saw the Earl of Bessborough tap on the shoulder with his sword four men, a soldier, an archivist, an artist and a musician. By this ancient gesture His Excellency invested them with the order of knighthood King George bestowed on them.

The men were Major General Sir James J. MacBrien of Ottawa, Commissioner of the Royal Canadian Mounted Police, Sir Arthur G. Doughty, former Dominion Archivist, Sir E. Wylie Grier, of Toronto, noted artist, and Sir Ernest C. MacMillan, conductor of the Toronto Symphony Orchestra.

On the other recipients he planned or hung the insignia of their honors. At the end of the ceremony, a simple affair in which the honored persons walked before His Excellency on hearing their names announced by an aide-de-camp, the Governor General and Countess of Bessborough received all the guests.
