**Losses Experienced On N. Y. Market**

 NEW YORK, Nov. 6 (AP)—The widest break in stock prices in nearly two months was the market's response today to the Republican election landslide. Losses ranged from one to around 7 points.  
 The Associated Press 60-stock composite declined 24 points to 62.8, its sharpest since Sept. 9. Canadian stocks extended noon losses, finishing with substantial declines. Distillers Seagram dropped 1 1/2. Hiram Walker 3/4, Dome Mines 1/4 and Canadian Pacific 1/2. McGraw-Hill, ahead at midday closed unchanged. On the curb, Lake Shore slipped 3/4 and Giant Yellowknife 1/4.  
 Wide downswings were encountered by Coca Cola off 7 at 140. Du Pont 6 1/2 at 173. Chrysler 5 1/2 at 81 1/2. Goodrich 4 1/2 at 62 1-2. and Union Carbide 4 1/2 at 90. Other prominent losers included U.S. Steel, down 3 1/2 at 69 1/2. U.S. Gypsum 4 at 106 and Santa Fe American Telephone, Bethlehem, Youngstown Sheet, U.S. Rubber, Montgomery Ward, Caterpillar Tractor, North America, Electric Power & Light, Commonwealth & Southern, United Corp., American Water Works, American Smelting, Air Reduction, Eastman Kodak, Philip Morris, Phelps Dodge, Standard Oil (N.J.), Chesapeake & Ohio and Southern Railway.

**Trends At Montreal Parallel N. Y. Stocks**  
 MONTREAL, Nov. 6 (CP)—Trends closely paralleled post-election tendencies in New York in transactions today on the stock exchange and curb market. After a short upswing in initial deals a wave of liquidation set in. All groups were down in the indices except banks in contrast to the bullish pre-election performance of these. Inter-listed stocks were particularly affected by the selling movement. Turnover was moderate. Individual losses ran to 3 1-2 points. In papers, St. Lawrence Paper preferred, Donnacona, Abitibi common, International and Bathurst "B" converted gains into losses. Fraser, Great Lakes and Brown preferred lost 1/2. Consistently down were Price, the top loss. Consolidated, MacLaren and Quebec Pulp preferred, off a point or more, and Abitibi preferred, Brown common, M. and O. H. Smith, B. C. Forest, Eddy and St. Lawrence common.  
 Losers in industrials included Dosco, M. Locomotive, U. Steel, Ford, Electrolux, Asbestos, C. Glass, Massey C. Car issues and Cockshutt. Montreal switched from win to loss area. Up were G.S. Wares, Foundation, Algoma, C. Industries and Fairchild. Dominion Textiles was softer in its section and woolens did not hold a rise. U. Distillers was ahead in beverages. C. Breweries, Alco "A", and Walker turned increases into deficits. N. Breweries ceded an improvement and Seagrams and Alco "B" were always down.  
 Among utilities, retreating were Bell and B.C. Power "B", which opened higher. Winnipeg Electric, Power Corporation, Brazilian, I. Power and S.C. Power, Quebec and Montreal Powers did not retain an advance while B.C. Power "A" and Shawinigan showed resistance.
