## POOR MAN'S CLUB

### The Saloon is not Such Says Potter.

### Nor is it in any Way necessary to The Working Man or Poor Man—The Bishop Answers His Reported Defence of the Saloon—He Was Misinterpreted.

NEW YORK, January 27.—Bishop Potter's defence of the saloon is still drawing forth replies from church and temperance workers, who do not accept his views as declared at the recent meeting of the Church Temperance Union, in the Waldorf-Astoria.  
At the meeting of the Blue Button Brigade last night at the Open Door Mission, Col. Henry H. Hardy discussed the argument attributed to Bishop Potter, that the saloon is "the poor man's club" and must be tolerated in lieu of something better. Col. Hardy spoke, he said, from the point of view of "a rescued man."

"Dangerous words are said to have been spoken upon the subject recently. Let us charitably hope that they were misquoted. On behalf of my colleagues I may say that rescue workers feel that their cause has been injured, and the advocates of total abstinence, from a Christian standpoint, know that their work has received a serious set-back. I have been asked by the Christian Men's Union for Total Abstinence and Rescue Work to say a few plain words to-night protesting against the alleged declaration that 'the saloon or this poor man's club,' that it is in any way necessary to the workingman or poor man.

"Supposing the saloon were a club at all, it is the poor man's club only because he has made himself poor by spending the money that would have made his home comfortable. If a club at all, it is a bad man's club, a drinking man's club, a thieves' headquarters, the scheming place for a certain class of politicians, a place of sin and temptation, usually followed by remorse, disappointment, slavery to appetite, and death. I have known a great many men in my time who thought nothing of spending 50 cents for a single drink at the Hoffman House bar, and who afterwards were so reduced financially that they would be glad to get a 3 cent drink of whisky in Mulberry Bend. (Cries of 'That's right and True!')

"If the husband gave his home the cheer and smile and bright words that give the saloon, surely the wife would be less 'untidy' and the children would 'squeal' less. The average amount spent in the saloon by the workingman is \$100 a year. Each of the 250,000 saloons in America has an average of at least 40 customers, making the drinking people under 10,000,000, or one-seventh of our population.

"If we are going to have inns and other country attractions to the saloon I insist that the whole family be embraced in the benefits—untidy wife 'squealing' children, and all. They have rights.

I want to expose another fallacy, and

that is that the rich man's home is happier than the poor man's home. I have witnessed terrible degradation and misery through drink in the homes of the rich, as well as of the poor, and while I have seen many happy homes among the rich, yet the happiest homes I have seen and the homes to which I most love to go, are the homes of the poor, and I am glad to testify that the majority of the workmen prefer home to any saloon.

CINCINNATI, January 27.—The Rev. George M. Hammell, of the Western Christian Advocate, and Chairman of the Hamilton County Prohibitionist Executive Committee, of New York, who is reported to have said that the saloon is "the poor man's club" and a necessity. The letter to the Rev. Mr. Hammell, which was written in response to a personal inquiry, runs as follows:

Diocesan House, Lafayette Place, New York, Jan. 31.  
My Dear Sir: You have been misinformed. I have never expressed any opinion as to the "dramshop." In a recent address in behalf of the coffee houses, coffee wagons, coffee carts, and the like, I stated that something answering to the saloon, i. e., place of inexpensive recreation and refreshment, would always be a necessity. I may add that until it is provided the mischief of the saloon, which nobody recognizes more clearly than I, will continue. The saloon may be driven to cover, but it cannot be abolished. Something better, something wholesome, harmless, undefiled, and undefiling must take its place and so expel by substitution. Legislation has failed to do this, and Prohibition has failed. Denunciation has failed. It is a case for Christian capital, wisely employed, as the history of the Liverpool coffee houses has shown.

## SPREAD OF SMALLPOX

TORONTO, January 29.—So far as can be ascertained the boy, who is suffering from smallpox in the county of Grenville, contracted the disease in a train while on a journey to Smith's Falls. The strictest enquiry has, however, failed to discover any cases of smallpox in the latter town. At present the disease prevails in three localities in Canada—in Essex county, Grenville county, and the province of Quebec. The medical health officer for New York and Michigan states have not been reporting the smallpox cases in their districts, and this adds to the difficulty of guarding against its importation to Canada. This is in violation of the agreement arrived at between the health officers of Canada and the United States. Dr. Bryce has telegraphed to Albany to find out the condition of affairs in New York state, and had been informed that a statement is on the way. Smallpox is epidemic in Detroit, and Dr. Bryce has asked for a detailed explanation of the present situation there. The rapid spread of the disease on the other side is causing some anxiety to the provincial medical authorities, in view of the difficulty of guarding against the introduction of the disease from so many centres of infection.

## HIGH COMMISSION

### May Continue Sitting for Weeks Yet.

### Foster and Costigan in N. B. Elections—Both Parties Calling Conventions—Sir Francis Ford Dead—Chief Justice Taylor of Manitoba Resigns—Successor to Dingley.

OTTAWA, Jan. 31.—(Special)—Chief Justice Taylor of Manitoba has resigned.

Sir Thomas Wardlaw Taylor was born in Scotland, in 1833 and educated at Edinburgh University. He came to Canada early in life, studied law and was called to the bar in 1858. He was appointed a puisne judge of the Queen's Bench, Manitoba, in 1884, and became Chief Justice on the death of Hon. Lewis Wallbridge in 1887. He was knighted in 1897.

PARIS, Jan. 31.—(Special)—Sir Francis Clare Ford, recently British ambassador at Rome, is dead.

He was British agent for the fisheries commission at Halifax in 1875 and 1877 and British commissioner at Paris on the Newfoundland fishery matter in 1883.

FREDERICTON, Jan. 31.—(Special)—Hon. G. E. Foster arrived today to assist in the Conservative campaign against the local government.

Hon. John Costigan is expected here shortly to help the government.

The two parties are trying to ground the contest on different issues. The government party are making their fight against introducing Dominion party lines. The opposition attack the government mainly on the score of their bridge contracts.

The Conservative convention are already called for Charlotte, Carleton, Albert and Westmoreland counties and St. John city.

The government conventions are called in St. John, Kings, Westmoreland, Albert.

WASHINGTON, Jan. 31.—(Special)—Nobody will yet predict when the end of the sessions of the Canadian joint high commission will be reached.

The Alaskan boundary matter is now being considered. It seems probable that the President will appoint a new commissioner in place of Dingley deceased.

## EGAN GUILTY.

WASHINGTON, Jan. 29.—General Egan, commissary of subsistence, has been found guilty of the charges of conduct unbecoming an officer and a gentleman, and of conduct to the prejudice of good order and discipline, and of the specifications thereto, and has been sentenced to dismissal from the United States army, but with a recommendation from the court for exercise of executive clemency. Under the regulations, the court having reached the conclusion that the accused was guilty, had no choice in selecting a penalty, the regulations prescribing absolutely the one punishment—dismissal—for the offence. Therefore, the only hope for General Egan is in the direction of the commutation, mitigation, or disapproval.

## I. O. FORESTERS.

### Meeting of The Executive Committee Held in Charlottetown Yesterday.

The Executive Committee of the High Court Independent Order of Foresters were in session at the Queen Hotel from 5 to 10 p. m. last evening. Matters connected with organizing of new courts, free medical attendance and other questions affecting the Order were considered by the committee.

It was decided to hold the annual session of the High Court in Kensington on August 9th and 10th.

All members of the committee were present: viz., J. M. Clark, Summer-side; E. S. McPhail, Crapaud; A. P. Prowse, Murray Harbor; George F. Owen, Cardigan; L. U. Fowler, Bed-que; Dr. Dougherty, Cape Traverse, and F. S. Jost, Charlottetown. Dr. Robertson, Past High Physician, was also present.

Mr. Clark, High Chief Ruler, gave the following statement just received from the Head Office at Toronto:

During the month of December, the Surplus fund increased \$56,900. The total surplus on the first of January was \$3,186,370.36. During November and December, 11,024 applications were received, out of which 9,879 were accepted and during the first seven days of January 1,217 applications were received. This does not look like as if the new rates of the I. O. F. are having any effect on the growth of the Order.

## GOMEZ' DEMANDS

### Wants 60,000,000 From United States.

### Garcia Had Bargained for Three Millions—France Borrowing—The Government Satisfied—A. D. D. Falls Dead while Preaching a Funeral Sermon—Princess Ferdinand Dead.

LONDON, Jan. 31.—(Special)—Rev. Charles Albert Berry, D. D. a noted author of religious books, chairman of the Congregational Union of England and Wales and first president of the National Council of the Evangelical Free Church, fell dead today while conducting a funeral service.

SOFIA, Bulgaria, Jan. 31.—(Special)—Princess Ferdinand died after giving birth to a daughter on Tuesday last.

WASHINGTON, Jan. 31.—(Special)—Gomez has demanded nearly sixty millions of dollars and refuses to disband his Cuban army unless that sum is paid. He repudiates the agreement made by Garcia.

The government was ready to carry out that agreement, which would mean the distribution of about three millions, giving about \$100 to every Cuban soldier and more to the officers. Gonzalez Quezada, the Cuban representative here, has gone to see him and try to persuade him to a different course.

LONDON, Jan. 31.—(Special)—The French government is arranging to borrow forty or fifty millions for army and navy increases.

Some orders have already been given to English firms.

PARIS, Jan. 31.—The Chamber of Deputies yesterday by a vote of 346 to 139, adopted the government's proposition to submit to the committee interested with such matters, a bill providing that cases on trial of revision shall be brought before the united sections of the Court of Cassation.
