Persons were in hospital at Amherst, 18 miles from here.

Among those, Fireman C. M. Reeves was most seriously injured with scalp and chest wounds. Like engineer Bauer he was taken from the engine after the accident.

From Springhill Junction to the spot where the accident occurred, 1.3 miles to the west, the road is all down grade. After the heavily laden coal cars were jolted out

of the yard by shunting operations and jumped a switch onto the main line, they gained terrific speed on the grade.

Although the crew of the little junction shunter, knowing the limited was approaching, set out in pursuit, they were unable to catch the eight runaway cars. The engine reached the scene just after the accident and barely missed plunging into the chaos.

With screeching brakes, it came to a stop just behind the last of the coal cars. An automobile, carrying a group of railwaymen at-

## Inquiry Reveals Alleged Racket In Gasoline

Gasoline was transported across Northumberland Strait last year by boat owned by Edmund Melanson, St. Thomas, Kent Co. N.B., and sold to fishermen at Miminigash for 15 1/2 and 16 1/2 cents per gallon while local dealers were selling gasoline to fishermen at the rate of 20 cents per gallon less a 6 cents rebate, it was revealed yesterday by a Royal Commission probing illegal fishing of lobsters and smelts in districts 7 and 8 during 1936.

The Commission concluded sittings in Tignish late yesterday after hearing the evidence of nineteen witnesses during the past three days, and last night returned to Alberton where sittings will be resumed today and probably continued Tuesday.

Fred Deagle, Miminigash buyer during the legal lobster season for the past three years for Edmund Melanson, stated the latter's boat had brought about 85 drums of gasoline to Miminigash during the open season of 1936 and sold it to fishermen there, adding that Melanson had told him he had bought the gasoline from McColl-Frontenac Oil Company Limited in Moncton at the rate of eleven cents per gallon.

When the hearing resumed yesterday morning, Arsene Gallant was recalled and his testimony completed. He admitted he had poached lobsters in 1934 and landed them at Tignish Run. Gallant, who was patrol boat captain for two months last year, told counsel Hon. H.F.G. Bridges that he was under the impression his duty was on the water. He said he could not read but that his engineer had read his appointment warrant to him. Asked if he had the appointment with him, witness replied he had, and handed it to counsel, who then read it to him. After this was completed he said it was the first time the entire appointment had been read to him and he was unaware the appointment gave him permission or authority to do land work.

He said he did not want to get "in wrong" with the fishermen at Tignish Run by searching their boats when he was patrol boat captain, and his testimony was completed. He would have a job for say, five years he would have worked much harder.

The next witness was Timothy LeClair, Nail Pond fisherman, who said he had fished and canned eleven cases of lobsters in 1936 and had sold them to C. P. McCarthy. He said he had been caught packing illegally by Inspector C. R. Palmer early last fall and that he had been fined \$50 and had a case and a quarter of packed lobsters seized, but he did not pay the fine and continued packing after that. In fact, he said, he canned his eleven cases after he had been caught.

The next witness was Fred Deagle, Miminigash. He explained that he had acted as buyer during the spring season for the last three years for Edmund Melanson, who sold to Melanson sending gasoline across to the Miminigash shore and of Edward Mooney, who was in charge of the boat, selling it to the fishermen for 15 1/2 and 16 1/2 cents per gallon while local merchants were charging 30 and 31 cents.

He said Edmund Melanson told him he bought the gasoline from McColl-Frontenac Oil Company Limited at Moncton for eleven cents a gallon and that Melanson's boat had brought across about 85 drums of 45 or 46 gallons each to Miminigash last spring season and had made one trip in the fall with about twelve drums.

"The Big Guys"

The witness said the Melanson boat was delivering gasoline to West Point, but he could give no idea of what amount had been left there. He was of the opinion Melanson had not bought poached lobsters in this section of the province last year and remarked "The big guys would have had him caught. You cannot do that unless you are in with the big fellows."

Mr. Deagle admitted having poached and canned lobsters in 1935 and 1936 and told the Commissioner, Mr. Justice A. T. LeBlanc, that he had sold his pack to Arthur Clark, Alberton.

Told to "Go Easy"

He agreed that the shifting of the district line would help fishermen on the west coast and help to eliminate poaching. He expressed the opinion illegal fishing could not be stopped, but stated that was a patrol boat captain in 1926 and just prior to a provincial and federal election he had been advised to "go easy" on the poachers by a local committee. Asked if he adhered to this request, witness replied, "Sure, I lay low."

"From whom did the orders come to go easy?"

"From the member at that time. He is dead now, as well as the man who brought the word to me."

The patrol boat P.D.B. No. 1 was not a good boat for dragging for gear, Mr. Deagle said, and remarked, "It is a sort of pleasure boat brought up from somewhere

in Nova Scotia".

He doubted that 6,000 lobster traps had been destroyed off West Prince County shore last year, and said he did not think there were that many destroyed in the district for the past five years.

In the afternoon Mr. Deagle was recalled and said he had seen at West Point last summer a crate of lobsters of which about 50 per cent were berried and female lobsters. He did not know the name of the fisherman who brought the lobsters ashore, nor did he know the buyer's name.

Edward Gaudet followed to the stand. He said he lived at Pleasant Point and in addition to being a farmer was also in the lobster business. Concerning 46 cases of lobsters purchased from him by Chester P. McCarthy last fall the witness said the lot with one exception had been canned by himself and his brother Earl. The canning was done in their factory and in other buildings nearby. The factory had operated at night when the illegal canning was done.

He told counsel he owned 108 acres of land, of which 80 or 85 acres were clear, and added he could live without poaching.

"Are you of the opinion the moving of the district line will be an aid to stopping illegal fishing?"

On the west coast, "yes".

F. D. Callaghan, St. Louis merchant, admitted selling to C. P. McCarthy, Tignish 35 cases of lobsters during the closed season last year and said they were all illegally packed. He told of accepting the cases of canned lobsters on account. Witness informed counsel the firm had bought \$153,000 worth of lobsters one year between 1920 and 1925, but he was unable to give the exact year. He felt that that amount, between 10 and 20 per cent were illegally canned.

"Do you know Edmund Melanson?"

"No, but I have heard of him."

"Was he a competitor of yours insofar as gasoline was concerned?"

"He sure was."

"How?"

"Well, fishermen told me he transported gasoline over from the mainland and sold it to them for 16 cents, by the drum, while we charged 29 cents. Of course fishermen received a rebate of six cents when they bought from us, yet his price was considerably lower than ours."

He too expressed the opinion the changing of the district boundary line would assist in eliminating poaching along the west coast, but said he thought two short seasons would be the complete remedy.

The final witness of the day was Leslie McCarthy, manager of Tignish Fisheries Limited and also manager of C. P. McCarthy's Higgins Wharf factory. He denied ever handling any illegally caught lobsters and also denied ever having packed any poached lobsters. He said it was necessary for some fishermen to fish illegally, but also felt it was not necessary for others.

osis was to be found according to the latest information available, Dr. P. A. Creelman, superintendent of the Provincial Sanatorium, told the meeting in the course of an interesting address. There were 60 patients in the Sanatorium and 69 active cases outside and the records were not complete by any means. It was a far cry from the results attained now in the fight against tuberculosis compared with what had been the case when the organization which is now the Dispensary began work 27 years ago, Dr. Creelman said, reviewing briefly the history of the T. B. fight in this Province.

It was impossible under present conditions to care for all the tuberculosis patients in the Province in an institution, the speaker said, and went on to describe the formation of the Provincial Tuberculosis League. The object was to co-ordinate the work of all interested societies in rural and urban centres. The result has been that cases are now discovered earlier which means fewer Sanatorium cases and fewer deaths.

Dr. MacMillan moved a vote of thanks to Dr. Creelman for his address. He paid tribute to the work of the Sanatorium Superintendent, who, he declared, was "saving untold citizens for this Province."

Votes of thanks were tendered the Mayor and City Council for the use of the Board Room, the Secretary-Treasurer, Mrs. R. L. Cotton, Miss Amy Earle and the Press.
