EAGLES FAIL TO HALT RUSH OF TORONTO

Jackson Scores Four Goals As Maple Leafs Take Sixth Straight

(C. P. by Guardian's Special Wire) ST. LOUIS, Nov. 20.—Toronto Maple Leafs crushed St. Louis Eagles 5-2 here tonight with a dazzling third-period rally engineered by Harvey Jackson that made the count six straight victories for the Leafs in the young National Hockey League season. Jackson bagged all four Toronto goals in the final session.

The powerful Leafs got into plenty of trouble before they got things organized after two rough even periods in which Harold Cotton, Charlie Conacher and Red Horner drew major penalties and Scotty Bowman got one for St. Louis. The stiffuists made a brief and exciting appearance in the second period.

Cotton and Bowman got tangled up and started to fight. Conacher went to Cotton's aid, almost precipitating a free-for-all on the ice. All three were awarded majors. A minute later Horner lashed out at Deese Roche and another battle was under way. The red-head drew a major and Roche a minor.

At times all the players on both teams were on the ice, most of them attempting to stop the fighting. The score was tied when the first started to fly but St. Louis went into the lead before the second ended when Syd Howe shot in a double pass from Carl Voss and Glenn Grysdon. Brydson had scored for the Eagles in the first period. Bill Hollett tying it up early in the second.

Jackson teamed with Conacher to overpower the Eagles in the third period. The dark-haired left-winger snapped shots into the cage past goalie Bill Beveridge and three of them were on plays in which the giant right-winger has a part. Red Metz organized the other successful raid, passing to Conacher who relayed the puck to Jackson for the scoring shot.

Bill Cowley, formerly of Halifax Wolverines, hurt his head in the third period and had to leave the ice but returned after treatment. Earlier in the game he filled in on defence for St. Louis while Bowman was serving a major penalty.

Bruins Blank Red Wings BOSTON, Nov. 20.—(A.P.)—Expert backchecking led the speedy Detroit Red Wings over controls tonight when Boston Bruins gained a 1-0 victory in their second home start.

NEW YORK, Nov. 20.—(C.P.)—Montreal Maroons, in their first appearance in Madison Square Garden this season, tonight gave New York Americans their second shutout of the National Hockey League campaign 3-0 in a dull game before 10,000 spectators.

Absorbing their second defeat in two games, the first by Toronto Maple Leafs last week, Americans have yet to score their first goal in the campaign. Their next attempt will be against Canadiens at Montreal Thursday.

A tight Maroon defence which played strongly despite the loss for this game of Lionel Conacher, cut off every attempt by Americans to make their drives count. After Maroons scored their first tally, in the second period, they played safety-first hockey and made few attempts. Both of their third period tallies were break affairs, each by the rookie Gus Marker.

Earl Robinson, Maroons' best marksman at this stage of the race, scored the opening tally on a quick thrust when the Americans left the unguarded for a moment in a scramble after Russ Bilno's rebound. Earl pounced on the puck and rifled it home.

Late in the third period Marker, called in from Windsor because of a bad cold, scored twice with the aid of the enemy. His first shot, a long one, glanced into the net from Red Dutton's stick when the big defenceman tried to bat the puck in the air, causing a fashon. Goalsie Roy Worsley in his only error of the night deflected Marker's second goal into the cage while trying to intercept a passout.

CARDS SOLD TO WENTZ IS RUMOR

Presence of Oklahoma Oil Magnate at St. Louis Club Quarters Significant.

Associated Press Sports Writer LOUISVILLE, Ky., Nov. 20.—Rumor mounted on rumor as major and minor league baseball leaders cautiously began sparring for big player deals today, but the most persistent one of all was that Lew Wentz, Oklahoma oil man, already had closed the deal for the world championship St. Louis Cardinals.

Wentz, a red hot baseball fan with seas of ready money, was much in evidence around the Cardinal headquarters, but insisted his presence had no significance. However, two representatives of the far flung Cardinal chain store system who didn't want their names mentioned for obvious reasons, said they were positive the big deal had been consummated making Wentz owner of the champions.

"I'm here because I just can't stay away," said Wentz, an affable man with the enthusiasm of a boy over his first football. "Guess I'm the nuttiest fan of all. Why, between world series games at Detroit, I flew down to Columbus to see a night game of the little world series."

Although there were countless huddles among major league owners, managers and scouts today, the only news item was the little world series. The American Association voted to scrap its usual play-off series for the league championship and served an ultimatum to the International League to do likewise or at least arrange a short post-season play-off series as to decide the I. L. pennant winner on or before Sept. 15, the closing day of the A. A.'s 154-game schedule.

HALL WILL HEAD U.S.L.T.A.

By Guardian's Special Wire) NEW YORK, Nov. 20.—Walter Merrill Hall of New York, the first former nationally ranked player to be elevated to the presidency of the United States Lawn Tennis Association in 11 years, and four fellow officers were renominated today to govern the U. S. L. T. A. for 1935.

Boxing Board Heatedly Debates Changes In Fight Scoring System

By Guardian's Special Wire) NEW YORK, Nov. 20.—A baffled boxing board, the New York State Athletic Commission, today wearily surveyed the wreckage of what was once a fairly sound system of judging prize fights and at the end of hours of argument and discussion wound up exactly where it started—nowhere.

Brig. Gen. John J. Phelan, chairman, wants to retain the present combined system of point scoring and round awards, despite a rising tide of bad decisions that reached its crest last Friday in Madison Square Garden. Bill Brown, his militant associate, wants to amend the present complicated code, do away with the two judges, and return to the old idea of a single referee in full charge of proceedings.

As a result they compromised and decided to ask the New York State Legislature to amend the state rules so that a referee's vote counts the same as that of a judge when there is a disagreement; a best two out of three idea. At present the referee makes the final decision when judges disagree. No one has any idea what they will do with the subject.

Almost without variance in major fights through the past year, storms of controversy have followed the decisions. The night Max Baer tore Primo Carnera to shreds, the cards of the officials had Carnera as the winner. It was the challenger finally stopped him in the 11th round.

Both decisions in the Barney Ross-Jimmy McLarnin series brought roars of protest. Last Friday night Sammy Fuller, Boston lightweight, knocked out Pete Jackson of California down three times, beat him apparently all the way, and still lost the decision.
