ZION CHURCH HONOUR ROLL UNVEILED.—An impressive and most interesting service was held last night in Zion Church, when the congregation's Honour Roll was formally unveiled. After the preliminary exercises, conducted by the pastor, Rev. J. D. McKenzie, the Roll was unveiled by Mr. J. T. McKenzie. On it are inscribed the names of 118, including several nursing sisters, all sons and daughters of the church, who had enlisted at home or in some of the other provinces. Mr. W. P. Huggan, on the pastor's invitation, read the names to the congregation. Consul Pierce, who was present by invitation, gave an inspiring and eloquent address on the great cause in which Canada and the United States were jointly engaged. He complimented the congregation on its very creditable record in recruiting as shown by the honor roll. A pleasing feature of the service was the singing of the Recessional by Mr. Charles Earle.

AT THE POLICE COURT.—Saturday was automobile day at the Police Court. One case was that of Sheriff Dougan vs. W. A. Gaudin, in which the latter was charged with operating a motor car on the Hillsboro Bridge. The defendant admitted that he pushed the car over and drove it back, and some other evidence was taken. Another case was that of Geo. W. Gardiner vs. Earl Grant in which the defendant was charged with operating a motor vehicle without a license. There was also the case of Gardiner vs. Richard Grant. A trial connected with ring run over by an auto. The three cases were adjourned until the killing of plaintiff's dog, by beagle July 7th. An assault case of Effie Joseph vs. Edmund Egan was adjourned for a week. On the previous afternoon three boys were tried for breaking into the warehouse of Mrs. Mary Sumara on Upper Queen Street. Jack Weatherbie, aged 17, was sentenced to three months in jail and Joe Knight 16, to two months. In the case of Fred McKinnon, 13, sentence was suspended for six months. From the warehouse sixty-one pounds of rubber was stolen which they, the boys sold and got \$3.10 for it. Three weeks previously they made a visit to the place and took bottles and rubbers for which they received \$2.25. The need of a reformatory instead of a jail for such boys as these is very manifest, and it is to be hoped that some such provision will soon be provided.

Although not unexpected, news of the death of Mr. Lorne R. Unsworth was received by citizens yesterday morning with a shock of pain. Called in his prime, in the prime of a splendid manhood, called from wife and little children and from a host of friends, his death is peculiarly sad. He was a man of more than ordinary physical strength, a trained athlete of only a comparatively few years ago and a winner in many a well contested event. Of his winnings and his championships in the field of athletics there are many evidences in the shape of cups, medals and other trophies, but there are testimonials that will be more highly valued than these, the testimonials of those who competed with him that he was one of the "white men" that ever entered a contest. And as he was clean in his sports he was clean and square in the game of life, honest, manly and upright, a citizen of irreproachable character, a loving and devoted husband and father. Up to only a month ago he enjoyed apparently perfect health, when he became ill and went to the Prince Edward Island Hospital for treatment. The disease developed rapidly despite all that medical skill could do for him. Dr. Archibald, one of Montreal's most noted specialists was called in consultation, but nothing could be done for him and he sank gradually till the end came. The deceased was 39 years of age; He was a son of the late Mr. Joseph Unsworth at one time Chief Superintendent of the P. E. Island Railway. For the past thirteen years he was an engineer in the Marine Service, serving on the winter steamers Stanley and Minto and later on the Car Ferry, Prince Edward Island. There are left to mourn his widow, formerly Miss Carrie Saunders, daughter of Mr. John Saunders, City, and four daughters; also two sisters, Mrs. Arthur W. Weeks and Mrs. C.H.B.
