

ELECTION TRIAL IN 1ST DISTRICT KING'S

Some Persons Wanted as Witnesses Ordered to Appear. Mr Mabon Produces Books. Various Facts Brought Out as to Election Doings. More Coming Today.

SOURLIS, April 21—(Special)—The Court opened at 10.15 this morning, the attendance being by no means as large as on the previous day, though later, the number of those present was greatly increased.

The next business taken up was the absence of the witnesses who failed to appear yesterday afternoon. Mr. Mathison petitioned the Judge for an order for F. R. Heartz, after some little talk an order was given. H. J. Mabon's examination was then continued by Mr. Morson, he (the witness) having brought his books in to court. He stated under oath that he had about \$500 worth of liquor on hand between Oct. 16 and Nov. 18 of 1908. That is, he bought \$738 worth of liquor, but it was not all in the store at the same time. It would be very hard to state, how much cash

he had taken in, as the certificates prior to a recent Prohibition case, in which he had been fined, had been destroyed. On being pressed he admitted that the liquor sold during the election month, outside of that sold by certificate amounted to about \$200. The amount sold on certificate reached about \$300. Drafts were produced by witness or Mr. Morson's request, which witness claimed covered all transactions. The drafts were all carefully gone over and finally a new difficulty arose, from the witness having forgotten his bank book. He was dismissed in order that he might obtain this and other documents.

Mr. McMillan, Manager of the Royal Bank, Charlottetown was the next witness and was examined by Mr. Mathison. His statement was as follows:

I attended a public meeting in Sourlis during the last election, about a week before the election took place. After the meeting, I met F. R. Heartz in Cox's Hotel, also J. J. Hughes and S. P. McDonald. There was absolutely nothing said about the coming election except in a general way. Mr. McDonald, during that night said absolutely nothing to me about campaigning for him. I did not finance the campaign myself in any way.

William Brown, was then called by Mr. Mathison, his testimony being as follows:

I know Mr. Creamer of Sourlis. He wanted me to vote for his party, McDonald and Heartz. He offered me three bottles of brandy and some sashes if I would vote for these men. I took nothing but one bottle of brandy. That was the day before the election. L. McDonald spoke to me at my own place about a month before the election, but made me no offers whatever.

Cross examined by Mr. Johnston. I never promised to vote for Mr. Creamer's party as I never turn my color. Mr. McLean never canvassed me or no one else ever canvassed me to vote for him or Mr. Kiekham. I saw Mr. Kiekham about a week before the election. We just had a drive but nothing to drink. I was home all election day and saw no canvassers. I never at any time asked Mr. Creamer to get a certificate for me. The witness was then dismissed.

Mr. Mabon having brought his books as required into Court his examination was resumed.

He admitted having lost some important records and most of the facts that he deduced from his bookkeeping

GRAND TRUNK HELD MEETING

Sir Charles Wilson Takes Cheerful View. Wants Borrowing Power Enlarged.

LONDON, April 21—(Special)—The semi-annual meeting of the Grand Trunk Railway of Canada was held today.

Sir Charles Rivers Wilson, President, took a hopeful view of the situation.

There was abundant evidence he said of steady improvement in business, even if not so rapid as desired. Before next meeting he expected to have to attend the inauguration of 1,250 miles of new line from Edmonton to Fort William, the most important section of the system.

He declared the shareholders would be asked to approve a bill before the Dominion Parliament enlarging the borrowing powers and increasing the capital of the company to meet the ordinary growth of capital and expenditure.

RUSSIAN ARMY NEAR TO PERSIA

Is Halted by an Armistice. The Persian Nationalists Meet With Loss.

TIFLIS, April 21—(Special)—General Sharke who commanded the Russian punitive expedition to Jaffa in 1908 has been designated to read the proposed Russian expedition into Persia.

This expedition has been organized at the suggestion of Great Britain for the relief of foreigners at Tabriz. The departure has been postponed on account of the armistice granted by the Shah.

The vanguard is now camping near on the frontier, in instant readiness to march.

The expedition will be accompanied by a detachment of artillery, engineers and field telegraphers.

The Tabriz Nationalists lost sixty men killed and 100 wounded in a sortie from the city in which H. C. Baskerville an American school teacher, lost his life.

The armistice was arranged by the Shah for the purpose of bringing in provisions and is not regarded with enthusiasm, as the absence of transport makes provisioning most difficult.

YOUNG TURKS ASSIST SULTAN

Their Army Reaches City Borders and Negotiations Going On. Serious Troubles In Syria.

CONSTANTINOPLE, April 21—(Special)—The advance guard of the Constitutional army has arrived at the outskirts of the city.

The Cabinet met this afternoon and proclaimed martial law.

Administering the oath to the troops in garrison is proceeding in accordance to the demand of the Constitutionalists and the authors of the recent upheaval are being sought out and arrested.

A cabinet meeting was held to consider the proposals made by the army of investment.

It is believed there is an increasing probability of arriving at an understanding which may result in a reconciliation between the Young Turks and the Sultan.

It is declared in official circles that pourparlers between the Government and the Constitutional army promise a settlement.

The army no longer insists on the withdrawal of the present Ministry, and the re-installation of the Hilmi Cabinet, but maintains the demand for the punishment of the authors of the recent troubles.

Reports from the Syrian coast say that racial fanaticism is extended in the villayet of Aleppo.

Disturbances have broken out at Antioch and Birejek, and foreigners have taken refuge in the British consulates.

The British cruiser Diana has landed fifty men in Alexandretta. Sheik Ulliam Hedos has telegraphed the ecclesiastical authorities in Syria to exert every effort to put a stop to the disorders.

The civil and military powers appear powerless to effectually control the situation.

NIAGARA RIVER STILL BLOCKED

With Ice, Water Rising Bridge in Danger, Citizens Fleeing For Safety.

NIAGARA FALLS, April 21—(Special)—With the water rising a foot every two hours and pouring into the cellars and lower rooms of the Hotel Cornell at Lewiston, the guests deserted the hotel.

All the residents along the river have moved from their dwellings, fearing the flood.

The conditions are best understood by the fact that Queenston's suspension bridge, which ordinarily stands sixty feet above water, would be reached from the ice by a man stretching his hands up.

There appears to be absolutely no relief unless the ice at this point gives way, allowing the water an outlet to the lake.

The situation at Niagara-on-the-Lake is extremely grave.

The Michigan Central is removing goods from its store houses, and the residents of the whole town are getting ready to leave.

The water has risen twelve feet since yesterday morning and the whole lower town is in danger.

Lewiston bridge is also in danger, several piers which tied the bridge to the shore having snapped and a sudden move of the ice may carry away the structure.

HALIFAX, April 20—Dr. John Henry Elliott, one of the foremost evangelists in Canada and in the United States, was born in Ontario. He was engaged as secretary of the Y.M.C.A. in his younger days, building a two hundred thousand dollar Y.M.C.A. plant in Minneapolis. Dr. Elliott has also been one of the pastors of one of the leading churches in New York City, and a leader among the Christian Endeavor Societies of that state. He was associated with D. L. Moody, in the World's Fair campaign in 1893, in the Chapman meetings in the Boston campaign. Dr. Elliott and his associates took a leading part; God has wonderfully honored his services.

SHE WILL WED A JAP PREACHER

LOS ANGELES, April 20—An unexpected romance has entered into the life of Miss Kate Goodman, an American mission worker among the Japanese women and children in and around this city, and Rev. Joseph Kechichi Inazawa, pastor of the Japanese Presbyterian mission. As a matter of fact they have known each other for many years, but their friendship ripened into mutual admiration and now they are engaged to marry.

Mr. Inazawa was greatly surprised when he learned his secret had leaked out, but freely acknowledged the truth of the report. No date, he said, had been set for the wedding ceremony.

Inazawa has been a resident of this city for several years, during which time he has been in charge of the work of the Presbyterian mission. He is well educated and Americanized, and for more than twenty years has been engaged in missionary work on the Pacific coast with headquarters at San Francisco.

Miss Goodman is a resident of Moneta, a suburb of Los Angeles, where she conducts a night school for Japanese boys. For many years she has been a worker among the Japanese and has studied their language with the intention of going to Japan as a missionary. She is well educated and highly connected and was a student at the University of Chicago when she started a year ago for Japan. Inazawa is 45 years old and Miss Goodman a few months his junior.

WINTER BOATS FAR FROM COMFORTABLE

ST. JOHN, April 21—J. J. Olive, Dominion Inspector of Hulls, in an interview tells the Standard that during the trip which he has just completed he had an interesting time in travelling the Straits of Northumberland. He spent a week in the ice during the trip, the boat being held up four days on the trip over and for another two days on the return.

"We were stuck in the ice before we had steamed two miles out of Pictou harbor," said Mr. Olive. "We found it impossible to proceed, and so the boat was put about and we returned to Pictou for a supply of tobacco. The captain knew by the weather signs that our stock would be exhausted by the time we made the 'Garden'."

The inspector characterizes the accommodations on the Stanley and Minto as wretched. "If I was called upon to pass them for passenger carrying purposes," he said, "I would not allow them the right to take more than twelve at the most, at least while they are making their winter trips."

"One of these boats has staterooms for ten people and the other for four. The management will, however, accept any number of passengers, and care little how they fare on the long and tedious trips. I had to accommodate myself on a sixteen inch bench during the four weary nights of the trip."

"If you can imagine a man of my bulk sleeping in that space, you will not wonder that I fell on, nearly broke my nose, and blacked both of my eyes. The worst of it was that the cook aboard the steamer wired the news to St. John, and when I got there a telegram was awaiting me from home asking about my injuries."

Mr. Olive said that the Stanley was in extremely poor shape for the work she is doing.

SAD ACCIDENT AND DEATH.

EAST PROVIDENCE, April 21—While rushing to the aid of her little daughter, whose clothing had caught fire, Mrs. Sallan Clinton fell to the kitchen floor dead. The fire on the child's clothing was extinguished by an older daughter.

When the father reached home, after being hurriedly summoned, he was prostrated. The girl was burned about the face and arms.

The death of the mother was caused by congestion in the lungs, brought about by sudden fright. The girl will recover.

SEVERE EARTHQUAKE SHOCK.

MEXICO CITY, April 21—A severe eruption of Colima Volcano, followed by an earthquake shock, has spread terror and confusion among the inhabitants of nearby towns and villages.

A number have deserted their homes and have gone to points outside the infected zone.

ADMITS THAT SHE HAS THREE HUBBIES

WOODSTOCK, Ont., April 20—Elizabeth Davis, a middle-aged woman, was brought to the County Jail last night from Richmond charged with bigamy. Mrs. Davis was married over twenty years ago to Charles Davis, now living near Tillsonburg. Eleven years ago it is said, she discarded Davis and married Fred Rogers, and lived with him several years. Last February she launched on her third matrimonial venture, and it is charged she went through the form of marriage with Martin Cronkright, knowing that her original and second husbands were both living. When County Constable Dobson went out to arrest the woman she was found with Cronkright and eight young children living in the poorest of quarters. They had one bedroom in which ten people slept. There was absolutely nothing in the house in the way of provisions save one dozen turnips, and, according to the children, the family have been living on turnips for some time.

The woman admits her guilt, claiming in extenuation that her husband also married again before she did.

A direct line of steamers will run from Bay D'Espoir to New York.

HALIFAX, April 20—Not the least interesting of the results being achieved by Dr. Alexander Graham Bell in the world of science are those having to do with agriculture. For some years Dr. Bell has devoted a considerable portion of his time to the sciences, and the results attained have more than amply repaid him for the money and labor spent.

The development of a breed of sheep of unusual propagating powers has engaged his attention for some time back. By a process of selection Dr. Bell has now rearing about his headquarters at Beinn Breagh a flock of sheep the ewes of which rejoice in the possession of six nipples in place of the orthodox two. TROOPS SURROUND TURKISH CAPITAL.

CONSTANTINOPLE, April 21—Sultan Abdul Hamid is awaiting in the Palace for whatever may befall. He has not taken to flight and the Grand Vizier, Tewfik Pasha, has announced that, without fear, the Sultan will remain with his family and accept any fate which has been prepared for him and his country. Tewfik Pasha, and Minister of War Edhem Pasha, who sent in their resignations decided to withdraw them to day and the Grand Vizier is spending most of his time with his Majesty.

Nazim Pasha is still in command of the Garrison, but no preparations have been made to offer any resistance to the advance of the Saloniki troops.

The Constitutional lines now enclose the city, but Commander-in-Chief, General Husni Pasha, is still at Hademkozi and there is little likelihood that the invading army will enter the city before night.

FRENCH CANADIAN RENAUD WINS BOSTON MARATHON

BOSTON, Mass., April 20—No Greek the open door of a furnace blew on runner ever gained the laurel crown the seven score of runners, as, stripped under the torrid conditions in which he competed to gymnasium costumes they lined up in six rows for the start.

Renaud was the 25th runner to turn into the boulevard, the half way mark, and begin the climb up the long hill.

His hill proved a heart breaker for many a runner, many of those who survived it succumbed to the longer incline three miles beyond. The running up these two hills was a grueling one, but the strength of endurance of the French-Canadian seemed to stand it better than any of the other competitors, and when the top of the reservoir hill was reached Renaud was in third place and settled gamely to his task of overhauling Grant and Jensen. Jensen was nailed on the way to reservoir from Coolidge Corner and the pair overtook the fast tiring Grant at that point.

From Coolidge Corner to the finish the course was a two-mile corridor with human walls. In the last mile Renaud was cheered at every step and as he scudded around the corner of Exeter street, and saw the glimmer of the red yarn at the finish, 2,000 people acclaimed his coming and threw up their hats as he broke the thin red line. Renaud was so fresh at the finish that he made the last hundred yards like a short distance runner and walked jauntily into the club house, where he received a beautiful silver bowl as his emblem of victory.

Renaud is a member of the Montcalm Athletic Club of Nashua and is 20 years old. He is employed as a weaver at the Nashua Manufacturing Company's mill and his first long-distance effort was in a Marathon run at Manchester, N. H., a year ago.
