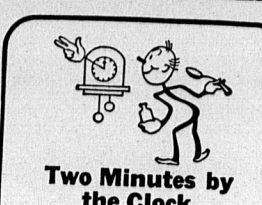

"John Buchan" Has Gone Home

Ashes Of Late Governor General Of Canada Return To His Homeland.

OTTAWA, Feb. 26—The funeral urn containing the ashes of Lord Tweedsmuir, late Governor General of Canada, has arrived in England. It was borne across the Atlantic by one of the British cruisers on the same time conveyed to the latest Contingent of Canadian fighting men overseas. In that company were many men who, a few weeks previously, had passed before the gallies of the Admiralty. Then he stood at salute to face them. On this occasion they saluted him in death.

The ashes will await the arrival of the latest Contingent of other members of the family in England before they are taken to the last resting place.

Who had entered the respect and affection of his citizens was all moving because of its simplicity. At Montreal the urn was placed on a special car. Former Defense Minister Discusses Canada's War Effort

VANCOUVER, Feb. 26 (CP)—Manpower requirements of organizations already created for Canada's war effort were the equivalent of "more than five army divisions," Hon. Ian Mackenzie, Minister of Pensions and National Health, said today in an address over the national network of the Canadian Broadcasting Corporation.

The former Defense Minister, charging that "those who seek for political reasons to belittle Canada's war effort do not give you the whole picture," said that "in the last war we maintained four divisions in the field."

Canada already had two army divisions completely formed, one overseas and one in Canada, he said. In addition, there were half a division, who have also gone overseas.

Naval and air force men already on active service in Canada were equal in numbers to a third army division, he said, and added: "The maintenance personnel of the air training (the Commonwealth Air Training scheme) will require the equivalent in numbers of two more divisions—making the manpower requirements of organizations already created for the equivalent of more than five army divisions, not counting home defence forces and any further troops to be sent overseas."

The former Defense Minister termed "completely erroneous" statements that the Canadian government refused Great Britain permission to establish the air training scheme several years ago.

The Hahn Contract for Bren Guns

THE CHARGE: Awarding the largest contract yet placed in Canada by the present Government without competition to a group consisting of a stockbroker, the brother of a member of Parliament and a promoter who had no experience in the production of small arms and was not equipped to produce them.

Awarding a cost-plus contract which purported to limit profits payable under the contract but actually did not.

Awarding a contract which made profiting in the shares of an arms company possible.

Misrepresentation by Mr. Mackenzie to the House of Commons of the nature of the contract and the promoter's pre-contract relations with the Government of Canada.

Misrepresentation to the British War Office of the status of a contractor endorsed by the Government of Canada to the exclusion of all others.

MR. MACKENZIE'S DEFENSE: (a) "I have never been prouder in my life than tonight when I say that I accepted them and I accept now the full responsibility for that contract."

(b) The company had been criticized as "inefficient" but "it will be known seven days after the Dominion election that the completed guns in April 1940—at least six months ahead of the three specified in the contract."

(c) Mr. Justice Davis reported that there was no evidence of "corruption."

(d) Mr. Justice Davis reported: "The facts are all in evidence. I cannot recall any fact to which direct proof was adduced that is in dispute."

"There are adequate powers of inspection, supervision control vested in the department under the contract and, if they choose, vote as civilians."

Supervision of Vote

Military authorities will supervise casting of ballots in barracks and camps. An active service elector provided with official nomination will be in the name of the candidate of his choice. The ballot after receiving the ballot from a commissioned officer designated to carry out the duty by the officer commanding.

The voter then will insert his ballot paper in an envelope and seal it. This envelope will be enclosed in an outer envelope upon which is a declaration of identity and address of the voter. The special returning officer for the military voting section.

This outer envelope postage paid and properly certified by military authorities, is mailed to the special returning officer for the voter's active service section, who at his headquarters supervises the placing of these outer envelopes into 243 ballot boxes, one for each constituent in Canada.

Once returned to the special returning officer and the vote must reach him by the deadline, six o'clock on the day of the voting. The day—the vote, identified by the name and address on the outer envelope, is placed in the ballot box containing the given address. The active service voter is scheduled to attend at 9 p. m. local time on the Saturday (March 23) preceding polling day (March 26).

Sorting Takes Time

Jules Castonguay, chief electoral officer, in explaining the system whereby ballots will be sorted by civilian voting officials, as received, instead of waiting until the whole active service vote has been taken said it was this point which formed the basis of the delay.

"It is the sorting, not the counting, that takes the time," he said, "and it has been arranged for the sorting to be progressive as the ballots are received by the special returning officer and staff."

"Nothing in the declaration on the outer envelope as for the voter to get his address in Canada right. Then civilian authorities can get the constituency right. And of course the soldier must vote in the candidate running in the constituency containing his given address. Otherwise it is a rejected ballot."

Overseas Voting

Four special returning officers will handle the active service vote, Lt.-Col. John Thompson of Ottawa, will be in charge of the active service vote in the United Kingdom. Aided by an assistant, a secretary and six scrutineers, all from Canada, he may have several other clerical assistants if necessary.

His headquarters, where the vote abroad will be sorted and counted, will be in Ottawa, Canada itself. It has been divided into three sections for the taking of the active service vote.

Special returning officers superintending sorting and counting in Halifax, Prince Edward Island, New Brunswick and Nova Scotia; in Ontario, Mr. J. W. McEwen, in Alberta and in Edmonton for Saskatchewan, Alberta, British Columbia and the Yukon.

After the count has been taken at these headquarters, the tally is forwarded to the chief electoral officer, Mr. J. W. McEwen, by April 2. Mr. Castonguay has to have it in the hands of the returning officers for the various constituencies.

An attempt will be made to get the names of candidates in the various provinces on their affiliation, but the election machinery itself provides many of the details available to each unit, from which voters may figure their constituencies and a list of candidates in various riding, their addresses and occupations, but no political affiliation.

Royal Canadian Scale Of Pay

OTTAWA, Feb. 26 (CP)—Scale of allowances payable to Royal Canadian Navy personnel dependent was announced tonight in the Canadian Gazette.

Heretofore, allowances for dependents of commissioned ranks of the Navy were not payable. Henceforth, an officer's wife will be entitled to \$1 a day, \$1.25 if she has one child, \$1.50 if she has two children, \$1.75 if she has three children, and \$2 if she has four or more children.

Wife of a naval rating is entitled to 75 cents a day, \$1 if there is one child, \$1.25 if there are two children, \$1.50 if there are three children, and \$1.75 for four or more children.

Allowances for motherless children begin at \$1 a day for an officer's child and \$1.25 for a rating's child, increasing 25 cents a day for each additional child until the limit of four, which rate is \$1.75 for officers and \$1.50 for ratings.

Other forces are contingent upon a pay assignment to the dependents from the pay of the officer or rating. The pay assignment must be at least 15 days pay in the case of a wife or five days pay for each motherless child.
