## OBJECT LESSON FOR CANADIAN DELEGATES

### Montreal Steamer Laden With Hund- reds Of Tons Of Can- adian Goods Arrive At Hamilton, Ber- muda.

HAMILTON, Bermuda, May 5—  
(Canadian Press Cable)—The future  
possibilities of trade between  
Canada and Bermuda as part of  
Empire and international commerce  
were brought home to Canadian  
delegates at the parliamentary  
trade conference here today as the  
steamer Cavalier from Montreal ar-  
rived at St. George's, laden with  
hundreds of tons of Canadian  
goods.  
The British and Canadian groups  
were at picturesque St. George's  
when the Cavalier steamed into  
harbor in morning sunshine which  
made the island appear an Eldorado  
in reality. Beneath her hatches  
were hay, bran, oats, rye, flour,  
lumber and rye whiskey. Though  
limited in quantity and variety, this  
Canadian merchandise was regard-  
ed as a tangible example of what  
could be achieved in greater meas-  
ure through commercial co-opera-  
tion between the countries.

## Lieut. Massie Is Ordered To Another Station

WASHINGTON, May 5. (A.P.)—Obviously intent upon concluding the Fortescue-Massie slaying case, Charles F. Adams, Secretary of the United States Navy, today said no disciplinary action would be taken against naval personnel involved and Lieutenant Thomas H. Massie was ordered to another station.  
Plans in Congress to give legislative relief to the four persons convicted of slaying an Hawaiian caused of attacking Massie's wife meanwhile were allowed to rest.  
The House of Representatives judiciary committee indefinitely postponed action on bills to grant pardons to the four whose 10 year sentences were commuted to one hour by Governor Judd of Hawaii and took no action on the Binham Bill to prevent two hung juries in Hawaii from operating to acquit defendants. It was designed to prevent three other persons charged with the attack on the officer's wife from going free.

## CONFERENCE NO PLACE FOR BARGAINS

## Make Get-Away

SAINT JOHN, N. B., May 5—(By the Canadian Press)—Three prisoners of the County Jail, William R. Donaldson, 33, ex-convict of Dorchester Penitentiary; William Leeger, 21, and Arnold Hansen, 27, succeeded in a dash to freedom today. At midnight they were still at large. While a turnkey left them to answer the doorbell, the three forced a window and climbed over a fence. They were last seen at Westfield where members of the Royal Canadian Mounted Police learned they had begged a meal.

## \$50,000 Fire

COBDEN, Ont., May 5—(By the Canadian Press)—Threatening at one time to wipe out the entire business section, fire today destroyed the Tuffy general store and four warehouses with a loss to the buildings and stocks of \$50,000. Pembroke's fire department came 25 miles to assist in controlling the blaze, which originated in the general store.  
The combined fire forces of Cobden and Pembroke saved the Bank of Nova Scotia building with great success.

## DOUKHOBORS THREATEN TO QUIT LANDS

YORKTON, Sask., May 5—Peter P. Veregin, head of the Doukhobors in Canada since the death of his father, was this afternoon convicted by a jury here on one charge of perjury. Two other similar charges were withdrawn and he was acquitted on one charge. Sentence will be pronounced Friday morning.  
Veregin, who has a following of 15,000 in this country, was convicted of committing perjury by swearing at the preliminary hearing of George Chutskoff last January, that he was absent in British Columbia for seven months prior to March, 1929. Evidence was given to disprove this statement by a doctor and nurse who attended him in the late fall of 1928.  
Following conviction, J. A. M. Patrick, K. C., defence counsel, read a wife he received from Doukhobor settlers at Benoit, Manitoba, threatening to quit their lands if their leader was convicted, and asked Mr. Justice D. MacLean to take this into consideration when passing sentence.  
NELSON, B. C., May 5—(By the Canadian Press)—Eighty-four Doukhobor men were sentenced to three years in the penitentiary this afternoon after pleading guilty to parading in the nude at Thrums last Sunday.

## Woman Will Be Deported

PORTLAND, Me., May 5—Deportation faces Mrs. Madeline E. Nelson, 46, Haynesville, and a native of Kingston, N. S. Tomorrow she will be released from the women's reformatory at Skowhegan, where she has served a two-year sentence in connection with the slaying of her husband at Haynesville in 1929. At the trial she pleaded guilty of manslaughter.  
Samuel H. Howes, immigration director here, said today Mrs. Nelson would be deported to Amherst, N. S.

## Pulp Fire Now Under Control

PORT ALFRED, Que., May 5—(Canadian Press)—Authorities and fire fighters began to breathe a little easier here today. The fire which has been raging through an immense pile of 250,000 cords of pulp wood since last Friday was beginning to assume controllable proportions, thanks to a flood of water being poured into its heart from automatic pumps on board the dredge General Montclair.  
Danger of a conflagration in the village which might sweep the mill of the Port Alfred Paper Company was not entirely over but it was believed that should the present wind conditions last and nothing go wrong with the pumps, then the fire would be well past the danger mark before the week-end.

## A QUESTION FOR SENATORS

The attitude of Liberal Senators on the Beauharnois motion is thus summed up by a disgusted reader in the Toronto Globe, leading Liberal newspaper, of May 3:  
To the Editor of The Globe: "Let him who is without sin cast the first stone." We on this side shall not disown our colleagues," was the reported dramatic concluding sentence of Senator Dandurand in the Senate in defense of the Senators accused of misconduct in the Beauharnois scandal.  
Then the Senator and his Liberal colleagues voted against censure.  
The fair implication is that the Senator confessed to some sinful acts on the part of himself and of those who voted with him. He and they felt that they were not without sin, and that they could not consistently condemn sinners. They did not say that they refused to vote the censure because sin was not made out, but that they refused to vote because they themselves were not sinless. Now is the time for confession. In what respect have they erred? Have they been so bad as to feel that they ought to resign? Or do they set up the contention that, no matter how bad they may be, they are good enough for the Senate?  
What a prospect this sort of argument opens up! Henceforth the question is not to be, Is the accused guilty? but, Are the Judge and jury sinless? Not, Has the offense charged been committed? but, Have undiscovered offenses been committed by others? Every person accused of crime will hereafter be able to point to Senator Dandurand's eloquence in support of the contention that no sinful Judge may properly preside at his trial, and that before a jury can be sworn in it is necessary that the career of each jurymen in the box shall be carefully inquired into. If such standards are set up, criminal trials in this country will be more protracted than in the United States of America.  
Seriously, though, it is amazing that men who have grown to the age of Senators should place themselves upon record as setting up, not that accused persons are guilty or innocent, but that the tribunal which hears the charges is guilty of unconfessed sins, and, therefore, should not sit at all.

## SUCCESSFUL OPERATION ON ENGLISH PREM.

LONDON, May 5. (Canadian Press Cable)—Prime Minister Ramsay MacDonald tonight was resting in a London nursing home after a successful operation for glaucoma on his right eye this afternoon. The operation was almost a duplication of one performed four months ago on his left eye.  
Glaucoma is an ailment resulting in painful tension of the eye muscles and, if not remedied in time, results in serious diminution of vision and eventually in blindness.  
The Prime Minister's physicians, however, said he was in no danger of losing his sight, although as a result of today's operation he will be incapacitated for about six weeks. His general health was described as excellent.

## THE SINO-JAP TRUCE SIGNED ON SICK BEDS

### Two High Japanese officials Affix Sig- natures While Re- cuperating From Recent Bomb Out- rage.

SHANGHAI, May 5. (A.P.)—The Japanese high command announced tonight that evacuation of the troops that fought the battle of Shanghai already had been ordered in accordance with the terms of a formal armistice signed earlier in the day by emissaries of the Chinese and Japanese governments.  
The signing of the truce was a most unusual procedure. It was necessary to carry the documents to two sickbeds. Mamoru Shigemitsu, Japanese Minister, affixed his signature in the hospital where he has been a patient since the sanguinary Hongkew bombing last week—and a short time after he had written his name he was taken to an operating room where one of his legs was amputated.

## May Have Been Taken For Ride

TORONTO, May 5—(By the Canadian Press)—Mystery surrounds the whereabouts of Arvo Vaara, Editor of the Finnish Daily Vapaus at Sudbury, and Martin Parker, translator. The two men were arrested when police raided the newspaper office yesterday, bundled into a large automobile with five plainclothesmen, and the car left immediately, heading south.  
Today the Royal Canadian Mounted Police at Ottawa said the raid was carried out by the provincial police, while the Ontario provincial police headquarters here said they "had no report."  
"Have you any idea where the men were taken?" Inspector Alfred Cuddy of the provincial police, was asked by the Canadian Press today.  
"Not the slightest. We have no report on them," he replied.

## Want Discharge

WINNIPEG, May 5. (By the Canadian Press)—Application for discharge from custody of Dan Holmes, Orton Wade and Conrad Cessinger, three alleged Communists, was argued before Chief Justice W. A. Macdonald today and decision was reserved for two or three days.  
"The matter is much too important for an off-hand decision." His Lordship declared.  
The three were arrested Monday on warrants issued by the Deputy Minister of Immigration at Ottawa, and are now detained at Halifax, N. S. detention shed.

## Gave Evidence From Court Door

WINDSOR, N. S., May 5. (By the Canadian Press)—Charged with breaking and entering the Supreme Court here today, William Whiting said a sweater entered as an exhibit, and claimed by crown witnesses to be the property of a burglarized store, had been given him by Clifford Sweet. Sweet, wanted as a witness, was found to be quarantined with mumps. The impasse was ended when he was brought to the courtroom and gave evidence from the door, far enough from Judge, jury, lawyers and spectators to obviate the danger of infection. He had never seen the sweater, he said. Whiting was convicted.

## Former U.S. Dept. Of Justice Agent Is In The Toils

WASHINGTON, May 5—Gaston B. Means was arrested today by Department of Justice agents who charged he had obtained \$100,000 from Mrs. Edward B. McLean, wife of the Washington Post publisher, on representations that he would recover the Lindbergh baby.  
Means, a former United States Department of Justice agent, has served a penitentiary term for accepting a bribe and for conspiracy to violate the prohibition laws.

## Sounds Alarm

WASHINGTON, May 5—(By Ken Clark, Canadian Press Staff Writer)—Alarm was sounded in the United States Congress today by President Hoover and Senator William E. Borah, chairman of the Foreign Relations Committee.  
Declaring "uncertainty is disastrous," the President said fear prevailed in the country because of events in Washington which "greatly disturb the public mind." He demanded prompt action on the revenue and economy bills to balance the budget and repair the finances of the United States.

## Suit Dismissed

HALIFAX, N. S., May 5—The suit for \$10,907.50 brought by Kemel Kahn, former "under cover" worker for the preventive service, against A. T. Logan, former preventive division chief, was dismissed in a supreme court decision handed down today. Kahn claimed the amount for expenses and services covering a period May to December, 1930.  
Inspector Logan is now a member of the R. C. M. P.

## U.S. SUPPLY BILL SLASHED BY MILLIONS

### 2,000 Officers Cut Off Active Military List.

WASHINGTON, May 5—(A.P.)—Slashed by many millions under President Hoover's budget estimates, the last of the big regular supply bills for 1933—that for the War Department—was reported to the United States House of Representatives today by its appropriation committee.  
Cutting 2,000 officers off the active list and making other sweeping reductions, the measure carries \$386,983,000 for maintenance of the army and its non-military activities.

## New York Hockey Coach Resigns

NEW YORK, May 5—Eddie Gerard, coach of the New York Americans of the National Hockey League, resigned today, it was learned from an authoritative source.  
With the report of Gerard's resignation rumors flew thick and fast in local hockey circles. One had it that Frank Patrick, brother of Lester, coach of the New York Rangers, would take over Gerard's post.  
The New York Times will say tomorrow Gerard is considering an offer from his old love—Montreal Maroons. There is also a possibility that Sprague Cleghorn, who coached the Maroons last season, will replace Gerard here.

## Stevens Honoured

VANCOUVER, May 5. (By the Canadian Press)—The honorary degree of Doctor of Laws was conferred upon Hon. H. H. Stevens, Minister of Trade and Commerce, and E. B. Paul, former principal of Victoria College, Victoria, at the annual convocation today of the University of British Columbia.  
Two hundred and ninety three students received degrees.

## The Waterway

WASHINGTON, May 5—(By the Canadian Press)—Hon. W. D. Herridge, the Canadian Minister, was in conference with Assistant Secretary of State, James Rogers, here this afternoon on the St. Lawrence waterway and other matters. It is understood progress was made.  
Emergency measures to get ratification of the waterway treaty if and when signed, are to be considered by administration leaders in the Senate.
