### New Goodwill Scholarship For Final Year Meds.

(Queen's Journal, Kingston, Ont.)

Mrs. Florence M. Goodwill of Charlottetown, Prince Edward Island, has just established at Queen's University a second endowment in memory of her husband, the late Lieut.-Colonel Dr. Victor Lyall Goodwill.

A year ago Mrs. Goodwill endowed the Victor Lyall Goodwill Memorial Prize of the annual value of \$100 awarded in sixth year medicine to the student who submits the best essay dealing with some aspect of mental health or disease. The new foundation is for the Victor Lyall Goodwill Memorial Scholarship in internal medicine. It also has an annual value of \$100. It is awarded at the end of the fifth year and is tenable in the sixth year. Mrs. Goodwill has generously added to the endowment a sum sufficient to make possible the first award at the end of the present session.

Mrs. Goodwill who was the daughter of the late Paul Reid, belongs to a well known Kingston family. She has two brothers and a sister in Kingston whom she is

now visiting. Her husband's father, Rev. John Goodwill, was a student at Queen's in Arts and Theology from 1838 to 1839 and was for many years a missionary in the New Hebrides. Three sons are also Queen's graduates, Edward, who later practiced law in Peterborough, Thomas, who is now a minister at Hillsburgh, and Victor Lyall who graduated in medicine in 1899.

Dr. Victor Lyall Goodwill was a brilliant student who achieved very high rank in his profession. He was a medical superintendent of Falconwood Hospital, Charlottetown, for 25 years, not including the period of his war service. He retired to private practice in 1927 and died in 1935. He was buried in Cataraugus Cemetery. An editorial in a Charlottetown paper at the time of his death was headed, "A Beloved Physician."

It is a great satisfaction to Queen's University that the name of so distinguished a graduate as Dr. Goodwill should be kept alive by two memorial foundations.

LONDON, Feb. 2.—A man may erect a high tower in a field alongside a racetrack and with the aid of binoculars broadcast a running commentary on the race without being guilty of trespassing upon the rights of the track-owners.

Authority for this important and far-reaching ruling is no less than the Judicial Committee of the Privy Council. The decision occasioned great interest in view of the ever-widening possibilities of broadcasting and television.

The case arose in November, 1936, when the Victoria (Australia) Park Racing Club applied for an injunction to restrain the Commonwealth Broadcasting Corporation from broadcasting races.

The Supreme Court of New South Wales dismissed the petition with costs, and the High Court of Australia in August, 1937, upheld the lower court's decision. The petitioners then applied for special leave to appeal the majority judgment of the high court (it was three votes to two) to the Privy Council. That body has now dismissed the petition.

The racing company's case was that the owner of adjoining land had erected a tower on the top of which was a platform from which anyone could see the race course and the information boards of odds, jockeys and post position within the track; and that the owner had permitted the tower to be used as a vantage point for a broadcasting company.

Counsel for the appellants admitted there was no right in an owner of land to be immune from being overlooked, but he did not consider it followed that there was therefore a right of unlimited overlooking. He instanced as precedent a case where a dentist's contraption enabling him to see in the dentist's operating room.

Counsel for the defendants argued there was no substantial law on the issue of nuisance and that the broadcasting could not be said to be interfering with the use of enjoyment of the racecourse. The only effect was on people not on the racecourse.
