MONTREAL, Sept. 13.—Livestock for sale on two markets this morning amounted to 142 cattle, 230 lambs, 1213 hogs, 120 calves. Common bulls sold mostly around \$3.25 and common sows \$3.50 to \$4.25 and better kinds up to \$5.25. Good cows were quoted \$5.50 to \$5.75. Veal calves were very scarce, a few fair ones brought \$11.00 and \$11.50 and a half dozen good weaners \$12.00. Grassers sold mostly \$4.50 to \$5.50. Old lambs were quoted around \$10.25 flat or \$11.25 for ewes and wethers and \$9.25 for the bucks. Poorer quality lambs were from \$9.00 to \$10.00. Hogs were a shade stronger. Most sales were made \$10.85 to \$11.00 for good quality lots. Sows sold from \$7.50 to \$9.00.

OTTAWA, Sept. 13.—A force of two hundred men, under George Kydd, resident engineer, is busy at Port Nelson and on the Hudson Bay, reconditioning the floating plant there, preparatory to transferring it to Fort Churchill, according to an announcement, today, by Hon. G. A. Dunning, Minister of Railways. This activity is the first step to put into effect the declared intention of the government act immediately on the recommendation of Palmer, that the ocean terminus of the Hudson Bay Railway be transferred from Port Nelson to Fort Churchill.

Flag Question To Be Submitted To Referendum

CAPE TOWN, South Africa, Sept. 13.—In connection with the controversy in South Africa over the new national flag that has been proposed by the Hertzog government and which question is to be submitted to a referendum next January, Hon. F. W. Beyers, Minister of Mines and Industries, in an interview asserts that Gen. Jan Christian Smuts, former Premier and present leader of the South African party in the House of Assembly, advocated a Union flag in which the Union Jack did not appear when he was premier. Mr. Beyers however qualifies his assertion by saying: "Such as any reference was the spirit of his (Premier Smuts) utterances and suggestions, and so they were construed."

The Nationality and Flag Bill providing for a new flag that would be "distinctively South African, which was first introduced in the House of Assembly over a year ago by the government of Gen. J. A. B. Hertzog, Premier, then withdrawn and re-introduced in the Assembly a few months ago, was passed by the Senate and now, as stated, will be voted upon in a referendum in January, 1928. The actual date of the taking of the referendum has not yet been decided upon. The flag bill submitted to the South African parliament that the Senate rejected provided for the inclusion in the design a Union Jack occupying only one-sixtieth part of the whole flag, and this was a concession to the British sentiment in South Africa. As originally drafted the bill did not contain the Union Jack at all.

Hon. Mr. Beyers' statement as to General Smuts' attitude on the flag question a few years ago when the Smuts government was in power is somewhat surprising. During the controversy that has raged in the country since the first introduction of the flag bill last year, Former Premier Smuts has strongly opposed the bill because it made no provision for the inclusion of the Union Jack at first, and finally as revised, provided for a Union Jack that should occupy only one-sixtieth of the flag.

Hon. Mr. Beyers claims that the question of a flag for South Africa is essentially a domestic matter for the Union of South Africa itself to solve, and in this he is understood to be voicing the views of all the members of the Hertzog Government and the Government's supporters in the Assembly. Mr. Beyers points out that this fact was recognized as far as 1921. It was, he says, open secret, and admitted by General Smuts, who was then Prime Minister, and who later reduced to writing important proposals or suggestions on the status of a distinctive flag for the Union of South Africa in connection with the Imperial Conference of 1921, although General Smuts did not actually make those proposals formally.

It being a purely domestic question, Hon. Mr. Beyers says, it can not be expected that South Africa should take the flags of the Dominions as precedents. The circumstances of South Africa, with its two prominent white European races sharply in conflict with one another in the past, were entirely different from those of Australia and New Zealand, with their homogeneous communities, and whatever might be the opinion in Canada regarding the Canadian flag the Union of South Africa must settle the flag question itself.

The Dutch people of South Africa, especially those born under the Free State and Transvaal flags, Mr. Beyers says, have never really recognized the Union Jack, and although the Union Jack has flown in the old colonies of the Cape and Natal there has never been any formal decree or statutory provision to this effect. The Nationality and Flag Bill, passed into law, will be the first statutory recognition in South Africa of the Union Jack. Mr. Beyers says, and the whole law moreover will be the result of the January referendum if it is favorable to the Government's bill. Benny Bass Is Feather Champion

PHILADELPHIA, Sept. 13.—In a sensational ten-round match which almost ended in a simultaneous knockout in the ninth round, Benny Bass, of Philadelphia, battered his way to victory tonight over Red Chapman, in a bout that carried with it recognition by the Pennsylvania State Athletic Commission as featherweight champion of the world.

Coming out of their corners in the ninth round with a furious rush both connected solidly with lefts to the head. Both reeled back and tumbled to the floor, Chapman in the centre of the ring and Bass along the ropes. But Benny recovered quickest was on his feet in a second or two while Chapman rested on one knee and took a count of eight.

Bass himself seemed groggy, but he leaped back at his opponent with savage fury, forced him about the ring under a fierce barrage, and curbed another left to the head that sent Chapman to the floor again for a count of eight.

Chapman was all but out, reeling about and bracing himself on the ropes, but he managed gamely to weather the storm as Bass fought himself out in a vain attempt to score a knockout. Both were so exhausted from this thrilling round that they had little left, and spent most of the tenth and final round, clinching.

Sir,—In conjunction with the majority of our citizens, I was very much surprised at the result of last night's Council meeting, and the appointing to the position of Chief of Police, a perfect stranger to our city and the province at large, and that, over the head of our efficient and painstaking Sergeant of police, who has so capably filled for the past two months, with satisfaction to all, the position from which he was ousted at last evening's meeting. Sergeant Allan MacInnis as a home man, a citizen and a public official enjoys the confidence and respect of the citizens of Charlottetown, irrespective of race, class, or creed and last night's treatment of all that is finest and best in Canadian manhood, is a sorry reflection on the administration of Civic affairs at the City Council Board. It is difficult to reconcile the vociferous demands of certain citizens for patronage of home industries, and products, with last night's appointment to a Civic position. The gift in their bestowal being given to a stranger from the Pacific Coast, while our Island man, born, and bred, who has given his best for sixteen years in the City Police Force, was turned down, although fully qualified, and did fill for some time, to the satisfaction of all, this disputed position. Is this patronage of home products? Is this a boost for the stay-at-home policy we hear so much about? Sir, I emphatically aver the contrary, and we as citizens are but exercising our civic right when we demand that civic position be filled by Island men when we are so well prepared to do so as at the present time.

Last night's amendment gives our City Fathers a time of grace. Let us hope they will profit by it, to the extent of appointing a man already "on the job," instead of importing a perfect stranger who would require a year at least to acquire the rudimentary knowledge of our local conditions to properly fill the position.
