RE-OPENING OF PRINCE ST. SCHOOL

There was a large turn out of pupils yesterday morning at Prince Street School when school was reopened after the summer vacation. An interesting programme was gone through, and there was an unmistakable air of brightness and enthusiasm about the whole proceedings, which were very pleasantly blended with patriotic songs and choruses rendered in fine style by the older girls, accompanied by Prof. Thompson at the piano. The public were invited to view the class rooms, grounds, etc. During the term the school has been thoroughly cleaned and repainted in harmonious tints. In previous years the walls had been kalsomined, but the superior finish and wearing qualities of oil paint, completely justifies this new policy of the board. Mr. Henry Smith, chairman of the School Board presided. Present on the platform were Principal Seaman, Mr. James Paton, Rev. Mr. Taylor, Zion Church; Rev. Mr. Fulton, First Methodist Church; Mr. Cross, Secty Y. M. C. A. and Mr. T. C. James. The Chairman said it gave him very much pleasure to see so many scholars on the opening day. During the recess the trustees had endeavored to make the interior as clean and nice as they possibly could for their return. About \$400 had been expended in painting, between \$200 and \$300 on new floors, and a considerable sum had also been spent on the outside as well. The school was now in pretty good condition. They were glad to welcome so many of the parents on opening day. Before the pupils got down to the "hard pan" of work again they wanted to have some addresses and some singing. Rev. Mr. Taylor, of Zion Church, followed with a few appropriate remarks. This was one of the chief events of the year. He thought the scholars generally felt that the school closing was something to take precedence over the opening. This was a great day in the life of the children, especially to those who were starting out on something they had never experienced before. They were going to get into a great many new lines of knowledge they had never dreamed of before. When they were through with this the world would have altogether changed for them, because they would have learned so much more about what the world was and their part in it. Mr. Taylor stated that on behalf of Zion Church he would offer to any scholar in the school who was identified with Zion Church, a handsome medal for competition. Mr. James Paton, who spoke next, said that it gave him a great deal of pleasure to be there that morning and to see such a beautiful school as they had now. The School Board was certainly to be congratulated in making the rooms so comfortable. On such a beautiful morning it was a treat to look on the pretty girls with their faces so bright and sunny. It almost made him wish he was a boy in Prince Street School himself (laughter). After referring to a medal formerly given by a hint which he had seen during a recent visit to Western Canada, he now was by a married lady, he said that he had a proposal to make in order to encourage the young ladies to get a good husband (laughter). He had much pleasure in offering a gold medal to the most deserving young lady in the school. The Rev. Mr. Fulton then spoke. He had noticed, he said, that Mr. Taylor invariably said boys and girls. That reminded him of the man who used to speak frequently in another section of the country and who always began his address with "gentlemen and ladies." He was remonstrated with and told that that was not the way to begin his speech. But he said that was always the way because the ladies were always after the gentlemen. The girls were going to lead the boys a merry dance in the way of education in the coming year. He hoped the boys would reach as high a standard as these

girls had. But he knew that the man who spoke the shortest was the man they loved the best. They were beginning the work of life. He had just been at West Kent and left his boy there and over to the Kindergarten with his little girl. It made him feel that he was getting old and he felt a little sad to think that they were beginning the responsibility of life. He hoped this year would be filled with success for the pupils. The First Methodist Church also was going to offer a medal to the scholar who had the highest general average for the coming year. He was always prepared to tell his church beforehand what they were going to do, and the First Methodist Church had complied. Mr. Cross, Secretary of the Y. M. C. A. also made a few remarks, congratulating the pupils and the teachers on the bright new school and wishing them success in their year's work. T. C. James then spoke. He said that for a number of years he had been giving a medal to the best scholar. He was very proud to say that the medal he gave to a pupil was now a Rhodes scholar, was now covered over by a more honorable decoration presented by the Czar of Russia. He referred to Mr. Robert Stewart, who had won it for valorous service on the plains of Flanders. It might not be that the young ladies would go out to the war as soldiers, but he was quite sure they would show the same devotion as these boys when they were called upon. If there was one member of the Board to whom credit was due it was their friend Mr. Smith. He had had a great deal more experience than any of the rest of them. He had assisted Mr. Mathieson in selecting the colors with which the school had been painted. He said

the scholars would appreciate the wise words of counsel they had heard that day. He hoped to watch over them very carefully during the coming months and hoped also they would thoroughly appreciate the splendid
