

STIFF SENTENCE FOR SAILORS

Attacked Nonunionists, Beat Them Severely and Damaged Property

(Canadian Press.) SOUTHAMPTON, Aug. 22—Three of eight men of the crew of the steamer St. Louis, who were arrested yesterday on charges of assaulting a number of non-unionists were sentenced today by the magistrate at the police court here to two months hard labor.

FISHERMAN MISSING.

LOUISBURG, Aug. 21—The schooner Olga, of Gloucester, Mass. Albert Goodwin master, arrived here with her flag at half-mast. A \$6,000 FLAT.

NEW YORK, Aug. 21—Nelson W. Aldrich, chairman of the National Currency Commission, and formerly United States Senator from Rhode Island, with his wife and family, is coming to New York to live. He has leased from Charles A. Sherman, the drygoods man of No. 381 Fourth avenue, his furnished apartment in the New White marble building at Sixty-first street and Park avenue, known as No. 540 Park Avenue. A similar apartment in this building, unfurnished, rents for \$6,000 a year.

MONTREAL'S BYE LAWS.

MONTREAL, Aug. 22—A complaint was made by Ald. Blumenthal at the City Council meeting against the making of the bye-laws in English and French only. He said that many fruit dealers had not been able to read instructions they had received from the health department in regard to the covering of fruit to protect it from flies and dirt, and that in consequence, they had been fined for contravening the laws. He would suggest that the bye-laws should be printed in Greek, Hebrew, Italian, French and English. The motion was carried without discussion.

TWO WOMEN WHO ATTACKED MINISTERS

(Canadian Press.) DUBLIN, Aug. 22—Mary Leigh and Gladys Evans, two suffragettes who were sentenced Aug. 7 to five years imprisonment on charges of wounding John E. Redmond, leader of Irish parliamentary party, with a hatchet thrown at Premier Asquith's carriage and of setting fire to the theatre Royal, respectively, have started "a hunger strike." They are being forcibly fed by jail officials.

DOHERTY FIRST TO RETURN

(Canadian Press.) OTTAWA, Aug. 22—Hon. C. J. Doherty, Minister of Justice, will be the first Cabinet man home from England. He will be here by the end of the week.

CANADA WILL PROTEST.

OTTAWA, Aug. 21—The department of justice and other departments have, it is stated, received instructions by cable from Premier Borden and Hon. C. J. Doherty, to collect all information and statistics, contained in the records in possession of the government having any bearing on the Panama canal controversy. It is understood that this action is taken for the purpose of augmenting and strengthening Great Britain's case, which will be put in motion through diplomatic channels in the event of the bill granting special privileges to United States ships becoming law.

DR NOBLE IS AGAIN FREE

(Canadian Press.) MONTREAL, Aug. 22—Dr. Chas. Noble, the eminent Philadelphia physician who has been confined since June 24th, in the Verdun insane asylum, was granted release this afternoon by Mr. Justice Demers on a writ of habeas corpus. The judge did not dwell on the supposed mental condition of the plaintiff but gave judgment in favor of the release of the petitioner on account of a technical error in the commitment papers on which Dr. Noble had been confined.

BOUNTIES ON ELECTRICAL STEEL.

OTTAWA, August 21—The bounty on steel treated by the electrical process expires this year and is one of the last of the more important bounties ahead from which are fixed by statute. The steel interests generally are preparing to submit to the government at an early date a collective memorial setting forth the conditions which exist in the industry and emphasizing the necessity of meeting the situation. It is intimated that tariff changes are necessary that it may be on lines somewhat different from last session's presentation of the case.

NEW BRUNSWICK MAN DROWNED IN EAST RIVER

Is Supposed To Have Fallen Overboard Accidentally

(Canadian Press.) NEW YORK, Aug. 22—Milton Hicks, 24 years old, a seaman on the schooner Carrie C. Ware, hailing from Dorchester, N. B., was drowned, it is supposed, in East River today. The police coroner is making an investigation of the death of the man. Hicks was missed from the schooner by Captain A. T. Ward and here yesterday were bound for points. Shortly after noon the body of Hicks was found floating about three blocks away from the schooner. It is not known how Hicks met his death but it is believed to be a case of accidental drowning.

MUTINY OF OFFICERS OF MOUNT ROYAL

(Canadian Press.) LONDON, Aug. 22—The culminating strike of a series which has crippled the British carrying trade during the past two years is threatened by the officers of the Mercantile Marine. The movement began today when the newly formed union of shipmasters and mates tried to prevent the C. P. R. liner Mount Royal from sailing and the chief officer had been dismissed and the union demanded reinstatement.

A substitute was obtained by the company, however, and the vessel left port. The officers are well organized and discontented and propose to put forward before the end of the year what they consider their legitimate demands. Failure to meet these will be met by a strike which may starve the nation.

CHALLENGE TAKEN.

PITTSBURGH, Pa., Aug. 21—The Leader has accepted the challenge of Senator Penrose, who says he wanted some one to make a direct accusation in respect to the \$25,000 sent him by John D. Archbold of the Standard Oil. The Leader says—

We make the direct accusation that Boies Penrose was paid \$25,000 by the Standard Oil Trust after he, as a member of the Industrial Commission, had taken order from John D. Archbold, of Standard Oil, as the course of that commission in investigating the monopoly.

We make the additional direct accusation that Penrose was paid this \$25,000 after the report of Industrial Commission had been submitted to John D. Archbold and approved by him previous to being made public.

TO OPPOSE LONGWORTH.

CINCINNATI, Aug. 21—A Progressive candidate for Congress will be put into the field in the district now represented by Nicholas Longworth, Republican, son-in-law of Theodore Roosevelt. The order to put up a candidate for Congress in this district is said to have come from Colonel Roosevelt himself. Leaders of the Progressive movement say Dr. A. O. Zwicker will probably get the nomination.

\$125,000 ON DEPOSIT BY BECKER

SHORTHAND WORLD RECORD IS BROKEN

NEW YORK, Aug. 22—All world's records for shorthand speed were broken here today when Nathan Behring, official stenographer of the New York Supreme Court, and formerly official reporter at Police Headquarters, wrote an average of 278 words a minute for five consecutive minutes. The previous world's record was 269 words a minute.

NICARAGUANS MASSACRED

(Canadian Press.) Washington, Aug. 22—The massacre of the loyal Nicaraguan troops sent to defend the town of Leon is confirmed. All the defenders, except three or four soldiers who escaped were annihilated.

CAMERON WINS.

CHATHAM, N. B., Aug. 22—The five mile relay race in which Fred Cameron, the pride of Amherst, ran against three local men, was won by the former, he going the distance in the time of 27 minutes, 54 seconds. The locals, Watling, McGrath and Moore, gave the sturdy little easterner a hard run for the money, he only coming under the wire about two feet ahead of Watling, who ran the last quarter.

Cameron's time for the distance was as follows: Half mile, 2.45; mile, 5.36; mile and half, 8.36; two miles, 10.52 two and one-half miles, 13.40; three miles, 16.15; three and one-half miles, 19.40; four miles, 22.32; four and one-half miles, 25.13; five miles, 27.54.

STEFANSON AT NOME.

NOME, Alaska, Aug. 21—Vilkhmar Stefansson the explorer who discovered a race of blonde Eskimos in Victoria Island arrived here today on the revenue cutter Bear, after spending four and a half years in the Arctic. Mr. Stefansson collected much information concerning the Eskimos of the Far North and found many new tribes. He was accompanied by Dr. R. M. Anderson of Iowa. They made the journey out from the mouth of the McKenzie River on a steam whaler as far as Point Barrow where they boarded the Bear. The expedition was financed by the Geological survey of Canada and the American Museum of Natural History.

SUFFRAGETTES ARE INDIGNANT

STORY OF RUSSIAN PLOT IS DENIED

BRAMWELL BOOTH TO VISIT CANADA

(Canadian Press.) MONTREAL, Aug. 22—A London cable says Bramwell Booth, the new General of the Salvation Army, is likely to visit Canada before Christmas on a tour of the world's Army posts. The new General regards Canada as the most convenient and most natural point of settlement of the Exodus from the crowded mother countries.

THE CIRCULATION OF PAPER MONEY.

OTTAWA, August 21—Returns received by the finance department show that the circulation of small notes is substantially larger than it was last summer. Comparing the circulation of July 31, 1912, with that of July 31st, 1911, there is an advance in one dollar notes of approximately \$500,000 in two dollar notes of approximately \$800,000; in four dollar notes of over \$360,000 or in all of between \$1,600,000 and \$1,700,000. In addition there is the additional circulation of the new five dollar note, which at the end of July was \$6,078,000. This is practically balanced by the decreased use of large notes, which are used exclusively by banks. In the three weeks of August which have elapsed the circulation of fives have increased to approximately \$8,250,000.

Furniture Seized by Sheriff's Officers to Defray Court Expenses

(Canadian Press.) LONDON, Aug. 22—British suffragettes were highly indignant today because sheriff's officers entered the country home of Mr and Mrs. Patrick Lawrence, two of the leaders who are now in Canada, and ordered the furniture to be sold in order to pay the costs of the recent conspiracy prosecution.

Mr. and Mrs. Patrick Lawrence were sentenced to nine months imprisonment on May 22 in Old Bailey sessions for inciting their followers to malicious damages but were liberated on June 27. The Womens' Social and Political Union today issued a statement because that the action of sheriff's officers was in the nature of persecution because widows broken were replaced by insurance companies and tradesmen had benefited by advertising.

ARRESTED FOR INSTIGATING STRIKE.

FREDERICTON, Aug. 21—The Canadian Pacific Railway Company has no intention of allowing labor agents and agitators to interfere with its operations as is evidenced by the arrest at McAdam of Benjamin Block, a Russian labor agent, who was brought to the city by Albion T. Foster of the C. P. R., Police, and against whom there is a charge of instigating arrest and intimidating workmen.

On Saturday the C. P. R. brought a party of seventy-two foreign laborers from Montreal and on Monday they were put to work at McAdam. Block, who had been acting as a labor agent, went among the men, and by telling them that they were not receiving sufficient wages, induced them to leave the work. It is supposed that he was attempting to get the men to work on railroad construction near this city. Monday night the strikers congregated about the railway station at McAdam. Policeman Gardner of the C. P. R. force, ordered them to disperse. Block refused to move on and when seized by the officer resisted arrest.
