When photoplay fans of the greater new show world of eye and ear diversion think of sophisticated delicacy denouement without smirk and finesse in characterization ranging from gutter to ballroom; there is one combination which comes to mind.

That is the famous pair of "Charming Sinners" and "The Laughing Lady" Ruth Chatterton and Clive Brook, newly and brilliantly appointed by Paramount for "Anybody's Woman" in its premier engagement.

ment," the Government appealed to them for cooperation.

Under the constitutional reforms to be put through by the Round Table Conference, he said, the Bombay presidency will become to all practical purposes an autonomous state linked with the other British states and provinces and with the Indian states in a federation for matters of common concern, but almost entirely responsible for the administration of its own affairs.

"I claim the Government is entitled to your full cooperation in bringing India's new constitution into being," the Governor told the business men. Similar speeches were made by the chief officers of all provinces and presidencies.

Business Slump

Business on the Bombay Cotton Exchange, second largest in the world, has dropped from 100,000 hales a day to less than 100, a daily loss amounting to about \$3,000,000.

The gold export trade has decreased from \$2,000,000 a day to \$1,000,000. The cotton, bullion, piece goods and stock exchanges have been closed. Since the arrest of the Mahatma not a yard of British cloth has been sold in the

Serious Situation Alleged

Submerging of the Intercolonial Railway's identity, and removal of its management from Moncton were questions which the Maritime submission suggested the Commission "might take into consideration." It was set forth that following the Intercolonial's absorption, steps had been taken by the C. N. R. to limit to that system as much of the revenue load haul as possible. The situation had become so serious for the Maritimes that "in the interest of shippers, action had to be taken to protect this section of Canada from its being placed in the hands of a railway monopoly."

The Maritime Board's case for a greater proportion of traffic through Maritime ports was based on the building of the National Transcontinental - R. K. Smith quoted Sir Wilfrid Laurier - "to secure our commercial independence." Statutes had provided that "the through rate on export traffic from the point of origin to the point of destination shall at no time be greater via Canadian ports than United States ports." It was needless to say that neither in the spirit nor the letter was the Act being observed.

Mr. Smith gave figures to show that during the calendar year 1930, Canadian wheat moving eastward had moved through United States ports to the amount of 67,000,000 bushels, whereas Canadian ports got 47,000,000. During a four-months period of the 1931-32 crop year 30,000,000 bushels of wheat for the British Isles had gone through United States ports, 13,000 through Canadian ports. In 1930 New York had handled 54,000,000 bushels of Canadian grain and 3,000,000 bushels of American grain.

PERSONNEL OF COMMISSION

HALIFAX, N. S., Jan. 11 - (By the Canadian Press) - To hear Maritime recommendations bearing on their task, the Royal Commission inquiring into the problems of transportation in Canada arrived in Halifax by special train from Ottawa last night. Lord Ashfield acted as chairman when the commission convened at a public hearing in Province House this afternoon. Mr. Justice L. P. Duff having been forced by an indisposition to remain at Ottawa for the present. Another absentee was Sir Joseph Flavelle, illness of Lady Flavelle having precluded his coming to Halifax.

Sitting with Lord Ashfield were L. F. Loree, president of the Delaware and Hudson Railway; Beaudry Leman, General Manager of La Banque Canadienne Nationale; Dr. W. C. Murray, President of the University of Saskatchewan; and Dr. J. Clarence Webster of Shediac.

Halifax marked the seventh point at which the Commission has held public hearings. Travelling westward on the C. N. R. and back on the Canadian Pacific, public sittings were held at Victoria, Vancouver, Calgary, Edmonton, Regina and Winnipeg. Scores of conferences with railway officials, several of whom accompanied the commissioners on their tour of physical properties, have come in between. The officials are not accompanying the investigators in the Maritimes.

The commissioners will leave Halifax on Monday night, holding a session in Saint John on Tuesday, and travelling thence to Quebec, Montreal and Toronto. The commission began its work on December 4.

Charlottetown Case Presented

R. K. Smith filed with the Commission a memorial from the Charlottetown Board of Trade, endorsed by the Prince Edward Island Government, protesting certain train cancellations, which had come up before the board of railway commissioners in December. He also filed, in support of the Maritime Transportation Commission's submission, a copy of the Duncan Report on Maritime claims, the Nova Scotia Government's submission to that body, a paper on the traffic problems of the Maritimes, and on the military and strategic mileage of the Intercolonial, by F. C. Cornell, and an address of H. A. McKeown, late chief of the Railway Commissioners.

Besides backing the Maritime board's stand on east and west traffic and advocating of the I. C. R. by lines other than the C. N. R. on "a more equitable basis," the Halifax board's brief, submitted by

ment last year are continuing to carry out their good work. Children often are slow in school because of physical defects. They become delinquent and many of them land in the police courts. Our population in the prisons, penitentiaries and insane asylums is steadily increasing. This is wrong, not only economically but humanely and the most effective way to offset this is to properly take care of the children.

He gave great credit to Dr. Woodhouse of the Canadian Tuberculosis Association for the work he has done for this Province. The hon. speaker stated that Dr. Woodhouse is the best outside friend the Province has, when it comes to matters of public health.

He stated he had every confidence in the ability and attitude of Drs. Creelman and Keeping. They are painstaking, hard-working and will go a long way in the next few years in making possible the desired result in Public Health in this Province.

Neglected children are awarded to the Children's Aid Society by the Judge of the Juvenile Court. When they have to be taken from their parents and given as wards to the Society then arises one of the biggest problems. The question of a trained social service worker is one of money. And it must not be forgotten that the Children's Aid Society is the only organization, under the law, able to carry out work and must not be allowed to go down. He stated he wished that it were possible for all parents to be trained and taught so that their children would not have to be taken away.

A vote of thanks moved by Dr. B. C. Keeping, seconded by Mr. W. J. Monaghan was tendered the speaker by the chairman, Mr. W. D. Gillis.

U. S. Pastor Praises Britain's Indian Rule

TORONTO, Jan. 11 - Challenging citizens of the United States as well as Canada to support the present policy of Great Britain in India, including the imprisonment of Mahatma Gandhi, Rev. Warren H. Wilson, director of the department of town and country work, Board of Home Missions of the Presbyterian Church in the United States, speaking at the home missions council in the King Edward hotel, declared that the British government was doing its utmost to promote self-government in India.

"Though the recent imprisonment of Mr. Gandhi will bring many strikes, boycotting of British goods, violence and great injury to England's trade and commerce, India's government will carry on as usual," Mr. Wilson predicted. England, he said, was allowing the Indian people to become autonomous as rapidly as was good for them. But the Indian congress - the popular body - demanded that autonomy should be hastened, and that complete independence be given India.

An Englishman an Irishman and a Scotsman were arguing as to which of their respective countries had the lightest men.

"That may be," said the Scotchman, "but we have men of Ayr."

ation in promoting better fishing. Mr. S. A. McLeod referred to the netting of trout in the streams and thought that the Provincial Police could do much to help out if they were given information as to what streams were being netted.

Mr. A. W. Hyndman stated that a great number of trout were netted to be fed to the foxes, especially in the eastern part of the province, and he solicited the cooperation of the Tourist Association with the Fish and Game Association to deal with this matter.

Mr. S. A. McLeod read the financial statement of the Association and moved its adoption, seconded by Mr. R. L. Cotton.

The chairman explained the manner in which the business was carried on during the year. He regretted the absence of Mr. J. A. MacMillan, who is a valued member of the executive. He mentioned further that the Association has had wonderful co-operation from the Tourist Bureau of Halifax and Fredericton.

Mr. S. A. McLeod moved a vote of thanks to the Provincial Government, City of Charlottetown, Town of Summerside, Rotarians, Gyros, newspapers and all those who helped in last season's drive and hoped the same co-operation would be forthcoming again this year. The resolution was seconded by Mr. R. L. Cotton.

The chairman introduced Mr. Mould, manager of the Canadian National Hotel, as a valuable new member of the executive.

Mr. Mould expressed his appreciation of the work of Mrs. MacFadyen. He stated that moving pictures had been taken this year by the Canadian National Railways and would prove valuable advertising. He suggested fewer and larger pictures in the Association folders as a better form of advertising. He thought we should sell our climate, scenery and fishing and he offered to help in any way he could.

The chairman referred to the prominent writers who visited the island during the past year and whose works have helped materially in interesting tourists. He stressed the fact that the tourist money is widely distributed. He believed that there would be a greater percentage of Americans touring this year and he was optimistic for the coming year.

Mr. T. G. Ives, who has recently come to Charlottetown from Montague, was then called upon. Mr. Ives stressed the fact that

there is not a person on the Island who does not benefit from the Tourist money. Mr. Ives wished to second Mr. Mould's statement with regard to selling our climate. He also stressed the wonderful improvement which the Car Ferry provides.

Mr. W. A. Stewart, M. L. A., thought it would be well if the sea-side resorts intend to have lower rates this year, to advertise this change.

Mr. A. E. Morrison moved that the present officers be re-elected with the same executive. It was seconded by Mr. W. A. Stewart. The meeting then adjourned.

Asked to State Manchurian Policy

TOKYO, Jan. 11 - (A. P.) - Great Britain has asked Japan to state again its policy in Manchuria in connection with the United States representations which invoked the nine-power treaty and Kellogg anti-war pact, it became known today.

Whether the British request was made verbally or more formally was not announced.

The following motions were passed: That William Barwise be appointed to act as janitor for the town building, repair and clean machinery and also work with Henry DesRoches when required at a salary of \$120.00 per week, moved by Councillor Kelly, seconded by Councillor Phillips.

That Percy Kitch be appointed regular police officer for the town of Summerside at a salary of \$80.00 per month, uniform to be supplied. Moved by Councillor Strong, seconded by Councillor Kelly.

The monthly reports from the different committees were received. Councillor Strong presented the yearly report of the police department.

The financial report for the year was not ready and will be presented at a meeting which has been arranged for January 20th.

The police yearly report was as follows: Drunkenness 132; robbery 4; creating a disturbance 3; speeding 2; stealing 8; corner loafing 9; vagrancy 4; having stolen goods 2; resisting arrest 3; failing to stop at stop signs 1; fighting 6; stealing cars 5; using profane language 2; driving cars while drunk 3; driving cars without license 2; driving cars without brakes 2; arrested for Charlottetown 3.
