## SOME STIRRING SCENES

Continued From the First Page.

The journals of the House record the demand of the Leader of the Opposition and justify his action. Mr. Birch had important documents in the desk.

**Mr. Peters.**—Was it birch bark? **Mr. Shaw.**—Mr. Peters should be the last man to talk about birch bark. He supposed, however, it was near his heart.

**Mr. Peters** contended that all the talk was for a purpose. If a house is broken into an investigation is held. It is making a mountain out of a mole bill.

The Opposition have charged the Leader with everything and now the Leader is charged with burglary.

**Mr. Shaw.**—We do not charge the Leader with burglary.

**Mr. A. A. McLean** said that yesterday the Leader of the Government refused to grant an investigation. The break was obliterated before the commission was appointed. Will the Premier rise in his place and deny the fact?

**Mr. Farquharson.**—If the Hon. member wants to do special pleading he should go to the next building. "Don't argue the case, the commission will be granted."

**Mr. Farquharson** submitted bank statements asked for by Mr. Gordon.

The Speaker read the resolution passed at the City Council meeting Thursday evening.

**Mr. Campbell** resumed the debate on the budget and gave a detailed account of the expenditure by himself when Commissioner of Public Works. He then took up the present state of the roads and bridges, condemning the way the funds were expended.

**Mr. Campbell** was then taken ill and said he was sorry he could not continue the debate.

**Mr. A. Peters** said he was sorry to know that Mr. Campbell was unwell. Statements had been made by Opposition which reflected upon the characters of members of the House. The last charge was one of burglary, and it is a scandalous charge and members have no right to use such statements in the House. When the desk was examined it was found to be as empty as the head of the man who sat at the desk. The investigation asked for was absurd. He was not in the House but he heard a statement had been made that the Sheriff went in the front door of one of the members of the House and corruption entered the other. He remembered the time when Sir Charles Tupper was a poor man and where did he get the money which he now possesses? He could quite understand why Mr. Pineau had changed his politics. The man named Callaghan is the celebrated Callaghan who went around with liquor with Mr. Hackett and was the means of unseating Mr. Hackett.

**Mr. A. A. McLean.**—It is not the same Callaghan at all. **Mr. Peters** continuing read an extract from a Winnipeg journal in which he claimed that the race cry was carried on by the Conservative Party. Mr. Pineau went away to earn his living, which was an every day occurrence. During the Davies' Government Mr. Campbell changed his politics because he could not get the appointment of Commissioner of Public Works.

Considerable exception was taken to Mr. Peters' statement in reference to Mr. Campbell's change of politics.

**Mr. Peters** continued and said that the Hon. Member from New Perth had stated that the system of education now in existence in the province was inferior. The Island boys are found in the highest ranks of learning and if the charge was correct such things would not exist. An Island boy, who was at one time poor, was made a Commissioner on the U. S. Commission in the Philippine Islands. He did not know what school Mr. Shaw went to, but he did know that he murdered the Queen's English.

**Mr. Shaw.**—I went to the same school as the Hon. member from St. Peters but there was a difference between him and myself. I was at the head of the class and Mr. Peters was at the tail.

**Mr. Peters.**—It was a poor class. **Mr. Shaw.**—It was a poor tail. (Laughter)

**Mr. Peters** continuing said the Conservative Government had drawn \$200,000 from capital account and placed it to ordinary expenditure. The money which is being spent is being placed in permanent works. The present Government did not come into power with this understanding of making both ends meet. The Government did claim that the money at Ottawa would wipe out the indebtedness. If the present Government remain in power the claims will no doubt be adjusted. The House took recess.

### EVENING SESSION.

Last night's session of the Legislature was largely attended. Mr. A. Peters continued the debate on the budget and charged that some of the affidavits submitted by Mr. McLean were signed by men who were guilty of bribery. He expressed himself strongly in favor of Municipal Government.

**Mr. Arsenaull** followed and said he did not want Mr. Peters to throw a taunt of disloyalty in his face to shield another member who occupied a seat on the Government side. He challenged that member to explain his course.

During the evening word was spread abroad that Mr. Pineau would speak, and as a member resumed his seat all eyes were centred on the member from the 1st District of Prince County, Mr. Pineau. At last the expectation was realized and when Mr. Arsenaull resumed his seat Mr. Pineau arose amid hisses from the gallery.

He prefaced his remarks by announcing his pleasure in taking this opportunity of expressing himself. A great many charges had been made and those charges

were unjust. He was a young man and not used to parliamentary law, but he thought it was not parliamentary to make charges such as had been made against him. Many of the charges were contradicted and had to be taken back. Before giving his explanation he wished to say a few words on the finances of the Province. The public accounts show a surplus of \$5,000 and that was the reason he changed his politics. He did not wish to belong to a party that would falsify statements of that kind.

When he entered public life he was not desirous of doing so and after fighting a hard battle they (the electors) wanted to get rid of him. They circulated the news that he was going to be made Speaker of the House and he had to call meetings to denounce those charges.

**Mr. Arsenaull.**—The meetings were for organization and he never attended them.

Continuing Mr. Pineau said that he wished that the member from Wellington would give him time. He had repeatedly called meetings and he had said to himself, if he was going to be used in that way it was time to leave and he had struck in with a body of men who recognized him.

Perhaps he did say he was going to Paris. He was now in the House and that was evidence that he did not go. If he had gone away it was his own business. He went away and accomplished his business and he returned, and when he got to Point du Chene, Capt. Cameron came to him on the boat and said he had received a telegram from a man named A. A. McLean of Charlottetown.

**Mr. McLean.**—There never was a telegram and Capt. Cameron, who is an honorable man and a good Liberal, never gave it to that man, (pointing to Mr. Pineau.)

**Mr. Pineau** said that his political character would compare with Mr. McLean's. When he got to Summerside a delegation waited upon him and he was told to go to Mr. McLean's office in Charlottetown. (Applause.)

**Mr. McLean.**—I deny the charge in toto. (Here Mr. McLean commenced to read the letter written by Mr. Pineau when in Ottawa.) (Cries of Chair!)

**Mr. McLean.**—Does Mr. Pineau recognize this: "I was well received by the Government." "I suppose the people will blame me, but I could not help it." Does he know those words? Does he recognize them?

**Mr. Speaker** ruled that Mr. McLean was out of order.

**Mr. Pineau** continuing said that he was sorry now he did not go to Mr. McLean's office and get his exact words and lay them on the table of the House. He was not in the market, as Mr. McLean thought he was. With regard to the charges of being in Ottawa he said that probably he was and probably he was not. He wanted to say he never saw Sir Louis Davies or received a cent from any person for his recent action. He knew the members of the Opposition were taking advantage of the fact that he was not an orator. As to the question of not having a right to his seat, he said he had not lost the confidence of his district. He challenged Mr. McLean to resign his seat and to go to the 1st Electoral District of Prince County and run an election against him. The people of his district were a just people. The present session of Parliament is only the third one and

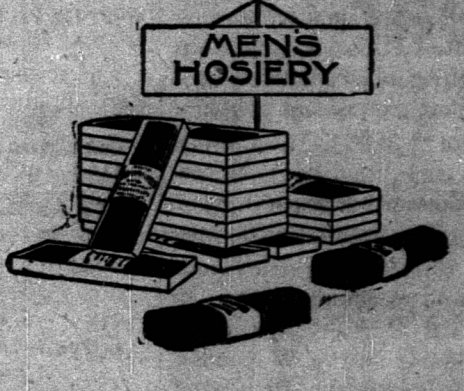
