## SKATE CHAMPIONS

Performed in the Rink  
Last Night.

The Victorias Defeated the  
St. Dunstan's by a Score  
of 3-5 in the Match For  
the Intermediate Trophy  
—The Game Was Fast and  
at Times Rough.

Hillsboro rink was well filled last night to witness the Davidsons skaters and the hockey match between the Victorias and St Dunstan's for the Intermediate trophy. About twenty five minutes past eight o'clock, Mr. A. A. Bartlett introduced Miss and Mr. Davidson and the two glided gracefully on the ice from one end of the rink to the other, then Mr. Davidson retired and his sister entertained the audience, who looked on with the closest attention while she skillfully went through her beautiful performances. Miss Davidson has 163 separate figures in her repertoire, but these were not by any means all given last night. She skated the edges rolls forward and backward, the boulevard forward on toes, the Dutch roll with circle and whirl, the Barney 8 with toe catch, the flying Mercury, also with toe catch; the grape-vine with single, double and triple whills; the Philadelphia twist, single and double; the plumvine with Philadelphia twist—this one is similar to the grape-vine except that it calls for a wider swing and the skater covers a greater area than in the limited lateral space used in executing the simple figure, is very pretty and particularly difficult. Single, double and triple toe springs she also performed, as well as single 3 and double 3. These are some of the most difficult and prettiest besides being in many cases original and really fine.

Miss Davidson is a pretty figure and has the proper physique for a skater. Her appearance and brilliantly executed curves won for her much admiration, and frequent applause followed her performances.

Mr. Davidson appeared just after Miss Davidson had retired and his movements like his sister's, charmed the onlookers. His chief performances were the plain outer edge with change forward and backward; the flying Mercury, lighting in one toe; the Dutch roll backward

with double whirl and cut off. The one foot 8 with toe spin he performed very prettily. This is one of Mr. Davidson's own manœuvres and he is the only man who is able to do it. It is considered very hard to perform but Mr. Davidson seemed thoroughly at home in exhibiting it. The Barney jump; the spread eagle with a complete turn in the air lighting and continuing on the spread eagle; the one foot whirl; cork screw whirl and double flat foot spin all were attractive and cleverly shown.

Together the two champion fancy skaters of the world next appeared before the eager gazing crowd and went through many interesting movements including the grape-vine double, the Bishop 8 with toe catch double, the flat foot waltz and the toe catch waltz and in fact all the figures performed by each were done together, making a picturesque scene for the delighted spectators. The peculiar charm of the Davidsons' skating is their succession of quick and attractive movements. This originality is gained by the introduction of new twists and figures. They are also adepts at the toe-catch and get around with as much ease and grace on the toes of their skates as on the runners. Their exhibitions were received with great favor and liberally applauded.

### LOYAL ORANGE PRINCIPLES.

As the Grand Lodge, L. O. A., meets in the city to-day, it may be worth while to reproduce a few extracts from the constitution of the order. The following is quoted from the general declaration of its principles:

"The Loyal Orange Association is formed by persons desirous of supporting to the utmost of their power the principles and practices of the Christian religion, to maintain the laws and constitution of the county, afford assistance to the distressed members of the association and otherwise promote such laudable and benevolent purposes as may tend to the due ordering of religion and Christian charity and the supremacy of law, order and constitutional freedom."

"The Orange Association lays no claim to exclusive loyalty, or to exclusive Protestantism; but it admits no man within its pale whose principles are not loyal and whose creed is not Protestant."

"Disclaiming an intolerant spirit, the Association demands as an indispensable qualification, without which the greatest and the wealthiest may seek admission in vain, that the candidate shall be deemed incapable of persecuting or injuring any one on account of his religious opinions; the duty of every Orangeman being to aid and defend all loyal subjects of every religious persuasion in the enjoyment of their constitutional rights."

The qualifications essential for membership in the Orange order are set down as follows:—"An applicant for admission should have a sincere love and veneration for his Almighty Maker, productive of those lively and happy fruits—righteousness and obedience to His commands, a firm and steadfast faith in the Savior of the world, convinced that He is the only Mediator between a sinful creature and an offended Creator. His disposition should be humane and compassionate and his behavior kind and conciliatory; he should be an enemy to savage brutality and every species of un-Christian conduct; a lover of rational and improving society; faithfully regarding the Protestant religion and sincerely desirous of propagating its precepts, i. e. charity and good will to all men. Zealous in promoting the honor, happiness and prosperity of his Queen and country; heartily desirous of success in those pursuits, yet convinced that God alone can grant them. He should have a hatred of cursing and swearing, and of taking the name of God in vain; he should use all opportunities of discouraging them among his brethren and shun the society of all persons addicted to those shameful practices. Prudence should guide all his actions; temperance, sobriety and honesty direct his conduct; and the laudable objects of the Association be the motives of his endeavors."

### Kipling Sued for \$50,000.

BRATTLEBORO, Vt.: Feb. 15.—Beatty Balesier, brother of Mrs. Rudyard Kipling, left here for New York this morning, for the avowed purpose of bringing suit against his famous brother-in-law, claiming damages of \$50,000 for alleged malicious persecution and false arrest.

Young Balesier says he has no malice in bringing the suit but simply wishes to be reimbursed for what he has suffered. It will be recalled that on May 6 1896 the two men met on a highway near Brattleboro. Kipling claimed under oath in court a few days later that his brother-in-law had threatened to take his life. The hearing at that time attracted wide interest, and young Balesier was bound over to the grand jury and put under bonds to keep the peace.

The case was to have been tried in the September term of that year. M. Kipling, however, sailed for England in August, and the case was dropped. Young Balesier claims that he has been publicly held up to contempt and ridicule and called a drunken maniac by Kipling's friends. He claims he has had no opportunity to tell his story in the court, and he now seeks justice by bringing suit.
