4 SENTENCED TO DORCHESTER PENITENTIARY

Convicted Of Fraudulent Conversion

NANAIMO, B. C., Dec. 4.—Senator A. E. Planta, 67, convicted of fraudulent conversion of the sum of \$700 the property of a client, to his own use, was sentenced by Chief Justice Aulay Morrison in Assize Court today to two years in the penitentiary at New Westminster.

The Senator had conducted a financial insurance business in Nanaimo but the firm had been taken over in bankruptcy last year by J. B. Mather as trustee.

Senator Planta was alleged to have obtained the \$700 from Henry Aho of Nanaimo in 1931 on representations it was for a mortgage of Mrs. Irma L. Bernard. It was shown the money was never paid to her. Aho testified he had approached Senator Planta who had repaid the \$700.

Mather testified the Planta Company had operated at a loss for the last year of its existence and the Senator had personally absorbed the losses, paying out of his own account the necessary funds.

The jury Tuesday night returned a verdict of guilty with a strong recommendation for mercy.

Two charges of theft from Mrs. Bernard and one of theft from the estate of Henry Crewe, deceased, against Senator Planta were transferred to the Spring assizes.

FINANCIAL SITUATION KEPT SECRET

Decree Suspends Publication of Treasury Figures, Statistics And Public Debt Of Bank of Italy.

ROME, Dec. 4.—A royal decree masked Italy's financial situation with official secrecy tonight.

Amid an apparent tightening of the Kingdom's home defences, the decree suspended publication of treasury figures, statistics on the public debt and statements of the bank of Italy.

The last bank of Italy statement was issued Oct. 20. Then, the bank had nearly 4,000,000,000 lire in gold (approximately \$324,000,000).

Granted Authority

Subsequently, Premier Mussolini was given authority to withhold all statistical information which might give aid or comfort to Italy's economic besiegers—the "sanctionist" states of the League of Nations.

Following upon the reported withholding of all naval leaves, well informed persons said certain troops which had been destined to sail for Italian Somaliland, the Southern African war base, still were in Italy.

The cabinet has ordered, too, that all vacancies in the Kingdom's powerful air force be filled. Already the army has reached a peak of efficiency with the cancellation of leaves for 100,000 men.

Going On With War

As for the conflict in Ethiopia, official sources said Mussolini was going on with his war without waiting for Great Britain and France to propose peace. Those who pressed to know said the dictator wants both territory and a smashing victory before he listens seriously to peace terms.

Marshal Pietro Badoglio, the new high commander of the African armies, was pushing his penetrations as rapidly as he could. But today he cabled tersely: "There is nothing of note to report on either the Eritrean or the Somaliland fronts."

The government issued an official communique, denying reports published by "several American and English newspapers" concerning a supposed petroleum monopoly which the government was said to have conceded to the Standard Oil Company in New York.

FUNDING LOAN SUBSCRIBED

Huge Loan For Defence Purposes May Follow.

(C. P. Cable By Guardian's Special Wire)
LONDON, Dec. 4.—It was authoritatively stated tonight that the funding loan which was successfully subscribed soon after its issue could not be devoted to defence purposes. It was specifically earmarked for the retirement of other obligations.

In some quarters, however, it has been suggested that the clearing up of the money market by the present funding operations would simplify the flotation of a defence loan later.

(Previous reports were to the effect that part of the \$300,000,000 loan might be used for defence purposes. It was said it had learned from a high admiralty source that in the event that no agreement was forthcoming from the naval conference here some of the proceeds would be used for the building of three new battle cruisers.)

Official assurances that there would be a substantial increase in the defence forces naturally stimulated interest as to where the money was coming from. But far from satisfying public curiosity the government hitherto has declined to reveal even the extent of the new armaments. The appearance of the new funding loan revived conjecture on this point.

QUINTS FACE MOVIE CAMERAS

GALLANDER, Ont., Dec. 4.—Displaying no stage fright, camera shyness or even plain contrariness, the quintuplets did a successful day's work in their first appearance with Jean Hersholt and Dorothy Peterson today in "The Country Doctor."

SEES CANADA IN VAN OF RECOVERY

Hon. Vincent Massey Addresses Canadian Club.

LONDON, Dec. 4.—(C. P. Cable)—Hon. Vincent Massey, Canadian High Commissioner to London, tonight gave to the Canadian Club a cheerful picture of a Dominion well on the road to economic recovery.

Sir Edward Peacock, native of Glengarry County, Ontario, and widely known in London financial quarters, presided at the meeting.

The progress of Canada during the last year, said Massey, "has been steady and unbroken. Nearly all the important indices of economic activity, such as bank clearings, exports, car loadings, the use of electrical power, customs revenues, contracts for construction—all these indicate uniform improvement."

In some respects at least, he said, progress recently had struck an accelerated pace.

At the same time Massey emphasized Canada was peculiarly dependent upon external trade. The promotion and expansion of her external trade was vital to Canada's future welfare.

Dizzy Heights To Old London

LONDON, Dec. 4.—The tower that will dominate the new buildings of the University of London in Bloomsbury will be 210 feet high, 40 feet higher than Nelson's Column in Trafalgar Square, but not the highest structure in London.

The Big Ben tower on the House of Parliament is 320 feet high. Yet by standards the university tower will be something of a skyscraper, and the view from its roof should be magnificent.

Special sanction has been received by the university authorities from the London County Council for the erection of a building above the limit of from 80 feet to 100 feet, prescribed under the London Building Amendment Act of this year.

Work on the base of the tower has begun, but the whole structure may not be completed until 1937.

The tower will have eight stories, several of which will be used for storing books for the library. The library will be in the base.

MONTREAL TO BE AIR TERMINAL?

The witnesses will be heard tomorrow as judicial recount proceedings continue.

Since the recount was yesterday the majority of Dr. Anatole Plante, Liberal M. L. A., elect, over Calixte Cormier, A. L. N. candidate, has sagged from 776 to 741 in the 60 polls scrutinized. There are 164 polls in the constituency.

Alliance lawyers said they wanted to summon the officials in 40 polls to prove fraud in Montreal Mercier in the provincial elections of Nov. 25. Liberal lawyers argued the Judge had no right to grant the demand. Judicial recounts were for the purpose of checking the votes and were not contestation proceedings, they claimed.

Judge Forest cited a judgment of the Supreme Court of Canada which gave him the authority he said to call officials as witnesses in cases where fraud is apparent.

TORONTO, Dec. 4.—Premier Mitchell F. Hepburn returned to his offices at Queen's Park today from Florida, where he has been resting, and announced he would lead the government in the next session of the legislature and would represent Ontario at the interprovincial conference at Ottawa.

The sun-tanned premier refused to discuss the question of his proposed resignation as premier after the next session or whether he would reconsider. He said he was amazed at his quick recuperation from the poor health that sent him south in search of a cure. Premier Hepburn will return to his wife and adopted son at Miami after the Ottawa conference.

He will reside at a cabinet meeting here tomorrow, when the agenda for the Ottawa conference will be discussed.

OTTAWA, Dec. 4.—Montreal may be chosen in place of North Sydney, N. S., as the Canadian terminal for projected trans-Atlantic air mail and passenger services with Newfoundland, Ireland and England, it was intimated today. The proposal is understood to be under favorable consideration by delegates to the Imperial Airways Conference who are now in Washington following close of the parley here.

The intimation gives color to earlier reports the great-circle route from Canada to Harbor Grace, Newfoundland, and to Clifden, on the Irish coast, would be the route adopted for the trans-Atlantic survey flights to start next year followed soon afterwards by an experimental airmail service.

The ultimate objective through this service of closing the Atlantic gap in the chain of Empire air communication is a minimum schedule of two flights each way weekly for passengers and mail, probably in about three years.

Independence Resolution Defeated

(C. P. Cable by Guardian's Special Wire)
DUBLIN, Dec. 4.—A resolution demanding that the Free State Government should claim from the League of Nations recognition of its independence was defeated by a large majority today in the convention of the President Eamon De Valera's Fianna Fail Party.

It also required the Government to withdraw from Geneva, if the League failed to accord the recognition demanded.

Another resolution commending the present policy of the Free State Government was carried with only one dissenting vote.

President De Valera declared if Irish membership in the League did not help, it was also true it did not hinder them working for the unity and independence of their country. They could not go to the League making various demands. They could go only if there was a likelihood of the world's peace being affected by the matter in dispute.

The League could not listen to national appeals, said De Valera, unless there was a serious threat of war. Otherwise Geneva would become a court in which all sorts of questions would be brought up.

Replying to a question in the Dail today, President De Valera said recent rumors of new negotiations with Great Britain were without any foundation. He was understood to refer to disputes involving the payment of land annuities and tariff rates which have remained unsolved since 1932.
