## TWO TO ONE IN FAVOR OF PROHIBITION

EDMONTON, Alta., July 22.—By a majority that will run about two to one, the Province of Alberta, in a plebiscite vote under the new Direct Legislation Act, yesterday pronounced in favour of the proposed liquor Act, prohibiting the sale of liquor throughout the Province. Returns received up to 10 o'clock showed 39,020 in favour, and 20,104 against, with half the polls heard from.

The biggest majorities in favour of prohibition were piled up in the country districts in the southern part of the Province, while in some of the northern constituencies where liquor is now partially barred, the majorities were against prohibition.

All the cities, with the exception of Lethbridge, went dry. Edmonton showing a majority of 3,600 and Calgary about 3,900.

The new liquor Prohibition Act goes into effect July 1, 1916.

It has gone through so many revisions to modern party exigencies that there is only a remnant of the original left. Not only did we get the money, but they got complete control of the other fisheries, which is equivalent to another \$100,000. It's results that counts, my lad, its results."

"Well, isn't it results I'm after," interrupted the editor. "It's results that count, as you say, but these cannot be got by the voter after the Government on the big things. The expenditures must be criticised. It must be shown, by insinuation if there is no other way, that there is extravagance," went on the caller, "but eye is being squandered."

"You must be the watchdog of the treasury. You must see that the people's interests are conserved. But be careful what you say about what you see. Don't forget that Mathieson got tea at Victoria Park. This afternoon, however, tea will be served by Misses Auld, Louson and McKinnon."

There has been some harping, for instance, about the salary paid to the premier. I think that's a small thing out of our sails somewhat by the fact that the Liberal leader in the House favored a salary for the premier. "We'll let that pass," said the boss. "But what do you think about getting after the Mathieson administration for the travelling expenses of its members with portfolios?
