## GARRETT HOBART

Vice-President of the U.  
S. Passes Away.

### THE NATION MOURNS

Lady Salisbury Dead—Will  
Prevent Lord Salisbury  
Meeting the Emperor.

PATRICK, N.J., Nov. 21.—[Special]  
—Vice President Garrett Augustus  
Hobart died this morning and will prob-  
ably be buried on Saturday.

WASHINGTON, Nov. 21.—(Special)—  
The news of Hobart's death was heard  
with sincere regret and flags every-  
where are at half-mast.

#### HIS SUCCESSOR IN OFFICE.

There is no provision in the con-  
stitution for the succession, but Senator  
Erye, President pro tempore of the  
Senate, will call that body together  
December 4th, and preside until a Pre-  
sident pro tempore is elected.

#### HIS CAREER IN BRIEF.

Mr. Hobart was born at Long Branch,

N. J., in 1844. He was educated in  
Rutger's College and was admitted to  
the bar in 1869. In 1872 he served in  
the state Assembly and in 1876 was  
elected a member of the state Senate.  
In 1881 he was elected President of  
that body and in 1896 was elected Vice  
President of the United States. The  
Vice President is ex-officio President of  
the U. S. Senate.

#### LADY SALISBURY DEAD.

LONDON, Nov. 21.—(Special)—Lady  
Salisbury, wife of Lord Salisbury, died  
on Monday.

They were married in 1857. Lady  
Salisbury, was Georgiana Caroline,  
daughter of Sir Edward Hall Alderson,  
Baron of the Exchequer, and niece of  
the celebrated Mrs. Opie, of literary  
fame.

#### WILL PREVENT NEGOTIATIONS.

Lord Salisbury's bereavement will  
prevent any negotiations or consulta-  
tions with the German Emperor and  
make his visit a pure family affair.

### SUPREME COURT.

Michaelmas Term—Adjourned Sitting.

TUESDAY, NOV. 21.

Court met at eleven o'clock. Present  
the Chief Justice, Mr. Justice Hodgson  
and Mr. Justice Fitzgerald.

Walter G. Davies and others, vs  
Walter Matheson—The Court gave  
judgment over-ruling the demurrer of  
the defendant. A. Peters, Q. C., and  
Stewart, Q. C. for plaintiff; McLeod,  
Q. C., and W. E. Bentley for defend-  
ant.

John W. Allen vs Charlottetown  
Steam Navigation Company—Tried  
Trinity Term last when a verdict was  
given for the plaintiff for \$155.00. Rule  
nisi for a new trial argued present  
term. The Chief Justice and Mr. Jus-  
tice Fitzgerald today gave judgment  
setting aside the verdict and making  
the rule for a new trial absolute. W.  
J. Stewart, J. C., and John S. McDon-  
ald, for plaintiff; F. L. Hazard, Q. C.,  
and A. Peters, Q. C. for defendants.

Peter Richard vs B. Mattinson—W. S.  
Stewart, Q. C. on behalf of defendant,  
who is a prisoner at a Prince County jail,  
was granted a rule nisi returnable on  
Friday next to show cause why the de-  
fendant should not be discharged from  
jail on account of alleged irregularities  
in the proceedings.

Rose A. Simpson, who sues in the  
name of Her Majesty the Queen, vs.  
George A. Thompson and James E.  
Robertson. This case, which is an  
appeal from the judgment of Mr.  
Justice Hodgson, given on a question of  
pleading, is now before the Court. J.  
A. Mathieson for defendant; W. S.  
Stewart, Q. C. and J. T. Mellish for  
plaintiff.

## DOUBT ABOUT THE BATTLES Of Wednesday and Thursday Being Fought as Reported.

### JOUBERT HAS GONE SOUTH

Besieged Towns All Safe—Kruger Getting Blue and  
Worried—Buller's Officers to Carry Rifles—  
Will Proceed West of Orange River—Troops  
Arrive in Esquimalt.

LONDON, Nov. 21.—(Special)—The  
news from South Africa shows that the  
British campaign is now beginning in  
real earnest.

#### THE BESIEGED TOWNS SAFE.

All fears of the safety of Kimberly,  
Ladysmith and Mafeking are at an end  
and the belief is that the Boers will  
soon be driven across the border into  
their own country.

#### BATTLES THAT WERE NOT FOUGHT.

Late despatches from Ladysmith do  
not confirm the reports of severe fight-  
ing on Wednesday and Thursday last  
but rather show that all is quiet.

Nevertheless Estcourt despatches  
dwell on these victories.

#### JOUBERT GOES SOUTHWARD.

The belief is that General Joubert  
has gone South leaving only sufficient  
forces around Ladysmith to keep White  
from rallying out.

#### KRUGER HAS THE BLUES.

LONDON, Nov. 21.—A despatch to the  
Central News from Preoria, says that  
President Kruger is no longer confident,  
but appears terribly worried. The des-

patch says he lives like one isolated  
from the world.

#### BULLER'S ARRANGEMENTS.

From the presence of General Buller  
near. General Methuen at Orange  
River, it is interpreted that the main  
advance into the Orange State will be  
made on the west side of the river.

General Buller's orders to his officers  
on the subject of their equipment are  
taken to mean that the officers are to  
carry rifles like the troops.

OTTAWA, Nov. 21.—The report that  
the Canadian contingent will do nothing  
more than garrison duty in South Africa  
is emphatically denied here.

The statement on its face bears an air  
of improbability as the disposition of  
troops does not rest with the war office.  
General Buller is given a free hand, and  
will place the Canadians as he may  
think fit.

VANCOUVER, B. C. Nov. 21.—(Spe-  
cial).—A special military train from  
Halifax with 100 men and six officers  
has reached Esquimalt.

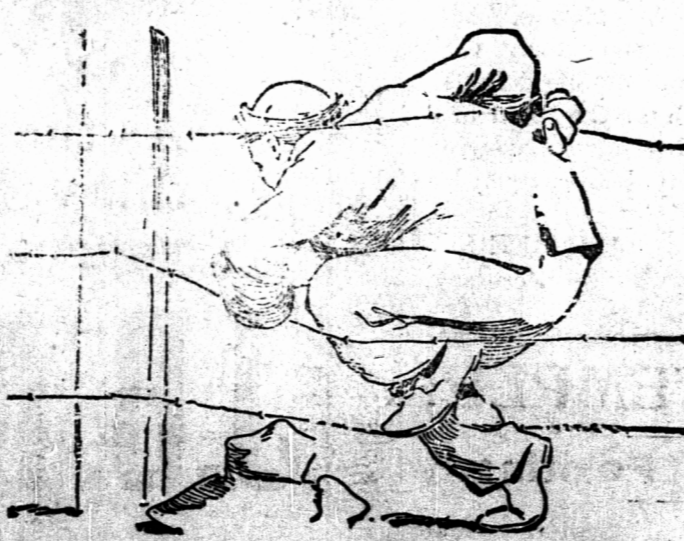

## WORK ON SEWERS

Nine Miles Completed  
During Summer.

### MANY APPLICATIONS

Have Been Received—Three  
And a Half Miles to Be  
Laid in 1900.

The work on the sewers is practically  
ended for the present season. Some of  
the houses, however, are still being  
connected.

The western pumping station is now  
in operation and houses on that part of  
the system can use it. Everything is  
completed as far as reservoir and pump-  
ing station are concerned.

The Sewerage System of Charlotte-  
town is in three sections which are  
divided as follows: 1st, the gravity  
system. 2nd, the western reservoir  
pumping station system. 3rd, the  
eastern reservoir and pumping station.  
In the eastern section all clear of the  
gravity system flows naturally to the  
reservoir at the Gas House, on corner  
of Cumberland and Dorchester streets.  
It is then pumped through a cast iron  
main to the corner of Weymouth and  
Richmond streets where it strikes the  
gravity system.

In the western section it flows to a  
point at Government Pond, or a point  
to the extreme west of Fitzroy Street,  
where it is pumped to a point at the  
corner of Pownall and Fitzroy streets,  
where it connects with the gravity  
system.

The western section will be in opera-  
tion about the 4th of December. That  
practically completes the system south  
of and including Euston Street and the  
Brighton Road.

There remains about three and one  
half miles of pipes to be laid in the  
summer of 1900, the main line of  
which begins at Longworth Street con-  
necting with the part already com-  
pleted at the Brighton Road.

It is estimated that about nine miles  
have been laid during the present sea-  
son. Many readers are possibly not aware  
that as many as 179 applications have  
been made for connection with the sys-  
tem. For the same time in the year 1888  
when the water works were completed  
there were only 154 applications. The  
following is the clause in the by-laws  
and regulations of the Charlottetown  
sewerage system governing applicants:

"All applications for the laying of  
service pipe from the Main Sewer shall  
be made in writing at the office of the  
Commissioners of Sewers and Water  
supply on forms supplied by them. In all  
cases the statutory fee of ten dollars shall  
be paid in advance and where the house  
or building is back from the street  
line the additional connection from  
the street line to the building shall be  
made at the cost of the applicant under  
the supervision of the Commissioners."

## BLOODY BATTLE

With Insurgents in State  
of Bogota.

### SHEEP RANCH RAIDED

Blair Nominated in Resti-  
gouche—Large Steamer

were killed and 3,000 wounded while
