THE license fund, deposited in the bank by the Dominion License Commissioners for Kingston, has been appropriated by the Ontario Government.

THE people of North Lake are expecting the Dominion Engineer there shortly to complete the survey of the Lake with a view to making a harbor of it.

THE Northern Light left Pictou at seven o'clock this morning, with mails and passengers, but up to going to press, has not reported at Georgetown.

THE mails from Upper Provinces and the United States have been ordered by the Cape. If the Northern Light makes regular trips, the Nova Scotia mails will come and go by her.

A MALIGNANT type of diphtheria has appeared at Campbell's Cove, King's County. Angus A. Campbell lost one of his boys by it; a young chap of 15 years. He was only two days sick. Other members of his family are now laid up.

A LIVELY meeting of the Caledonian Club Debating Society took place last evening. J. W. Morrison, Esq., occupied the chair, and John S. McDonald, Esq., opened the subject, "Would Waterworks be Beneficial to Charlottetown." An interesting discussion followed, and the debate at 10 o'clock was adjourned until Monday evening next.

VAPOR FUEL.—Articles of incorporation of the National Transportation Motor Company were filed at Albany, N. Y., on the 1st inst. The company is organized for the purpose of supplying and using appliances for the manufacture and generation of vapor fuel on steamships, locomotives, &c. with a capital of \$5,000,000. The capital of this company is the largest ever recorded since the act of 1875, and reaches the extreme limits of the law.

DURING 1884 the wheat exports of San Francisco were worth \$17,233,408, and there is plenty of wheat still on hand. The export of merchandise reached \$37,235,500, and the foreign importation \$35,319,400. The wool product of California was 37,415,300 pounds; quicksilver \$439,280, and the treasure shipments, \$17,539,000. The duties collected amounted to \$6,410,400, internal revenue, \$2,700,000, bank clearings, \$556,359,700; and the population of the state increased 20,000.

SUPREME COURT.—The case of Buchanan vs. Pausing and others, is about closed, and will go to the jury this evening. The counsel on both sides have addressed the jury, and Mr. Justice Hensley is now delivering his charge. The next case to be tried is a criminal one, viz: The Queen vs. McIntyre, an indictment for forgery. There is also another indictment for a like offence against the same man which will be tried after the first. When these two criminal trials are over a portion of the jury will be discharged.

Western Items.

(From the Journal.)

Captain Arthur Irving, of Cape Traverse, is building two new ice-boats. They are nearly completed and reflect great credit on the builder, Mr. Robert Campbell.

A match race was trotted on the ice at Cape Traverse for \$10 a side on the 17th inst., between Mr. Crockett's mare, "Flora Temple," and Mr. J. Manson's horse, "Carleton Boy." The latter won easily in three straight heats.

Mr. Allison, of the Dominion Public Works Department, visited New London Harbor early this week, for the purpose of inspecting the breakwater at the Sandhill Point, which has been considerably damaged by the Autumn storms.

The people about Tignish are considerably worked up over the late forgeries, etc., which have been perpetrated at that place. As this is something new in the history of events in that section, they trust the guilty parties will be brought to justice.

Messrs. J. H. Myrick & Co., Tignish, have purchased the store formerly occupied by Hon. J. C. Pope, of Summerside, and have it all ready for moving to the square near the railway station. It is their intention to start a branch store there.

A grand Skating Carnival at the Rink is spoken of for Wednesday, 11th February. Summerside Carnivals have always been highly successful, and we expect to see the coming one fully equal to those of past years. Carnivals have always been a very popular form of amusement here, and a big crowd may be expected at the rink on carnival night.

Mr. William McDonald, who was instrumental in saving the lives of Mr. Noonan and family recently, was the recipient, a few days ago, of a handsome purse, made up by the people of Summerside, in recognition of his bravery on that occasion. This is the second time Mr. McDonald has been the means of saving lives from drowning, the first being that of a Mr. McIntyre, a Rustico, last summer.

Mr. S. W. McKinnon, of the Canadian Pacific Railway, Winnipeg, is at present visiting his relations and friends at Kensington. Mr. McKinnon has been for about ten years in the Northwest, during which time he has held a position as locomotive Engineer on the C. P. R. He was, we are informed, the first engineer who drew a passenger coach over the summit of the Canadian Rockies.

A public meeting was held at Stanley Bridge on Saturday evening last, at which it was decided to give Mr. Brown, the engineer, \$100 to survey the proposed Branch Railway to that place. There was some difference of opinion as to where the branch should tap the main line—some contending for Bradalbane, others for County Line, and it is difficult to say which had the majority. Much will depend upon the Engineer's report. The survey will commence on Monday next.

In last week's issue we published the death of Mr. Ernest E. Robson, son of Mr. John Robson of this town. Mr. Robson left here early last spring and spent the summer with his brother in New York State, and with his sisters in Boston and Portland. At the latter place he took very ill, and in spite of the best medical skill and attendance, died on the 8th inst. His remains were taken to the "Friends' Cemetery, Portland, and laid in a pretty spot beneath the shade of the trees. He will be much regretted by all his acquaintances. His parents have our sincere sympathy in their affliction.

A much respected, well-to-do farmer, who lives in Alma, and whose family consists of his wife, three sons, and a servant girl, were nearly poisoned a short time ago. The latter, as usual, got breakfast ready on the morning of the 19th inst., consisting partly of oatmeal porridge. After partaking of this dish, all took suddenly ill with severe vomiting. In this condition they remained until about 9 o'clock, when a neighbor called on business. Realizing the situation, he at once harnessed a horse and drove to Alberton, a distance of about five miles, and brought Dr. McLean, under whose skilful treatment the men have recovered. The lady of the house and the servant girl are still ill. No one can understand where the poison came from, as there has been none in the house for years. The Doctor says there was a large quantity of poison in the meal.

CIVIC ELECTION BY THE MAYOR

IN pursuance of an act of the General Assembly of this Island, made and passed in the forty-third year of the reign of Her present Majesty Queen Victoria, intituled: "An Act to amend the Act of the eighteenth Victoria, Chapter thirty-four, intituled 'An Act to Incorporate the town of Charlottetown and all Acts amending the same'."

I do hereby give Public Notice that an Election of a Mayor and one person to Serve as a Common Councilman in the City Council for each Ward of said City,

Being in all a MAYOR and FIVE COMMON COUNCILMEN, will be held on

Wednesday, the 28th day of January, A. D. 1885,

At the several places, that is to say:

- In Ward No. 1, at or near the store of Messrs J. & T. Morris, corner of Queen and Water Streets.
 - In Ward No. 2, at or near the house of Thomas Connolly, opposite Mr. R. Hearty's Warehouse, Sydney Street, between Great George and Prince Streets.
 - In Ward No. 3, at or near the Market House.
 - In Ward No. 4, at or near the Fire Engine House, fronting on Kent Street, east, between Weymouth and Cumberland Streets.
 - In Ward No. 5, at or near the house of Widow Tierney, corners of Euston and Great George Streets.
- And at the said Election the Poll will be opened at nine o'clock in the forenoon, and continue open until five o'clock in the afternoon of the same day.

DESCRIPTION OF WARDS.

- Number One shall comprise all that part of Charlottetown which lies south of Dorchester Street, and the parcel of land formerly known as the Military Barrack Ground.
- Number Two shall comprise all that part of Charlottetown which lies south of Richmond Street and north of Dorchester Street.
- Number Three shall comprise all that part of Charlottetown which lies south of Grafton Street and north of Richmond Street.
- Number Four shall comprise all that part of Charlottetown which lies south of Fitzroy Street and north of Grafton Street.
- Number Five shall comprise all that part of Charlottetown which lies north of Fitzroy Street, including the Common of the said Town.

NOMINATION DAY.

Act 43, Victoria, Cap. 15.—Seven Days before the time of any and every election for Mayor or Councilors, the Person or Candidates for the office of Mayor or Councilor shall give their names in as such Candidates to the City Clerk, and the City Clerk shall duly enter the names, residences and additions of such persons, together with the office and wards for which they are candidates, and such entry, when made, shall be deemed nomination for such candidates.

There shall be paid by each person so nominated for Mayor, at the same time, a fee of ten dollars, and by each person so nominated as Councilor, a fee of five dollars, which sums shall go toward paying the cost of the election.

No person shall be qualified either for the office of Mayor or Councilor unless such nomination be made in manner and the time aforesaid.

The time appointed for the nomination of candidates, shall be from the time of twelve at noon, until the hour of four o'clock in the afternoon of the day fixed for that purpose.
