Law and Order.

We are glad to be able to give to our  
city no second place as a law-abiding,  
temperate city. The test on Wednesday  
and Thursday was a severe one for the  
Canada Temperance Act. We never re-  
member—not even in the old fair days,  
when all the country came to town—  
seeing our thoroughfare so thronged  
with people. The double attraction—the  
regatta and the provincial exhibition—  
brought as well the sturdy farmer as  
the sporting youth, to enjoy the time.  
No rowdiness, no drunkenness, marred  
their enjoyment; and at no time did we  
feel prouder of our Island city than when  
we joined the happy sight seers, con-  
vinced that Exhibition day, as a day of  
licentious revelry and disorder, was  
only a memory of the past.

A great moral victory has been won;  
and we know of none greater than the  
sight of a people obeying its own laws.  
When the hand that meets out the pen-  
alty to the law breaker is firm, with  
swift punishment, good men take heart  
and courage; and the immoral offender  
soon finds his place is gone. We speak  
not of any particular law. It is not the  
subject matter of the law—it is greatly  
more its obedience and enforcement  
which affects the moral status of a peo-  
ple. The parchment letter of the statute  
is a dead and idle thing until the breath  
of life in it steals its way into the con-  
sciousness of the people; and no law is  
made conscious until the double truth is  
made plain, that it is necessary and that  
it cannot be broken with impunity. We  
believe that it is so learnt in this city  
with respect to the Canada Temperance  
Act; and we hail the knowledge with  
intense satisfaction.

## To the Editor of the Examiner.

MR. EDITOR,—Happily it is not often  
that a whole community has reason to com-  
plain of an outrageous wrong forced upon  
it by its political rulers, and it cannot be  
expected that an intelligent people will  
passively submit, without raising their  
voices and seeking redress.  
For many years past the Belfast Post  
Office has been located in the village of  
Eldon, which all acknowledge to be the  
proper place. Fearing the removal of the  
office from the village, on the resignation  
of the Post Master—a few weeks ago—a  
petition, signed by about thirty of the  
most influential electors in the district—of  
all political creeds—was forwarded to Ot-  
tawa, humbly recommending the appoint-  
ment of a gentleman who resides in the  
village and who, both by his past experi-  
ence and general knowledge, all are agreed,  
is eminently qualified for the office.

Our wishes were entirely ignored, for,  
strange to say, these in authority, instead  
of granting our simple and just request,  
have appointed as Post Master, one who  
resides some distance from the village, in a  
situation not very convenient to the mail  
courier nor the public, and who, though  
obliging, honest and industrious, makes no  
pretensions to such accurate knowledge as  
the Postal Department requires, and who  
further declares that "he never asked for  
it; it was shoved on him as there was no  
one else to take it."

The key to all this is simply the follow-  
ing: The former gentleman is a Liberal,  
the latter a Liberal Conservative, and for  
this trifle which is probably a mere accident  
the whole community must suffer grievance  
and inconvenience to perpetuate the worst  
of all policies, "To the victors belong the  
spoils." We elect our Representatives to  
place and power, to remove injustice,  
redress grievances, and grant us all the  
facilities and privileges of a free country,  
and in this instance they would have better  
succeeded had they acceded to the wishes  
of a community who are endeavoring to  
remove the partition lines, that the rant of  
bigoted and narrowminded politicians has  
established in the past. Trusting that this  
grievance will be speedily removed, and  
thanking you, Mr. Editor for your valuable

## To the Editor of the Examiner.

SIR.—In your issue of the 8th inst.,  
appeared a communication, purporting to  
have been written in Charlottetown, cap-  
tured "Drunkenness in King's" which, in  
justice to the people of King's demands a  
prompt denial. The writer with pardonable  
pride boasts of the extinguisher, put upon  
run selling in the city, and laments over  
the amount of drunkenness he witnessed in  
Georgetown on the 3rd inst. By omitting  
to state that the 3rd was Exhibition day,  
the writer leaves the public to infer that  
such is the case every day, and in the same  
arrogant manner asserts that this deplorable  
state of affairs is due to the laxity of In-  
spector Kearney. In subject I beg to in-  
form your correspondent, and others he  
may have misled, that the sale of spirituous  
liquors in Georgetown, and this County in  
general, is reduced to a minimum at pre-  
sent, and cannot be compared to that of  
the western Counties. It is true there  
were some signs of intoxication in Geor-  
getown on Exhibition day, but it must not  
be inferred from this that drunkenness, on  
ordinary occasions, is on the increase, or  
even perceptible; nor is it a fact that In-  
spector Kearney is derelict in his duty.  
I am in a position to know that that official  
is leaving no stone unturned to bring offend-  
ers to justice, and from all I can hear he is  
considered the right man in the right place  
—your correspondent's opinion to the con-  
trary notwithstanding. Judging from the  
tone of your correspondent's remarks, and  
the tenor of one or two other letters on the  
same topic, I am inclined to think that the  
writer must be a disappointed candidate for  
Mr. Kearney's position, who would doubtless  
deal summarily with him if it lay in his  
power. It would, however, be more  
prudent for correspondents not to inflict  
such a sweeping condemnation upon the  
inhabitants of a whole County in order to  
be revenged upon one individual.

Apart from the symptoms of intemper-  
ance visible in Georgetown on Exhibition  
Day, there is scarcely such a thing as  
drunkenness known in King's County.  
Even on that day there was hardly a man  
from any part of the country, drunk or  
sober, to be seen in the town at eight  
o'clock in the evening. So much for the  
veracity of your correspondent. If he had  
visited Summerside, and other assemblages  
nearer home, if he is not a person of the  
above stamp, he would hesitate before  
branding King's County as he has done.
