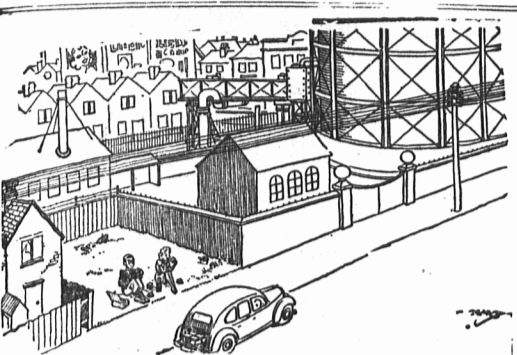

**PUBLIC NOTICE**

**The Highway Traffic Act**
