

Local and Other Items.

QUEBEC is shipping large quantities of potatoes to the United States.

THERE are now six war vessels in Halifax port, and probably there will be three more before the new Governor-General arrives.

ONE milling establishment in Ottawa has purchased this season, from farmers in the Ottawa District, nearly 100,000 bushels of wheat.

THE Small Debt Court, before R. R. Fitzgerald, Esq., is in session to-day. There are one hundred and twenty cases on the docket.

THE ladies of the Temperance Union will thankfully receive donations for a fancy table or tea at the Reform Club parlor the day before Thanksgiving.

JACOB HUFF was tried recently in the Interim Sessions, Belleville, before the County Judge, on a charge of burning five hay-stacks in the township of Rawdon, the property of William Little. Judgment was reserved.

THE members of the Local Government of Nova Scotia have been returned by acclamation. Under the leadership of one so able and so prudent as Mr. Holmes, the Government of Nova Scotia will, without doubt, be wisely administered.

ONE case for trial at the Stipendiary Magistrate's Court this forenoon—an old man named Moar who was found very drunk rolling in the "beautiful snow" on Market Square yesterday morning. He was excused with \$1 or four days.

TOO MUCH CREDIT GIVEN.—A letter to the Montreal Witness, signed "Storekeeper," says that the curse of Montreal is credit—that is, speaking commercially, "it is the bad debts on the books of retail merchants which invariably cripples them, and pulls them down at last."

THE BRIDGES SPECIAL SMASH UP.—The engine was rendered a complete wreck; one of the driving wheels was smashed and the other three were strained from the axles; the frame of the engine was broken; the connecting rods badly bent, and the cab wholly demolished. In fact, such a complete smash to any engine has not taken place on the Intercolonial but once before. The damage will be at least \$4,000.—*Moncton Times*.

ANOTHER HALIFAX VESSEL LOST.—Information was received at Halifax yesterday that the brig, "Comrade," hence Oct. 2nd for Jamaica, had been abandoned at sea; crew saved. No further particulars. The "Comrade" was a vessel of 123 tons, built at P. E. Island in 1868, owned by Messrs. J. T. & A. W. West, of this city, and hailed from Halifax. Vessel and cargo were insured in the Ocean Office, of this city, for \$7,500, and in the Nova Scotia Office for \$4,500.—*Hal. Herald*.

BERNICH, the itinerant showman who visited this and other cities in Canada exhibiting a trained bear, was devoured by that animal in Weldon, W. C. Bernichi, who was drunk, came forth with Bruin and told the crowd and bystanders that he would show them something they had never seen before. He unfastened the muzzle and took it off. No sooner had this been done than the pot bounced him and commenced to "chaw" on his throat. The poor man yelled, but as he was in the habit of yelling and making a great noise when he was exhibiting the bear, no attention was paid to that. Presently the blood gushed out, Bernichi fell. Some one then rushed to his assistance, and found that he was dead. The bear had taken a large piece of flesh out of his neck and devoured it, and in a few minutes the showman was dead. The struggles of the man with the bloody monster were terrible. The bear was shot and Bernichi was buried in the town cemetery.

DAVID R. GLENN, an elderly Scotchman, who belongs to P. E. Island, and is a pianoforte maker, had Mrs. Mary Tyner (whose husband is a fisherman and keeps a tavern on Mill street, St. John, N. B.), arrested on Saturday afternoon on a charge of stealing from him a \$70 gold watch and \$74 in cash. The *Sun* says: His story was that he had sought lodgings at Tyner's, the night before, preferring to stay there, he being an Orangeman, rather than go to the boarding house of Mr. Costigan, as the latter was a Catholic. He turned into bed helplessly drunk, with his clothes on, at 11 o'clock, and, although unable to prevent any interference with his pockets, he says that he remembers perfectly the actions of Mrs. Tyner; that she came into his room about 1 in the morning, took his watch out of his vest pocket, assured him that she did not intend to keep, and got the key from him to wind the watch; that she then cut open a rule pocket in his pants in which he had the \$74, and some time afterwards watch and money were both gone. When the case was called, Glenn skipped out of the courtroom, and had not returned when the magistrate was ready to proceed with the case. Search was made, but he was not to be found. The magistrate ordered a postponement until Monday, which was objected to by Mrs. Tyner, who pleaded that all her witnesses were ready to have the trial proceeded with, and she wished to have the case go on. The magistrate, however, remanded the defendant to jail, refusing the bail, which was offered by her husband.

Local and Other Items.

THE contract for the Senate *Hansard* has not yet been awarded.

WORK on the Coteau Landing Railway has been abandoned for the present.

THE partial elections for the return of the recently unseated Councillors takes place to-morrow.

OTTAWA promises to be full of life this fall. The advent of the new Governor-General and the Princess Louise is looked forward to with great interest. A rush of visitors is expected, and extensive preparations for their accommodation are being made.

THE Court of Chancery is still in session on the application to dissolve the injunction granted to Thomas Alley, Esq., to prevent Messrs. Duchemin Bros. from using a steam engine and boiler in their factory. The counsel for the Plaintiff—Mr. Hodgson—is still pressing the argument he commenced yesterday.

THE partial civic elections take place to-morrow. Little or no interest appears to be manifested in them, and it is as yet improbable whether one of the seats vacated will be contested by any one. However, we have authority for stating that Mr. S. W. Crabbe will be in the field for Ward 3, and Thomas Morris, Esq., will be re-elected for Ward 1 without opposition. It is rumored that a third party will oppose Mr. Davy in Ward 3, and that Mr. Peake will not offer for Ward 1. Mr. Hertz will not seek re-election in Ward 3.

A NOVEL BRIDGE.—At the shops of the Prince Edward's Island Railway, a bridge is being constructed out of iron rails. It is a lattice girder, 31 feet span; the top chord is formed of three rails laid parallel; the bottom chord is formed in like manner, the lower rolls being placed in an inverted position. The diagonal bracing is formed of short pieces of rails, bent at the upper and lower ends and twisted with a half-turn in the middle, so as to cause the flanges to come in conjunction with the flanges of the top and bottom chords. The flanges are then riveted together with 3/4 inch rivets. At each place where the braces and counters meet the chord, a half inch iron plate is introduced, which binds the three rails of the chord together. The rails used are 40 pound iron of the Sandberg pattern. The bridge is designed by Mr. G. C. Cunningham, chief engineer of the road.—*Monetary Times*.

THE Halifax *Herald* of the 4th says:—The steamer "Worcester," which sailed on Saturday evening for Boston, put back yesterday morning disabled. When about five miles south of Sambro, at 10 1/2 o'clock on Saturday night, the head of the cylinder blew out and the connecting rod broke. The mate immediately started for Halifax in a boat, and secured the services of the tug "Goliath," which towed her into port about 11 o'clock yesterday morning. While waiting for the tug, the "Worcester" drifted about thirty-five miles further out to sea. It is expected that the repairs will be completed by Wednesday evening. The material is on the way from Boston, and the work will be done by her own engineers. It was fortunate the accident happened so near to port, as otherwise the consequences might have been serious had she encountered any of the gales which have been so prevalent this season. No one was injured.

TO-DAY the celebrated assault case between the three belligerent females of Mount Stewart was brought before Theoph. Peabrisay, Esq. The action is the result of a wordy quarrel which Mrs. McKinnon, the defendant, and Mrs. McNeill, the plaintiff, had some months ago. By the evidence it appears that, on the 17th ult., Mrs. McNeill took a stick from the vicinity of Mr. Taylor's mills, and Mrs. McKinnon, who saw this, twitted her with stealing Mr. Taylor's wood. Mrs. McNeill told her to mind her own business, and added that if all she stole during her life was put together it would far exceed the cost of the wood. Some heavy obscene epithets followed, and Mrs. McKinnon, in a violent passion, lifted a stone and struck Mrs. McNeill on the ankle, leaving a mark and causing considerable lameness. Again, on the 29th ult., Mrs. McKinnon's daughter Catherine, dressed in all gaiety, passed Mrs. McNeill's then peaceful abode, in the company of another young lady. As they passed, one of the sons said: "Look at that." "Deed," said she, "I do not want to look at that. Little you would think by her appearance now that she would get drunk and fight with her mother." A lively scene followed, and Miss Catherine fired two stones—one of which struck Mrs. McNeill in the side, doing serious bodily harm. Mrs. McKinnon and her daughter also threatened Mrs. McNeill's life, and said that the "would root her out of her premises before her husband would return from jail." They were fined 25 cents and costs and bound to keep the peace for a specified time.

It is stated that the route for the Eastern or North Shore section of the Q. M. & O. Railway has been surveyed to go through St. Vincent de Paul and St. Rose, joining the Western or Colonization Road at the latter place, thus leaving Montreal out at one side.
