LEAVES TO-MORROW.—The S. S. Coban will leave Quebec to-morrow for Charlottetown.

SNOW.—It is said that there is enough snow in the woods on the upper St. John to enable the lumbermen to employ their sleds.

SCOTT ACT.—Several new summonses have been served. To-morrow will be another "field day" at the Magistrate's Court.

OPENED TO-DAY.—The Pictou Branch Railway was opened to-day with appropriate ceremonies. A grand dinner is to be given this evening.

S. OF T.—Victoria Division Sons of Temperance will resume their regular meeting to-night at 8 o'clock. Members of other divisions always welcome.

TO REPORT.—The Water Commissioners will submit their Report to a public meeting of citizens, to be held in the Market Hall, on Monday evening next.

ON THE INCREASE.—The Telegraph says the reports of the chief of police show that the number of juvenile criminals is constantly on the increase in St. John.

BOARD OF TRADE.—The Board of Trade continues the discussion on Commercial Union this evening. It is expected that P. Blake, Esq., M. P. P., will open the debate.

EXTENDING THE TRACK.—The railway track is being extended from the Round House across the landing at Ferry Wharf, to the Steam Roller Mills on the old Duncan property.

A LUCKY MAN.—Mr. Joseph Brace, who resides on Water Street, St. John, and is employed in the country market, has received intelligence of the death of his aunt, in England. Her estate is valued at £9,000, which is to be divided among six persons.

DIPHTHERIA.—We learn that diphtheria is prevailing at Priest Pond, in the eastern part of the Island. Two deaths from it have occurred, one in the family of Mr. Joseph McPhee, and the other in that of Mr. Joseph Campbell. It is also in several other families in that vicinity.

A GOOD MOVE.—The managers of the Y. M. C. A. purpose starting classes in writing, arithmetic and book-keeping if a sufficient number of young men are willing to join. All persons interested, whether members of the Association or not, are invited to meet this evening in the Y. M. C. A. parlor at 8 o'clock.

ANOTHER CHANCE.—An imperial despatch to the Government states that the Lords Commissioners of Admiralty have decided to allow to colonial candidates who fail to pass at their first examination, an opportunity of being re-examined again in about six months, provided they are still within the prescribed limit of age.

THE COBAN.—The steamer Coban, en route from Quebec to Charlottetown, came in collision with the sunken lightship at Travers, a short distance from Quebec, and as a result had to return to port. Upon examination the damages were found to be slight, and she will resume work at once, sailing for this port to-morrow.

ST. ANDREW'S DINNER.—The annual St. Andrew's Dinner will be held at the Rankin House, on Wednesday evening next, commencing at nine o'clock. The Committee of Management have left nothing undone to add to the pleasure of those who attend. Tickets are selling rapidly, and those who have not yet invested should do so at once before all are gone.

NEW RAILWAY.—It is said that an application will be made to Parliament next session for an act to incorporate the Annapolis Atlantic Railway Co., and to authorize such company to construct a line of railway from Annapolis Royal to Liverpool, N. S., with a branch or branches from some point or points on said proposed line to Shelburne, Lockport and Barrington.

FALL HEERING.—Fishermen in the eastern section of the Island have been doing good work lately catching herring. Some of the nets set off Souris were filled with herring larger and of better quality than any that have been taken for years back. Several of the fishermen caught ten, fifteen and twenty barrels each, while Edward Cheverie, the highliner, caught thirty barrels.

FIRE.—We regret to learn that the horse-stable, new barn, full of hay, grain, straw, etc., a straw shed and many utensils in the farmstead of Mr. Samuel Drake, West River, were destroyed by fire on Sunday afternoon. The dwelling and one barn with granary and pigsty were saved—the barn with great difficulty. Mr. Drake's loss is very heavy. The fire originated with the children playing with matches.

ARRIVAL OF THE M. A. STARR.—The steamer M. A. Starr, Captain Ferguson, from Halifax via intermediate ports, and which was delayed somewhat by unfavorable weather, arrived here at eleven o'clock yesterday forenoon. She brought a cargo of general merchandise, and had Mr. A. L. Bridges as passenger from Port Hastings. She is now being loaded with canned meats, oats, pressed hay, etc., and will sail on return about midnight.

THE FIRST MEETING.—The first annual meeting of the Literary and Scientific Institute will be held in Caledonia Club Room to-morrow (Tuesday) evening at 8 o'clock, when the officers for the coming year will be appointed. The President will also deliver his opening address with an account of last year's work. Other matters of importance will be discussed at the meeting, and a full attendance of members and others interested is respectfully requested.

MAINTAINING A HOUSE.—A young man named Archibald McCormack, living in the neighborhood of Souris, got full of bad liquor a few days ago. For so doing he was remonstrated with by his father, to spite whom he went out to the stable and proceeded to brutally beat one of the horses therein with an axe. For thus exercising his muscles he was arraigned before Messrs. John McLean and James R. McLean, J. P.'s, who sent him up for trial at the next session of the Supreme Court. He was taken to Georgetown jail by Sheriff McDonald on Saturday evening.

TO-NIGHT.—The Boston Comedy Company open their season in Moncton to-night.

ACTION FOR SLANDER.—We learn that an action for slander has been commenced by the Stipendiary Magistrate of Charlottetown against the Rev. W. R. Frame.

IT PAYS EVERY TIME.—Robert Bonner once paid a New York paper \$3,000 for an advertisement and traced back to his information 4,000 letters. And yet some men think they can do business better without advertising.

HAS THE WORK CEASED?—No temperance sermons in City pulpits yesterday; but lots of drunkenness in the city on Saturday night and Sunday. Has the work of promoting temperance ceased now that a majority of 17 has been scored for the Scott Act?

STIPENDIARY MAGISTRATE'S COURT.—This forenoon William McCarey was sentenced to \$30 or 30 days for being drunk and out after hours; two young men charged with assaulting a countryman were remanded for eight days; and the two young men for burglariously entering the store of Patrick Monaghan, to which reference is made elsewhere, were held over for evidence.

OUR TRADE.—The value of dutiable goods entered for consumption in Canada during October was \$5,253,000 and the duty collected \$1,199,000. The grand total of goods entered for consumption was \$6,452,000. October's exports from Canada totalled \$10,841,000. The balance at credit of depositors in the P. O. Savings Banks at the end of October was \$19,779,000.

KILLED BY THE TRAIN.—The Scuris freight train, in charge of Conductor McKie, on Saturday evening ran into and killed a horse at Head's Crossing, near the St. Peter's Road. The animal was badly mutilated, and the timbers of the culvert into which the horse was thrown after being struck, were broken off at one end. The horse was evidently turned out to graze for the night, as there was no trace of harness or halter about him. We have not heard the name of the owner.

A FAT BABY.—There is on exhibition at 119 Granville Street, (opposite Kaiser's) a Newfoundland baby, 4 years old, 44 inches high, and weighing 150 lbs. She was a twin—the other died. This prodigy takes an interest in all childish affairs, toys, etc., and talks as any other child of her age. An idea of her proportions may be gained from the fact of her ankle being 18 inches around. The parents are ordinary sized people—the father weighs 167 lbs, and the mother perhaps 120. —Halifax Recorder.

THE DANGEROUS SIDEWALKS.—Time and again we have called attention to the dangerous condition of the sidewalks throughout the city, but as they continue in the same state it would appear as if the authorities do not intend doing anything in the way of giving citizens that accommodation to which they are entitled. The city, however, may have to foot up a bill one of these days, when some pedestrian sustains an injury through the defective and negligent state of the sidewalks, and then they will likely repair them. The City of St. John, on Friday last, was mulcted in \$2,000 damages, besides costs, for allowing the sidewalk of one of the streets of the city to get out of repair. The City Council here should profit by the St. John verdict.

TWO ISLANDERS ABROAD.—On Wednesday night, says the Transcript, three arrived from Prince Edward Islands at a Moncton hotel two men named Ross and Cameron bound for Bangor, Me., where they intended to obtain work in the lumber shanties of the State. The men took a room together at the hotel and went to bed. They were slightly intoxicated at the time. During the night Ross got up unknown to the hotel clerk, left without settling his score, and took the night train for St. John, en route to Bangor, Me. Cameron when he came down in the morning, was surprised at Ross' departure, and accused the latter of having taken with him his (Cameron's) purse, containing about thirty dollars, and a new fur cap, leaving his own old one behind. Cameron appeared much troubled over his loss. He was with Ross to have bought his ticket for Bangor, Me., here, but having no money he started on foot for Point du Chene to take the boat for the Island.

People say, says the Star, that the Province of Quebec is at a stand still. Nonsense. Those who say so do not read as they run. Look at the railways that have been built for the last ten years, and look at the railways now commenced or in contemplation. There is the Temiscouata, the St. Jerome, the Gatineau Valley, the St. Anne de Beaupre, and other lines already decided on or under consideration, while the Hon. Mr. Mercier has promised to run a line that will connect St. John with the Ottawa Valley and tap the head waters of the St. Maurice, the North River, the Rouge, the North Nation, the Gatineau, and the Ottawa. This will be a great undertaking. If continued to Sudbury on the C. P. R., it may take a great deal of the carrying trade to Quebec, but in any case it will open what explorers describe as a fertile country that can support an immense population.

It has been remarked that the converted Souix of the Indian Presbytery of Dakota during the past ecclesiastical year gave \$571 more to foreign missions than any other Presbytery in the Synod, and during the last Synodical year it gave to the nine Boards of the church \$234 more than any of the white Presbyteries of the Synod. It is becoming more evident every year that the white men will have to look to their laurels.

Archdeacon Farrar says that Cruikshank, the artist, offered \$500 for proof of a violent crime committed by a total abstainer from intoxicants, and the money remains unclaimed to-day. The Archdeacon says that he will give the same amount for proof of any one case, "either in the church or out of it, where drunkenness has been cured without total abstinence."

TELEGRAPHIC NEWS.

TROUBLED IRELAND.

A Demonstration Suppressed.

TROOPS IN CHARGE

LIMERICK, Nov. 27. An attempt made to-day to hold a demonstration in honor of the Manchester martyrs was suppressed by the police. The unveiling of a statue to commemorate the hanging of the men was set down as a portion of the programme. Fearing interference with the statue, a guard surrounded it during the night. Mr. McInerney, of New York, was chosen to preside and to address the people. The police then drew their batons and made an onslaught on the crowd. This was answered by stones. In the encounter many persons were hurt. Troops now occupy the thoroughfares. To-night a crowd stoned and hooted the police who cleared the streets with batons and bayonets. They met with great resistance and many constables were injured. The wounded were conveyed to the hospital. The police acted recklessly. The windows of hotels in the streets where the trouble occurred were filled with onlookers. Many taunted the police who replied, throwing staffs and stones, and breaking a number of windows. Thirty persons wounds were dressed.

Attack on the Salvation Army.

QUEBEC, Nov. 26. The Salvation Army was attacked on Thursday night by an organized mob of 600 French-Canadians, many of whom were students of Laval University. They sang French songs, assaulted the Army and stormed the barracks. The feeling among French-Canadians over the attack on the Army is very strong. They claim if the authorities will not allow them to enjoy the same privileges as the Salvation Army in parading the streets they will take the law into their own hands. Great fears are entertained as to the peace of the city, as the affair is dwindling down to race prejudices.

LATER.

QUEBEC, Nov. 27. Mayor Langier has written to the Salvation Army asking them not to parade the streets in a body until Wednesday next, when he will give them reinforced protection. It is rumored to-day that a meeting is to be held to-morrow night for the purpose of organizing a mob to attack the Army and their protectors on Wednesday should they parade. A large number of revolvers were purchased yesterday presumably for use last night.

Emperor William on the Situation.

BERLIN, Nov. 27. Emperor William to-day received the President and Vice-President of the Reichstag, who came to express the sympathy of that body with the Crown Prince. The Emperor said the ailment of the Prince was a severe visitation in view of his high position and great abilities for continuing and directing the policy of Prussia and Germany in a manner which would have enabled the Emperor to close his eyes in peace, what Providence might further decree none can tell; but it was the duty of all to bow to God, the Inscrutable Will. Universal sympathy was a great consolation. He desired peace although Germany was perfectly prepared to meet all attacks.

Hanlan Again Beaten.

SYDNEY, N. S. W., Nov. 26. The boat race between Beach and Robblee for the championship of the world took place to-day in the Nepeau River and was won by Beach. The race was an exciting one. Beach took the lead at the start, and though closely pressed by Hanlan, held it throughout, winning by two lengths. The contest was witnessed by thousands of spectators.

French Crisis.

PARIS, Nov. 27. M. Grevy, to-day, formally informed Rourier of his resolution to resign the Presidency. He said he would send a message to the Senate and Chamber on Thursday. Rourier proceeded to the residence of M. Floquet to announce the resignation. Motion to adjourn until Thursday will be made in both houses to-morrow.

Wishes to Retire.

LONDON, Nov. 27. Charles Carmichael, member for Dundee, Liberal Home Ruler, has applied for the Chiltern hundreds. He says he wishes to retire from Parliament, because he cannot steadily support Gladstone who, by his immoderate attitude hinders the granting of Home Rule to Ireland.

Fatal Storm.

MINNEOTA, Texas, Nov. 27. A heavy wind and storm, last evening, blew down a two-story building in which 70 negroes were dancing. Six were killed and twenty injured.
