**SHIP WRECKS.**

Bright. Sarah, Madgwick, master from Jamaica, bound to Quebec, with a cargo of Rum, Sugar, Coffee, Pimento, &c. lost on Mag. Islands on the morning of 20th November.

Schr. Sealer, Dunn, from Halifax to Charlottetown, was cast away on the North side of Pictou Island, on Saturday night the 22nd ult., and is a total wreck. There are various rumours respecting the disposition of the cargo; some persons from the Island assert that it was plundered; others that a sale was made by the master on the morning after the wreck for the benefit of all concerned. The magistrates of Pictou are investigating the circumstances, and if anything suspicious transpires, vigorous steps will be taken for having justice done.

Dunn received some injuries while getting on shore, and shortly after his arrival home died. His mother has since died, and was buried on Sunday last.

Bright. *Gipsy*, Baudains, sailed on Monday last for Liverpool;—she sailed some time since, but got ashore on Harbour's Mouth—unloaded her cargo—and since then reloaded—belonging to J. B. Cox.

The Schr. Young Henry, Gallant, master, bound to Halifax, was wrecked at St. Peter's Harbour on the 24th instant. She was laden with produce by Mr. John D. P. Coles.
