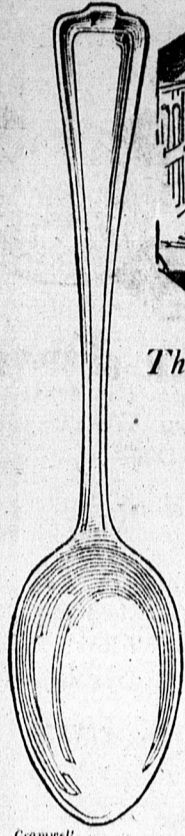

## Provincial Legislature

(Continued From Page Three)

Falconwood Hospital (\$102,200.)

Mr. Stewart: There is a little reduction here, and that is creditable. My hon. friends had a great deal to say about the late Government and their expenditures on this hospital during the war period and the last few years we were in power. Last year the expenditure was \$118,000 and that was pretty well above our mark. The prices today are as low as they were in 1918, so there is no reason why the estimate should not be down all so. I might remind my hon. friends that a reduction on this item was one of the planks of their platform. The economy so far is on the wrong foot.

Hon. Mr. Lea: It was \$119,000 in 1920. Prices rose and we had to rebuild a great deal of that building, spending thousands of dollars on it. Then we grew ten thousand bushels of roots, and we got some very modern appliances from the Sanatorium and Convalescent Home. If it were possible to get coal cheaper it would make a big difference in the expenses.

Mr. Dewar: What was your item for coal last year?

Hon. Mr. Lea: I can't give it to you off-hand, but it was very heavy.

Mr. Dewar: Was it up to \$30,000?

Hon. Mr. Lea: Somewhere around \$25,000 or \$30,000.

Mr. Stewart: I am afraid they will need all the coal they get. I hear that the tubercular patients have been moved from the other institution. If so they will need a lot of modern appliances as well as coal. So far as the repairs are concerned, my hon. friend knows we had a great storm just after the change of government about the condition of that institution but I think the government will admit that a great deal of the material was supplied by the late government. Repairs have always had to be made to the building so I cannot see much in that argument of my hon. friend. I remember just before the late government went out that the Grand Jury (the foreman of which was the Hon. James H. Cummiskey) visited that institution in January, 1919, and reported it in splendid condition. So I suppose some repairs must have been made by the late government. The items passed.

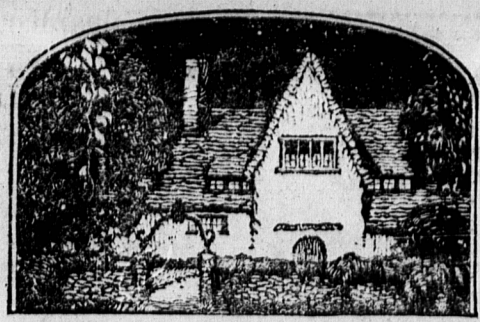

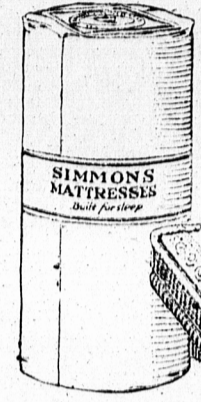

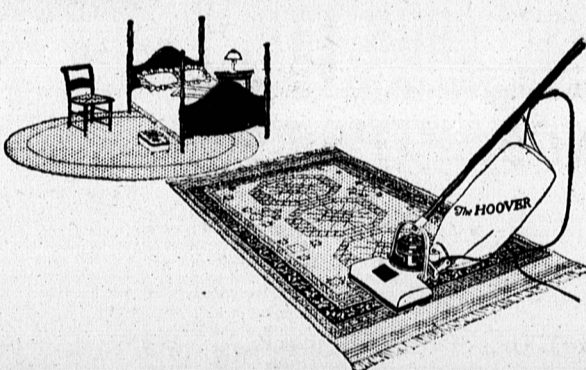

The Conservatives were in power we heard it said every year that because the interest charges were increasing the debt must be increasing. My hon. friends claim that they are reducing the debt, but the interest charges are still going up. It is a thousand dollars greater this year than it was last year. The rates of interest increased during our time, but that was not accepted as an excuse.

Premier Bell: One reason of this because we have had to overdraw on the banks as against the money that we got from Ottawa.

Mr. Stewart: And you have had a borrow for highways.

Premier Bell: That is one of the sources of the increased interest. We have been obliged to pay a higher amount of interest on account of the demands of the banks.

Mr. Stewart: You must have been increasing the demands considerably.

Premier Bell: Yes, but we succeeded in getting our interest at a cheaper rate than obtains in other provinces. We paid 6 per cent. to the banks at a time when the charge called for 7 per cent. in the other provinces. Now the prospect is that we will be able to get a reduction to 5 1/2 per cent. or probably lower.

Hon. Mr. Lea: The difference in the estimates this year is accounted for by \$100,000 maturing and bearing interest at 6 per cent.

Mr. Stewart: We had that, too, but you never gave us credit for it.

Mr. Kennedy: There's one thing more, and that is that the interest is increased. When interest increases the debt must have increased. That is a very fair argument. I think still our friends say they have a surplus this year. The very evidence to the contrary is furnished by the Premier himself sitting in that chair and passing legislation through this House for increase of interest which the tax-payers of the province have to pay! Isn't that evidence enough to show that there is something wrong? Surely by this time you would think that they would try to modify some of the statements he is trying to make! Surely he will come down to common sense. My hon. friend who uses a pen very often scribbling those great editorials in the Patriot—I notice he is over there in his seat tonight, and I suppose tomorrow that pen will be just as busy as it was today—surely he knows that he says things are perfectly all right when they are perfectly all wrong.
