

A Patriotic Speech.

In the course of his great speech on the question of disallowance of the Manitoba Railway charters, Sir Charles Tupper said: "There is not a man in this house but must feel that it would be a gross breach of faith, after that enormous expenditure, after we have risked even the credit of this country in order to accomplish this Herculean task, I say there is not a man on either side of this house but must feel that these older provinces would have a right to say we have been deceived and misled, if you permit a policy to be adopted that is going to take the traffic away from the line to the north of Lake Superior, and direct it into foreign channels, even at the bidding or in the interests of a certain section of the population of Canada. That trade we have all looked to, not only as a means of benefiting the older provinces, but of establishing close intimate commercial relations between the people of Winnipeg, of Manitoba and the great Northwest and the people of those older provinces. If we are to be knit together, if we are to become a nation, if we are to have patriotic aspiration, these things will be found in the policy of standing by each other, not in a single province asking that everything shall be conceded to it, regardless of the interests and feelings of which they belong or the side of the house on which they sit, what they think of this proposition. But yesterday the government of Canada came down here and asked this house to vote something like \$4,000,000—for what purpose? For the purpose of securing connection with a Canadian port as the eastern terminus of this great Canadian Pacific Railway. Will these gentlemen—I care not on which side of the house they sit—coming from New Brunswick, coming from the city of St. John, opposed to the present administration as they may be, after we have obtained a grant of \$4,000,000 to bring St. John 200 miles nearer the centres of communication in this country than it is by the Intercolonial Railway—will these gentlemen turn around and say, we are willing to divert this traffic, which you have shown your determination shall be Canadian traffic, intended to build up Canadian lines of communications and a Canadian port—we will turn our backs upon you and assist in diverting that traffic to the south, so that it will go to Chicago and St. Paul and on to the sea by another route. I do not believe it. I appeal to the independent sentiment of members sitting on the opposition side of the house, and I ask them to stand to their duty, not to their party, but to their country, in supporting a policy which in this regard is essentially a national policy—in supporting a policy that is going to maintain faith with the older provinces—that is going to realize to the older provinces that the most intimate and easy and rapid means of communication shall be kept up between St. John and Halifax, between the provinces of Nova Scotia, New Brunswick, Prince Edward Island, Quebec and Ontario on the one hand, and Manitoba and the great Northwest on the other. I say there is not a man in this house, I care not on which side he sits or what his political proclivities are, who will not say as we stand to-day in the presence of a threatened danger, the danger of having our own lines of communication on which we have expended so large an amount of public money, embarrassed and paralyzed—there is not a man to whom I cannot confidently appeal on such an occasion as this, to stand by the whole country. It is a painful position for me and my colleagues to occupy, after all we have done for the province of Manitoba, and the city of Winnipeg and the great northwest, after the support they have unanimously given us at the recent elections, it is an embarrassing position to stand for a single moment in contact with the hopes and sentiments or even the prejudices of any considerable portion of our friends; but we owe something more to Canada than to any personal consideration for ourselves, and that debt can only be discharged by independently, at any cost—aye, at the cost even of alienating the political support of these gentlemen which we have had the good fortune to obtain, and which we value so highly—even at that cost, we owe it to ourselves and to our country, straightforwardly and unflinchingly to pursue the course that, not our expectations of a couple of years ago, but the present exigencies of the country demand of our hands."

Dominion Parliament.

Mr. Moffatt, the new member for Restigouche, took his seat on Tuesday.
Hon. Mr. Foster has introduced a bill respecting the conveyance of liquors on board Her Majesty's ships in Canadian waters. He explained that the bill proposed to adopt the British Act, which made it penal and subject to fine on summary conviction of \$50 for any one to convey spirituous or fermented liquors on board Her Majesty's ships without the consent of the officer in command.
The Sun's parliamentary reporter says:—"After Prince Edward Island, Manitoba, Davies, two days ago, when sending the government for neglecting Prince Edward Island, complained bitterly about the millions which the Dominion had spent on railway construction in Manitoba. The people of that province, he then said, could get anything from the government that they wanted. Yesterday, Mr. Davies joined the opposition members in their clamor for justice to Manitoba, and charged the government with denying to Manitoba the railway connections which the province required. He declared that Manitoba was on the eve of rebellion, that the province was a unit in condemnation of the disallowance policy of the government, and that the government were turning a deaf ear to the despairing cry of the afflicted Manitoba. Only two days ago, and yet the bloated and pap-fed Winnipeg, growing portly on the bread snatched from the open mouth of the Charlevoix poor, has changed to an afflicted beggar, whose means of livelihood has been torn from him to satisfy the appetite of other provinces. Mr. Davies is not inconsistent. He is still 'agin the government.'"
Mr. Davies is like what Mr. Welsh said of his leader: "he has no principles to swallow."
Mr. McNeill's bill to amend the Civil Service Act sets forth that:—"The provisions of 'The Civil Service Act' so far as they render promotion in the Civil Service contingent in any degree upon examination as provided in the same Act, shall not apply to any civil servant who entered the civil service before the first day of July, one thousand eight hundred and eighty-two; and any civil servant who entered the service prior to that date shall be eligible for promotion in every respect as though such provisions as to examination had never been enacted."

An American tourist writing from Europe, says that the earthquake at Mentone was the only experience he has had abroad that he didn't have to pay for.
An autograph manuscript of Napoleon I., being a fragment of "Histori de Croise," which he wrote in 1790, has just been bought by an Englishman.
A lawyer asked a woman on the witness-stand her age, and she promptly replied: "Old enough to have sold milk for you to drink when a baby, and I haven't got my pay yet."
Herr Krupp has finished a forty centimetre gun, the biggest ever made at Essen. At a trial of the weapon, it shot into pieces armor 37 centimetres thick at a distance of 3,000 feet.
No sooner was it given out that Czar Alexander of Russia was a fluent practitioner of the cornet than a fresh attempt was made on his life. Human nature is the same the world over.
Miss Lille Field was found in a bog pen at Fergus Falls, Min., on the 28th ult., with her throat cut and her body terribly mutilated. A Hungarian servant named Haling is missing and is suspected.
Sir Alergon Borthwick, editor of the London Morning Post, requires all the copy in his office to be prepared on pink-tinted paper, by elegant young men who write with violet colored and perfumed ink.
It appears that the slander has circulated in Europe that Pharaoh's daughter married her own brother. An American Egyptologist has conclusively nailed this libel by proving that she married her own father.
The river Theis has broken the dykes at Crongrad, Hungary, and inundated 15,000 acres of land. The Temes and Hega have overflowed their banks, submerging 100 square miles of fields and twelve villages.
Thos. Robertson died suddenly at Kingston, Ont., on the 30th ult., of apoplexy. He was a witness in a case at court, and while being cross-examined he dropped dead. He was landing waiter in the customs.
On Saturday the peasants attacked the residence of O'Callaghan, at Westrop, Ireland, where 100 constables engaged in the Bodyke evictions are lodged. Many windows were broken. Twelve arrests were made.
A despatch from New York gives the particulars of a great but not entirely new project for an air line railroad between Boston and New York, shortening the distance to 193 miles and the running time to 3 1/2 hours.
The Italian chamber of deputies, by vote of 170 to 49, Monday, adopted a naval credit for 89,000,000 lire. The money will be expended on ironclads, torpedoes and forts. The credit is to extend over a period of ten years.
Lord Lansdowne has sent a letter to Mayor Stewart expressing thanks for the reception tendered him at Ottawa. He refers to the scene as a truly remarkable one and a wonderful demonstration of loyalty and significance.
The increase in railroad earnings continues to be well maintained. The thirty-nine roads which make their reports public for the fourth week of April had an increase, as compared with the same week of 1886, of over 9 1/2 per cent.
Herr Von Radowitz, German ambassador at Constantinople, declares that the article by Gen. Leflo, recently published in Figaro, in which it was asserted that Russia prevented Germany from attacking France in 1875, was incorrect.
A wooden cross has been erected at Bod-yoke, Ire., where the work of eviction has had to be stopped on account of the sheriff being seized with a fit, upon which are inscribed these words: "Praise the Lord, here the tyrant's work was paralyzed."
On his death bed, Wallace Christian confessed that he had murdered his brother Isaac fifteen years ago, and buried the body under the hearth of their residence, at Louisville, Ky. An excavation was made under the hearth and the skeleton was discovered which was buried by the side of the slayer.
United States Assistant Secretary Maynard has informed the collector of customs at New York that fresh fish, when imported for immediate consumption, are exempt from duty, no matter by whom caught or by whom imported, but if they are not imported for immediate consumption they are subject to duty.
Capt. W. L. White, one of the founders of the Kansas Daily Beacon, died on the 27th ult., aged fifty-one years. An hour before his death he was united in marriage to Miss Susanna Sebastian, to whom he had been for some time betrothed. The bride of an hour, who is a young woman, is heirless to his property, valued at \$500,000.
Mr. Oliver Latour, the well-known lumberman, has returned to Ottawa from Mattawa. He reports great excitement in that village over the discovery of rich gold bearing quartz in a hill opposite Mattawa close to the north shore, Ottawa river. On Sunday prospectors were busy at work all day blasting the rock, and villagers are filled with the belief that they have struck it rich.
Lord Colin Campbell's lines have fallen unto him in very unpleasant places. All the shame he thought to cast upon his wife's name was turned upon his own, and before the world, at the end of the divorce trial, he appeared in the saddest light. He is now drinking the dregs of his cup of bitterness, and appears before the world a bankrupt in purse and character. And it must be said there will be little sympathy for him.
