The Late Session.

A VERBATIM report of the Governor-General's speech at the close of the session, yesterday, appeared in THE EXAMINER of last evening! His Excellency refers in fitting terms to the most important measures of the session—the ratification of the Fishery Treaty and the blotting out of the exclusive privileges possessed by the C. P. R. Canada has all along done what she could to maintain the most friendly relations with the United States, and arrive at a just and honorable settlement of the fishery dispute; and she cannot be blamed if she should now, more rigidly than ever, enforce her laws against fish thieves. By the arrangement made with the C. P. R., the obnoxious monopoly privilege has been blotted out, the great Northwest made free to the enterprise of the people, and the C. P. R. enabled to improve and enlarge its continental system, —at a cost to the country which is merely nominal. It is not at all likely that the Government of Canada will ever have to pay, out of the coffers of the country, the interest which they have guaranteed; and, if they have, they can fall back upon the ample security afforded in the fifteen millions of acres of the best prairie land, of which they hold a mortgage.

The true policy of the future is, with all due economy, to hasten the settlement of the great prairies of Canada. The money obtained for land sold to settlers and others can be used in the reduction of the debt which has been incurred on account of the railway; and every additional settler will bear a share of the taxation, and thus help to lighten the burden imposed upon the taxpayers at large.

How completely the Opposition were out-generated during the session is manifest in the fact that they did not dare to divide the House on the Fishery Treaty, though some of them denounced it as a "National disgrace," "An unconditional surrender," "An infamous betrayal," etc.; and that the vote on the monopoly arrangement was nearly two to one in favor of the Government—the numbers being 112 and 60. The Opposition brought on a discussion of Unrestricted Reciprocity with the United States. The discussion did some good—it opened the eyes of the country to the great difficulties and dangers involved in the proposition. But it was, for the country, a very expensive discussion—one which might far better have been carried on during the recess at no cost to the taxpayers. From a party point of view it was a tactical blunder; for the Opposition were defeated by the largest majority of the session—a majority of fifty-seven.

We deeply regret that the interests of this Province were neglected in the Lower House,—worse than neglected: completely misrepresented by our own chosen representatives. Mr. Charlton could sneer at our railway as a useless burden, and Sir Richard Cartwright could refer to the \$20,000 a year added to our subsidy as a bad precedent. But there was no one to explain the peculiar position and requirements of this Province, as the Hon. Mr. Ferguson, or Mr. Hackett, or Dr. Muttart, or the other Conservative candidates would have done had they not been defeated at the polls. The men whom the people elected and trusted, seem really to have taken pleasure in prejudicing the case of this Province before the Parliament of the country. Take, for example, the conduct of Mr. Welsh, as set forth in Hansard of the 15th inst. It appears that the surveys for the proposed subway cost about a thousand dollars—\$1,072. Sir Richard Cartwright sneered at the project, and insinuated that the private opinion of Sir Charles Tupper was different from that of his official opinion concerning it. Sir Charles Tupper repudiated the insinuation, and pleaded that the comparatively small expenditure was justifiable, though he admitted that he was not sanguine as to the practicability of the work. Here was a splendid opportunity to set forth the great importance of having the Terms of Union with this Province fulfilled, in order that our farmers may have the advantage of high prices for early spring and late fall shipments of their produce and to enlarge upon the value of the opinions of the first-class Civil Engineers whose advice has been sought and obtained by Senator Howlan. But Mr. Davies—fluent enough when "the party" desire a man to talk against time—as was silent as an oyster. Dr. McIntyre, Dr. Robertson, Mr. Perry, and Mr. Yeo were equally silent. Only Mr. Walsh rose to say: "I do not want to kick up a row about this \$1,000 for these surveys, but I could have given all the information obtained by them for 10 cents I know the place well!" Again, when the grant of \$85,000 to build a pier at Cape Tormentine was under consideration, Mr Walsh rose to point out that "we have already very good harbors," to ask "what occasion is there for all the expenditure being made in building artificial harbors?" "what is the call for it?" and to say, "I never heard tell of any one in Prince Edward Island agitating for this communication;" "the Government are going to a great expense in these visionary schemes," Mr. Welsh misrepresented both the facts

and the views of the people of Prince Edward Island respecting the facts. The experience of every succeeding year has proved beyond a doubt that the Capes route is the route to which the chief care and attention of the Government ought to be directed. If only we had harbors on either side of the Straits, at these points, we could have earlier crossing in the spring, later crossing in the fall, and shorter and better crossing all the year round, than at any other points on the Island and the Mainland. Moreover, whether we eventually have a subway, or a steamer which will force her way through the ice, the crossing must be between the Capes. Every thing depends upon improving the harbors. But Mr. Welsh, forsooth, opposes his "notions" to carefully-prepared reports of accredited engineers, and tells Parliament that "there is no necessity for building these artificial harbors." To have, as one of our representatives, "the butt of the House," is bad enough, but to have our best interests misrepresented and sacrificed in this way, is much worse. Fortunately, Sir Charles Tupper was present to do effective service in our behalf, and Dr. Robertson put in a timely word as to the necessity of making communication "between the Island and the mainland as connected as possible," and having "one road for winter and summer."

This is but an example of the manner in which our special interests are unrepresented and misrepresented by those whom a majority of our people, in an evil hour, elected to the House of Commons. Yet some persons affect to wonder that our special interests are permitted to suffer.

The Fisheries Protection Service is to be fully maintained throughout this season.

Mr. Bell's speeches are usually as dense and long-continued as a Halifax fog; nor has he yet given any evidence whatever of administrative ability in matters of politics. But the public will, nevertheless, be surprised to learn that he is guilty of having revealed proceedings which took place while the Legislature sat "with closed doors." It is well known that to do so is a breach of honor and confidence, for which there is scarcely a precedent in British annals. Yet, if we have not been misinformed, the Pioneer of last week—edited by Mr. Bell—contains an article based on a discussion which took place in the House of Assembly when the doors were shut—a discussion concerning which every member was bound to secrecy. We presume that the Legislature will take Mr. Bell to task at its next meeting, and teach him that the simplest rules of Parliamentary honor cannot be violated with impunity.

"The Week" contains a lengthy critique of the works of art now on exhibition in Toronto. Of those of Mr. R. Harris it says:—

"Immediately beneath this is a little picture, 'Harmony' (175) by R. Harris, in front of which it will pay one to bring a chair and sit for half an hour. The painter has abandoned the painty sloppy manner of former years, also has tendency to redress in the flesh. The figure of whom it reminds one, could not have painted it better. It is the most artistic thing in the gallery—if the landscape men will excuse our partiality for figure pictures. 'Composing his Serenade' is necessarily less delicate and more off-hand in the painting; the right hand has been a trifle slighted, but the movement of picking a mandoline is there. 'The Tenor of Spruce Creek School' as a whole, is a complete failure. The right of the picture, the serious side, is very fine indeed, but the tenor in the left, the funny side, is not so utterly funny as it might be. The shadow projecting from the body at the same angle is a bad feature in the composition anyway, and Mr. Harris would do well to re-arrange it. 'The Chelsea Pensioner' (154) and a portrait (150). An exquisitely modeled gray picture of a little lady who might have sat to Farnborough, should not be overlooked. Mr. Harris is vastly improved since his last residence in England."

Reports from Toronto regarding the influx of British paupers have aroused discussion in England. Every desire is shown to meet the reasonable objection of Canada to receive destitute emigrants. The Liberal Daily News says we ought to keep our helpless people not only in justice to other countries, but as healthful discipline for ourselves. The Tory Standard says the language and sentiment of Canadians as regards destitute emigration agrees strikingly with that of Australasia as regards Chinese emigration. The colonies are old enough and strong enough to settle the point to their own satisfaction. The Radical Star says Canada's resentment at destitute emigrants gives a nasty blow to the quacks who advertise emigration as the remedy for every social difficulty. The Self Help Emigration Society, who sent most of the emigration to Canada this season, declare they only sent those proved to be suitable, and court the fullest enquiry. They have received a cable demand from Ontario for more farm laborers, but though they have many excellent applicants, the society lacks funds.

Queen's Birthday.

Among the attractions to-morrow will be the football matches at the Park. We understand that arrangements are being made to provide a band of music. The following will compose the Abegweit team, viz:— Back—F. Howatt Half-Backs—Geo. E. Robinson, D. H. Robinson, E. Iugs and Percy Macdonald. Quarter Backs—J. F. Wheat and Dr. H. Johnson. Forwards—A. H. McNeill, F. W. L. Moore, Eneas A. McDonald, D. Cameron and John McDonald. Spare men—Bruce Shaw and E. Matheson. The programme of the matches will probably be as follows:— Pictou vs Abegweits at 10 o'clock. New Glasgow vs St. Dunstan's at 11.30. New Glasgow vs Abegweits at 2.30. No. 2. Battery, G. A., will parade to-morrow forenoon at 11 o'clock, and at 12 will fire the general salute in honor of the Queen's Birthday. The steamer St. Lawrence leaves Charlottetown at 7 o'clock to-morrow morning, and will return at 7 o'clock to-morrow evening. There will be single fares all along the line of railway to-morrow. The steamer Eldon sails from Queen's Wharf to-morrow afternoon at 3 o'clock for Murray Harbor and Wood Islands.

NOTES AND COMMENTS.

Things Said and Done on the Streets and Elsewhere.

THERE are two concert companies in our city at the present time—the Weber Quartette and the Wizard Oil Co. The Quartette opened in Y. M. C. A. Hall on Saturday evening, and appeared again on Monday evening. They give another concert in the same place to-morrow night, and I trust they will have a large audience. They furnish a splendid programme and are deserving the patronage of our citizens. The Wizard Oil Co. also give a pleasing entertainment and are having good houses.

We are a musical community, yet we do not always employ talent when it comes amongst us. On Saturday evening the Weber Quartette were greeted with a small audience. On Monday evening there was a better showing; but not the patronage the performance deserved. It has been said that Saturday night is a bad night for concerts. There is something in this. There is also something in the nature of the performance given. Let a minstrel or variety show open up on Saturday night and they will have full houses. Bring along a first-class musical organization like the Weber Quartette and they are received with empty benches. What's the reason? Is it lack of funds or lack of taste?

The origin of the late disastrous fire is still, to use the language of latter day novelists, "shrouded in mystery." The prevailing opinion is that it was the work of an incendiary. The City Council have offered a reward of \$1000 for the conviction of the scoundrel who applied the torch. I hope the reward will have the desired effect. If there is any person in this community bad enough to do the nefarious deed it will be a good thing for the people if he is found out. There is no punishment short of life imprisonment too severe for a wretch of this description.

The City Council have donated \$100 to the Queen Square Gardens. I am not aware that the Local Government have taken a like step. If they have not they should at once. The keeping up of these gardens is a work which belongs of right to the Local Government and City Council. Each should place a sum sufficient in their estimates for that purpose every year. The people are becoming tired of the subscription business. It is being worked to death.

Speaking of Queen Square reminds me that it is about time a new fence were placed around it. The old one is becoming shabby, and should be replaced. Last year it was announced that the Dominion Government had granted a sum for this purpose; but so far nothing has been done. What is the reason? Have the Government gone back on their promise? Some Governments have a weakness for that sort of thing, but I do not think the present Government is "built that way." However, we shall see.

The call for funds to enable the Baptists of Charlottetown to rebuild their place of worship is being nobly responded to. Subscriptions are coming in from persons of all creeds. The Roman Catholics were among the first to offer their afflicted fellow-citizens the use of their hall in which to hold their services, and are now, I understand, not at all backward about tendering donations of money to the building fund. This is right. To-day the Baptists are the sufferers; to-morrow the Catholics may have their turn.

May or Haviland did a wise thing when he instructed the City Surveyor to see that the owners of property on the burnt district had the same fenced in without delay. It is hoped that the City Surveyor will insist upon the carrying out of the order. The city has one lawsuit on its hands at present as a result of carelessness in this respect, and evidently does not wish for another.

The fat has gone forth. Pigs and slaughter-houses must be removed outside the city limits during the summer months. Many of the poorer class of citizens think it a harsh proceeding on the part of the Council to thus interfere with their rights and privileges, and the carrying out of the by-law will no doubt, be attended with considerable trouble. Some of the aggrieved ones even go so far as to talk of testing the matter in the courts.

The Arbor Society have directed that Queen's Birthday be observed as Arbor Day. The Superintendent of Education has also directed that the same day be set apart as Arbor Day by the pupils attending the Public Schools. The joint programme has not yet been announced, but I suppose it will be similar to that of previous years.

In this connection it is pleasing to notice that the committee entrusted with the management of Hillsborough Square are also moving in the matter of tree-planting. I hope that they will see fit to make other improvements in the Square. I will remember when Hillsborough Square was a beautiful spot, when the trees and walks were nicely kept, and Galbraith's band used to delight our citizens with sweet music thereon. But that time is past. Let us hope it will return ere long.

To-morrow is Queen's Birthday. There will be the regulation salute from Fort Edward at noon; and football matches on the Park. There will also be an excursion to Pictou in the steamer St. Lawrence, and single fares all along the line of railway. I hear that some of our leading merchants talk of keeping their stores open all or a portion of the day, thereby preventing their clerks from taking advantage of the little enjoyment offered. I trust that the report is incorrect. The clerks have been working hard of late opening up new goods and well deserve a holiday. By all means let them have one.

The steamers are now running regularly, every speck of ice having disappeared from the straits; and the tree agents have resumed operations. The straw hat has also struck in; but the hurdy-gurdy man is a little backward about showing up. However much we may regret the latter fact, we shall have to persuade ourselves that spring, although somewhat slow, has got here all the same.

The insurance on it is as follows:— On Building.....\$2,850 " Tank, &c.....150 Total.....\$3,000

Empty Churches.

SIR,—In answer to "J. C." I may say Chappelle's Almanac is published by C's authority, and I have no doubt he accepts the responsibility of its dicta. I might justly, and perhaps with good reason, allege a want of denominational authority, for not complying with the request of "J. C."—"name the denomination." I might also shelter myself behind the newsgatherer's invisible cloak, as the author of the item "State of Maine Churches" did, and prefer generalization of circulation to centralization of specific knowledge; but I prefer the good old way of standing by my assertion, because it is true, and taken from denominational reports, which can be submitted, page and date, herewith; this only I qualify, that in using the term "churches vacant," I meant not the congregation but the pastor's absence, and quote the same authority for such usage, as for these vacancies, viz. Appendix 28, page xvii, Acts and Proceedings of G. A. P. C., 1887, where 5 congregations, representing 6 churches, are declared vacant, out of 69 churches and 29 congregations; of these 3 are still vacant and 2 have been supplied; but the reports of the Presbytery, published officially from time to time, show that there are now 32 congregations and 70 churches on P. E. Island, of which number 9 of the former, representing 14 of the latter (or 9 congregations with 14 churches), are without a pastor at present, viz. Summerside, Brookfield, New London North, Kensington, Georgetown, Richmond Bay West, West Cape, Campbellton, Morningside, Bedeque, Summerfield, East St. Peter's, Woodville, Little Sands.

Queen Square.

SIR,—The communication in yesterday's EXAMINER, with the three stars at its end (a mark of good brandy) meets with the approval of a good many of the citizens.
