Son's Wife Causes Rift With Shocking Charge

DEAR MARY HAWORTH: Our son Joe and his wife Jenny have lived with my husband and me twice in the few years they have been married. This was to help themselves in times of hardship.

My husband is a good man and good provider, who never has given me cause for worry. He is always ready to help anyone in need and so am I.

A year ago, Joe and Jenny moved into a place of their own for the second time. As Joe was working nights, he brought Jenny and the baby to spend some time with us. Dad and I took them home one evening.

Later, Joe came to us and accused his dad of trying to make love to Jenny. It seems she told Joe that Dad had taken her home alone, which wasn't true. I was with them and wrestled together as soon as we'd dropped her off.

I can't understand why she told this untruth but Joe believes her. He stayed away from us for months. Then, during a snow storm in February, his car broke down at 3 a. m. (he was en route home from work) and he called us for help. As I said, Dad is always ready to help.

Joe then started to visit us again and all was well until he asked us to dinner. Dad doesn't want to see Jenny or be near her. He says if she would tell the truth, he could forgive. Until then, he won't see her. This annoys our daughter, who says we are old enough to "forget it" and "take it in stride".

Meanwhile, Joe came to see me alone. He still believes Jenny's story but feels we should forget it, as he believes "Dad won't do it again." That was too much for me. I told him to leave.

What should we do? How work it out? A word to my husband from you would help. He has tried to write you several times, but breaks down as soon as he writes your name. Thank you.

DEAR S. C.: As I get the picture, whether Jenny is lying or telling the truth as she sees it, your husband's decision to stay away from her makes very good sense.

So tell him, for me, that I am not repeat: NOT - one who thinks he should try to patch things up with Jenny, superficially, while still adjudged "guilty as charged" by Joe.

As to the significance of Jenny's complaint to her husband, several possible explanations occur to me.

It could be that Jenny was tired of being dumped on Dad's doorstep by Joe, as his juvenile wife way of letting his parents carry his responsibilities of looking after her, from time to time. Thus it could be that she coined the shocker charge about Dad's making a pass at her, to jolt Joe into cutting out the "leaning on papa" bit.

Or it could be that Jenny imagines herself to be irresistible to males and, also has a very limited relationship potential in respect to them. In the sense she is a stranger to love experienced as family affection. In her ignorance on that score she might misconstrue Dad's characteristic fatherly kindness as improper "sex interest" in her.

On the other hand, there is the possibility, as all mature minds recognize, that Dad may have felt a happy glow of natural manly appreciation of a comely young daughter-in-law's female attractiveness, a tribute that glinted in his eye or warmed his attitude towards her.

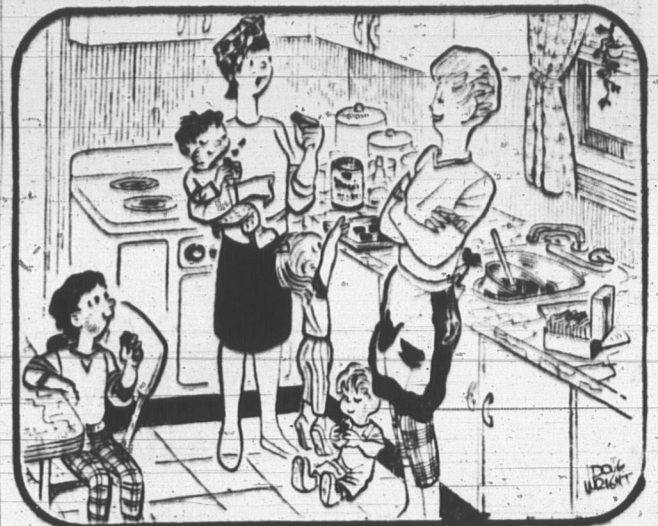
The envelopes were opened by Glenna Jordan while Vera Somers read the enclosed verses. The evening was spent with games and dancing to music
