Legislative Council Election.

CHARLES MACEACHERN, ESQ., THE CANDIDATE FOR THE FIRST DISTRICT.

We are glad to learn that Charles Maceachern, Esq., of Bayfield, Lot 46, has been selected by the Liberal Conservatives of the first district, as their standard bearer in the approaching Legislative Council election.

Mr. Maceachern has accepted the nomination, and there is little doubt but he will be elected when the time arrives. The Opposition, it is said, have some notion of trying Mr. Bowers again. He is not, however, the unanimous choice of his party, as several influential local men are kicking square against him; and, in case of a contest, their influence will be felt. Requisitions in his behalf are now being passed round the district for signatures. If a sufficient number of names be not forthcoming, the choice of a Grit Candidate may be considered as among the things to be settled yet. So far the requisition business has proved rather up hill work, notwithstanding the efforts of the resident Grit M. P. and the M. P. P. A number of the more independent ones who formerly supported the Grit party, are, it seems, determined to have a say in the choice of candidates this time. They see that the running of the Party machine has been too long in the hands of interested parties.

Mr. Maceachern, the Liberal-Conservative nominee, is a man of sterling qualities. Like his near kinsman, the late Hon. Emmanuel McEchern, he is a man of unblemished character. As a Justice of the Peace, he has long been one of the leading Magistrates of the County. Having at various times filled offices of public trust, he has in every instance acquitted himself creditably, and to the entire satisfaction of the public. The people of the First District know him well; the other men they do not know.

We trust that he may receive the hearty support of the free and independent electors of the First District of King's. By sending him to the Legislature they will honor the District by honoring one of themselves—one who is in every sense worthy the confidence and support of property voters.

The New City Bill.

It will be interesting to our readers to know about the amendment—perhaps it would be more correct to say the change—lately made in the Act Incorporating the City of Charlottetown.

First, as to taxes: In addition to the taxes which have heretofore been imposed, the Council have power to levy upon personal property, including goods, wares, merchandise, etc., and all movable things—except mortgages and money. Joint stock companies, including banks and branches of banks doing business here, are also liable to be taxed according to their profits, and Insurance Companies are subject to a license fee of \$50. Commercial Travellers doing business in the city may be compelled to pay license fees at the discretion of the Council.

The assessors are permitted to distribute by mail or otherwise a schedule which ratepayers are required to fill in, as follows:

SCHEDULE: Statement of Real and Personal Property of ——— liable to assessment: 1. Real Estate at its actual value. 2. Household furniture and moveable property in dwelling and premises occupied by subscriber. 3. Goods, wares and merchandises within the city. Total amount of ———. I, the above named ——— do hereby declare that the above statement is in all respects just and true, and that the sum of ——— dollars is the full value to the best of my judgment and belief of the real and personal estate for which I ——— (the estate of the person he represents) am liable to be taxed for the year ending 31st December, 1885.

Signature of Ratepayer. Instead of advertising the names of delinquent ratepayers in the Royal Gazette, the advertisements are in future to be published in any one or more newspapers issued in Charlottetown, for thirty days.

No voter who qualifies on his poll tax shall be permitted to vote in the election of any Mayor or Councillor, unless he shall have paid the poll tax at least one month before the day of the election.

If there be no opposition to a Mayor or Councillor—that is to say if there be but one candidate—he shall be declared elected without the formality of an election.

As to taxation, the bearing of the Bill as passed is diametrically opposed to the expressed desire of the people of Charlottetown. They proposed a measure which would reach all citizens and compel each person to contribute to the City Treasury according to his means. They have obtained a measure which, if enforced, will exempt from additional taxation persons in easy circumstances who are not in trade, and will materially add to the burden of the storekeeper, dealer and tradesman struggling to make ends meet,—a measure which will leave untouched property making revenue for its owners, while it heaps up the taxes on property which is unremunerative.

By what diabolical influence the change has been effected, is beside the question,—what are the Council going to do about it? The city ought to be made decent; and yet those who have plenty of money, and will take most pleasure in the improvement, are to contribute none of the additional taxes to be levied for that purpose. The Act is unjust; but it must be set in operation if improvements are made. Should the Council decide to go on and improve—or should they let the Act remain inoperative? That is the question.

We understand that the Board of Fire Underwriters, appreciating the determination of the citizens to construct suitable Waterworks without unnecessary delay, have (in the terms of its resolution of 30th February last) finally taken off the twenty per cent. added to the tariff in June of last year. The annual saving in premiums thus afforded is equivalent to the interest upon the whole estimated cost of the Waterworks.

Funeral of Hon. John Longworth.

At a meeting of the Law Society, held this forenoon, it was resolved that the members, as a tribute of respect for the memory of the late Hon. John Longworth, should attend his funeral in their robes. Mr. Longworth was President of the Society since its foundation until his acceptance of the office of Prothonotary last summer, and consequent retirement from the active practice of his profession.

Messrs. Charles Palmer, Q. C., Malcolm McLeod, Q. C., E. J. Hodgson, Q. C., and A. B. Warburton were appointed a committee to prepare and present a letter of condolence to Mrs. Longworth in her sad affliction.

The funeral of the late Hon. John Longworth took place at 2 o'clock this afternoon. The procession from his late residence to the Church, and thence to the Railway Station, was large and imposing. Among these present were His Honor the Lieut. Governor, His Worship the Mayor, the Judges, and leading citizens.

City Council.

The regular monthly meeting of the City Council was held last evening. Present His Worship the Mayor, the Chief Engineer, Councillors Crabbe, Koughen, Kelly, McLean, Davy, Hazard, McRae, Horne, Doune and others.

A report of rotten platforms, by the City Marshal, was submitted as follows: Platform corner of Pownal and Water Streets; from Judge Palmer's to Frederick Bavan's; from W. E. Dawson's to Robertson's forge; from Major Lane's pump to W. Weeks; in front of Robinson's, Euston Street, (bad); from Byles' corner to Knight's shop; in front of Andrew Doyle's, Grafton Street; in front of D. R. M. Hooper's; a very dangerous platform in front of James Fitzsimmons' east end of Dorchester Street—this is in a very bad condition.

Councillor Hazard moved that the public property committee have leave to let the building at the foot of Queen Street, lately occupied by David Small, by auction or otherwise. Carried.

The fire bell having sounded, Council adjourned to meet this (Tuesday) evening, at half-past seven o'clock sharp.

United States Debt.

Mr. Manning, the new secretary of the United States treasury, has adopted a new form in the monthly statement of the public debt, the result of which is to represent the debt as nearly a hundred millions greater than appeared in the old arrangement of the accounts. The interest-bearing debt at the close of March, placed at \$1,196,149,600 by the old form, is increased by Mr. Manning to \$1,260,773,112, by the addition of \$64,623,512, the amount of bonds issued to the Pacific railways, and the liability arising out of which appears not to have been considered in making up the debt statements up to this time. The amount of debt upon which interest has ceased since maturity is \$4,951,505, the same in each case, but the debt bearing no interest, that is to say the legal-tender issue, gold and silver certificates, and certificates of deposit, is nominally reduced \$98,500,000 under the new form, but, deducting the amounts of these held in treasurer's cash, and the amount of the fractional currency issue estimated to have been lost or destroyed. An analysis of the cash in the treasury is also made by Mr. Manning, previous statements having simply given the lump sum, by which it appears that out of a total amount of \$484,474,174 described as cash, only \$261,150,165 is available for the reduction of the debt, a reserve fund of \$100,000,000 is held for the redemption of United States legal tenders, and cannot otherwise be employed, and \$31,508,377 of fractional silver coin is also held which cannot be used to reduce the debt. The gross debt on April 1st was \$1,885,988,376, and the net debt \$1,502,579,184, an increase during the month under the new form of accounts of \$89,256, while under the old form a decrease of \$483,747 would have been exhibited.

The spirit of the world just now seems to be pretty generally belligerent. "Knock downs" in the legislative halls, quarrels among statesmen, Cabinets broken up, cities burning in the tropics, and rebellion among the half civilized in the far North, while red-headed war rages in the Sudan and in the Chinese kingdom. The great nations of the earth generally seem to be walking around with chips on their shoulders daring some other to knock them off. The condition seems to be endemic, epidemic, and contagious.

THE RIEL REBELLION

FURTHER PARTICULARS.

SITUATION OF THE TROOPS.

An Ottawa despatch of the 12th inst. says: "Gen. Middleton has reached within a few miles of Humboldt. Gen. Laurie caught up to him last night at six o'clock. Middleton has with him, or closely following him up, 860 men, including 46 expert scouts, who form the advance guard. He expects to reach the river and the enemy on Wednesday or Thursday. Three steamers and twenty scows will take the troops, who marched to-day from Swift Current to the Saska-che-wan, to meet the boats. They take two Gatling guns, and will drop down the men to meet Gen. Middleton at Clark's crossing. Crowfoot, chief of the Blackfeet, has sent a telegram to Sir John A. Macdonald, stating that he would keep faith with the 'great mother,' and not make war on whites. His young braves would spill no blood, but would go on their farms. He desired Sir John to keep the telegram to see how Crowfoot keeps his word. Middleton wires that Irvine is in Prince Albert all right, but short of horse feed and ammunition. The General considers Battleford safe. Mounted police are fortifying Fort Pitt. At Calgary are Gen. Strange, Capt. Stewart, the 65th, and Col. Smith's battalion. Just south of Gleichen are two battalions. At Swift Current, en route to the Saskatchewan, are Col. Otter, the Queen's Own, and half of company C. At Qu'Appelle are B Battery. At Winnipeg are Col. Scott's, the 35th and the 90th. With Gen. Middleton are A Battery, Winnipeg field battery, the 90th and the Ottawa sharpshooters. Following behind and expected to catch up, are the 10th and Winnipeg cavalry. Others are on the road.

THE SITUATION AT BATTLEFORD.

The Toronto Globe's special from Battleford, dated April 10, says: Since I wired you last the line has been down. It is now in good order again. Our position is very unsatisfactory. Indians raided the south part of the town on Monday, 6th April, and burned the store of Mahaffy & Clinkshell and next morning the government houses and stable besides a number of farm houses in the neighborhood. All settlers are in garrison here awaiting relief, but we can hold out against any band likely to attack us. Major Morris made a raid on the half-breed camp near the town last week and captured ten men, and a number of women and children. The latter are encamped near the barracks. On April 2nd the Indians at Frog Lake invited Quinn and others to a conference in their camp and shot them as soon as they entered. Twenty-five police and a few settlers are entrenched in the Hudson Bay house at Fort Pitt in a critical condition, being threatened from all sides and no possibility of aid being sent from here. They will, however, make a stout resistance and it is hoped successfully. A party of Stony Indians captured a police messenger on his way to Fort Pitt and took everything from him. He had to return to town. A band of Stoneys entered the settled part of the town yesterday and displayed great activity in gathering up parts and completing the raiding of the town. They opened fire on the police water carts which was so steady and long continued that the cannon was sent to cover the carts. A line of skirmishers also took a position on the bank, and their efforts were crowned with the killing of two Indians and three horses. None of our boys were hurt. The Saskatchewan is running and Battle River is clear of ice. Considering our position isolated from the world and threatened by bands of Indians from the south and west, our people keep up heart well, but all look anxiously for the arrival of the promised troops.

RIEL TO MAKE A STAND.

The Toronto Mail's special of the 12th inst. from Gen. Middleton's camp says: "A messenger from the north says Riel intends to make a stand at Batouche's Crossing, and if beaten to retreat north, or else endeavor to reach the American frontier. The best information shows that he has 500 half-breeds well armed, and that from 300 to 400 Crees and Sioux are co-operating with them at Beardy's reserve between Batouche's, Clarke's, and Battleford. Nearly all the Indians are on the war-path. The settlers have lost everything. The Teton Sioux are burning the homesteads at Gardemia Crossing, north of Grandin. In short the whole northern country is in a bad state.

Fenians for Canada.

MEETING OF DYNAMITERS IN NEW YORK—MEN AND MONEY TO GO TO RIEL.

(New York Journal, April 6.)

Secret conclaves of the Fenian Brotherhood were held yesterday. Considerable enthusiasm was aroused by the receipt of a letter from Colonel D. O'Sullivan, of Chicago, who said that the "A. R. L." had voted \$5,000 to help Riel, besides sending him 250 men and a gatling gun from that city. It was also reported that ex-Congressman John F. Finerty and ex-Assemblyman P. W. Dunne, of Chicago, had been communicating with Riel, and had assured him of the continued support of the A. R. L. (the Advanced Revolutionary League). Another letter was to the effect that the Wolfe Tone Circle, of St. Louis, had sent to Manitoba a dynamite corps of twenty-five men with sufficient material to make a ton of dynamite and Greek fire. These men, it is said, have just graduated from the "Fenian Military Academy," a pet name for Mezzofiore's dynamite school. A journal reporter had the good fortune to gain admission to a Fenian rendezvous in the Fourth Ward last evening. "John Murray," the name by which Louis Riel's agent is known, was there. He said his mission had been a success, having received substantial evidence that the dynamite faction of New York and vicinity meant business. They had shown it, he said, by contributing \$10,000, 2,000 improved repeating rifles, two gatling guns and 500 men, most of which and whom were on the way to the seat of war.

It was learned positively that Louis Riel was in this city two months ago. He came on for consultation with the leaders

of the various Irish organizations, with whom he has been in communication for two years. Riel, it is said, had a prolonged conference with Patrick Ford, who promised him substantial aid in case he revolted against the English Government. Among those he enlisted to his aid were Captain John McCafferty, "Rocky Mountain" O'Brien, P. J. Sheridan, of Colorado; P. W. Dunne, of Chicago; O'Donovan Rossa, ex-Congressman John F. Finerty, of Chicago; Judge John Brennan, Sioux City, Ia.; Colonel Allyward, General McAdaras, of St. Louis, and John Walsh, the noted Fenian organizer, who was arrested in France for supposed complicity in the Phoenix Park tragedy.

McCafferty, Sheridan, O'Brien, Dunne and Walsh are men of large experience in military and revolutionary matters, and people who know them say that they can render valuable aid to the rebel leader. O'Brien and Walsh, it is said, started Saturday to join McCafferty at St. Paul, Minn. Bryan McHenry, "Centre" of the Emmet Circle of Greenpoint, informed the reporter that twenty-five members of his Circle would leave for Canada in a week. They are to be disguised as railway laborers, provided only with revolvers to protect themselves in case the Canadian authorities should attempt to arrest them. John Davoy and John Breslin declined to say whether the Clan-na-Gael intended to take a hand in the trouble. Mr. Devoy intimated that the Fenian Brotherhood had charge of the affair.

Rossa was busy preparing a lecture to be delivered in Boston to-morrow night. He stopped writing long enough to say: "There will be blood and thunder and brimstone flying about Manitoba before two weeks pass. Mark my words. I'm no prophet, but I know when I see smoke that there's fire around."
